(I) WITH RESPECT TO A COOPERATIVE HOUSING CORPORATION, THE MEANING STATED IN § 5–6B–01 OF THE CORPORATIONS AND ASSOCIATIONS ARTICLE; OR

(II) WITH RESPECT TO A CONDOMINIUM,".
