A BILL ENTITLED

1 AN ACT concerning

2 **Dorchester County – Alcoholic Beverages – Class C Beer, Wine, and Liquor**
3 **License**

4 FOR the purpose of authorizing the Board of License Commissioners for Dorchester
5 County, rather than the Dorchester County Council, to issue a Class C beer, wine,
6 and liquor license; altering the authorized holders of the license; requiring the Board,
7 rather than the County Council, to remit the license fee under certain circumstances;
8 making conforming changes; and generally relating to Class C beer, wine, and liquor
9 licenses in Dorchester County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages**

23 19–102.

24 This title applies only in Dorchester County.

2 (a) There is a Class C beer, wine, and liquor license.

3 (b) The [County Council] **BOARD** may issue the license for use by:

4 (1) a yacht club and country and golf club that:

5 (i) has been incorporated for at least 5 years before filing the
6 application for the license;

7 (ii) has at least 250 members paying dues of at least \$10 per year
8 per adult member;

9 (iii) has facilities for preparing and serving food on the premises to
10 members and guests when accompanied by members; and

11 (iv) owns or operates a clubhouse that is on the premises and
12 principally used for its members and guests;

13 (2) a local unit of a nationwide nonprofit organization or club composed
14 only of members who served in the armed forces of the United States in a war in which the
15 United States has been engaged that:

16 (i) has a charter from a national veterans' organization that was
17 granted at least 5 years before the application for the license was made;

18 (ii) has at least 50 members paying dues of at least \$5 per year per
19 member;

20 (iii) operates only for the use of its members and guests when
21 accompanied by members; and

22 (iv) meets in a clubhouse principally used for its members and
23 guests;

24 (3) a lodge or chapter of a nonprofit and nationwide fraternal organization
25 that:

26 (i) is composed of inducted members;

27 (ii) has been operating in the county for at least 5 years before the
28 application for the license was made;

29 (iii) has at least 125 members paying dues of at least \$5 per year per
30 member; and

1 (iv) owns or operates a home or clubhouse principally for the use of
2 its members and guests when accompanied by members; or

3 (4) [the] A nonprofit organization[, Sailwinds of Cambridge, Inc.,]
4 **OPERATING ON THE PREMISES LOCATED AT 200 BYRN STREET, CAMBRIDGE,**
5 **KNOWN AS GOVERNORS HALL AT SAILWINDS PARK**, so long as an individual or group
6 of individuals does not derive personal profits from the operation of the organization.

7 (c) The license authorizes the license holder to sell beer, wine, and liquor at a club
8 at the place described in the license, for on-premises consumption.

9 (d) When alcoholic beverages are served at an event open to the public at
10 **GOVERNORS HALL AT Sailwinds [of Cambridge, Inc.] PARK**, the license holder:

11 (1) may distribute a wristband at the event to each individual who is at
12 least 21 years old; and

13 (2) if wristbands are distributed at the event, may not serve an alcoholic
14 beverage to an individual who is not wearing a wristband.

15 (e) (1) The annual license fee is \$1,000.

16 (2) The [County Council] **BOARD** shall remit the license fee:

17 (i) if the licensed premises is in a municipality, to the governing
18 body of the municipality; or

19 (ii) if the licensed premises is not in a municipality, to the Finance
20 Department of the county.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2020.
