# Vehicle Emissions Inspection Program – Deployed Military Personnel – Exemption

FOR the purpose of exempting certain active duty members of the armed services of the
United States who are subject to certain deployments from certain mandatory
vehicle emissions inspections; requiring all owners of a motor vehicle for which an
exemption is sought under this Act to certify in a certain manner that a certain
individual is subject to certain deployment; and generally relating to exemptions
from the vehicle emissions inspection program.

1 (C) (1) A MOTOR VEHICLE OWNED BY AT LEAST ONE ACTIVE DUTY 2 MEMBER OF THE ARMED SERVICES OF THE UNITED STATES AT THE TIME OF A 3 SCHEDULED MANDATORY INSPECTION UNDER THIS SUBTITLE IS EXEMPT FROM THE 4 MANDATORY INSPECTIONS REQUIRED BY THIS SUBTITLE IF:

5 (I) AN OWNER OF THE MOTOR VEHICLE WHO IS A MEMBER OF 6 THE ARMED SERVICES OF THE UNITED STATES HAS RECEIVED MILITARY ORDERS:

ORDERS FOR DEPLOYMENT OUTSIDE THE UNITED STATES OR TO A DUTY STATION
IN A JURISDICTION THAT IS NOT SUBJECT TO A VEHICLE EMISSIONS CONTROL
INSPECTION AND MAINTENANCE PROGRAM.
