A BILL ENTITLED

1 AN ACT concerning

2 **Admissions and Amusement Tax – Electronic Bingo and Tip Jars – Distribution**
3 **to Maryland State Arts Council**

4 FOR the purpose of altering, beginning in a certain fiscal year, the distribution of revenue
5 from the State admissions and amusement tax on electronic bingo and electronic tip
6 jars; and generally relating to the distribution of revenue from the State admissions
7 and amusement tax on electronic bingo and electronic tip jars.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Tax – General**

16 2–202.

17 (a) After making the distribution required under § 2–201 of this subtitle, within
18 20 days after the end of each quarter, the Comptroller shall distribute:

19 (1) except as provided in subsections (b) and (c) of this section, from the
20 revenue from the State admissions and amusement tax on electronic bingo and electronic
21 tip jars under § 4–102(e) of this article:

1 (i) 1. for fiscal years 2016 through 2021, the revenue
2 attributable to a tax rate of 20% to the Maryland E–Nnovation Initiative Fund under §
3 6–604 of the Economic Development Article; and

4 2. in fiscal year 2022 and in each fiscal year thereafter, the
5 revenue attributable to a tax rate of 20% to the General Fund of the State; and

6 (ii) [1. for fiscal year 2018, the revenue attributable to a tax rate
7 of 5% as follows:

8 A. to the Special Fund for Preservation of Cultural Arts in
9 Maryland, as provided in § 4–801 of the Economic Development Article, up to an aggregate
10 amount of \$1,000,000 in each fiscal year; and

11 B. the remainder to the Maryland State Arts Council, as
12 provided in § 4–512 of the Economic Development Article;

13 2. for fiscal years 2019 through 2021] **FOR FISCAL YEAR**
14 **2021 AND EACH FISCAL YEAR THEREAFTER**, the revenue attributable to a tax rate of 5%
15 as follows:

16 [A.] 1. to the Maryland State Arts Council, as provided in
17 § 4–512 of the Economic Development Article, \$1,000,000 in each fiscal year; and

18 [B.] 2. the remainder to the Special Fund for Preservation
19 of Cultural Arts in Maryland, as provided in § 4–801 of the Economic Development Article;
20 and

21 [3. in fiscal year 2022 and in each fiscal year thereafter, the
22 revenue attributable to a tax rate of 5% to the Special Fund for Preservation of Cultural
23 Arts in Maryland, as provided in § 4–801 of the Economic Development Article; and]

24 (2) the remaining admissions and amusement tax revenue:

25 (i) to the Maryland Stadium Authority, county, or municipal
26 corporation that is the source of the revenue; or

27 (ii) if the Maryland Stadium Authority and also a county or
28 municipal corporation tax a reduced charge or free admission:

29 1. 80% of that revenue to the Authority; and

30 2. 20% to the county or municipal corporation.

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
32 1, 2020.
