A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Voting Order Priority – Individuals Who Need Extra Assistance**

3 FOR the purpose of requiring a chief election judge to give voting order priority to certain
4 individuals; authorizing certain individuals to request voting order priority of any
5 election judge serving at a polling place; requiring the chief election judge to
6 determine whether certain individuals qualify for voting order priority based on
7 criteria established in regulations adopted by the State Board of Elections; requiring
8 individuals who qualify for voting order priority to be brought to the front of certain
9 lines and have a certain preference for using the ballot marking device or a voting
10 booth; requiring the State Board to adopt certain regulations; providing for a delayed
11 effective date; and generally relating to voting order priority for individuals with
12 mobility problems or accompanied by young children or children with a disability.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Election Law**

21 **10–309.1.**

22 **(A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A CHIEF ELECTION**
23 **JUDGE SHALL GIVE VOTING ORDER PRIORITY TO AN INDIVIDUAL:**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(1) WHO HAS A MOBILITY PROBLEM THAT SUBSTANTIALLY IMPAIRS**
2 **THE INDIVIDUAL'S ABILITY TO MOVE AROUND OR STAND;**

3 **(2) WHO IS ASSISTING AN INDIVIDUAL DESCRIBED UNDER ITEM (1) OF**
4 **THIS SUBSECTION;**

5 **(3) WHO IS ACCOMPANIED BY A YOUNG CHILD; OR**

6 **(4) WHO IS ACCOMPANIED BY A CHILD WITH A DISABILITY.**

7 **(B) (1) AN INDIVIDUAL DESCRIBED UNDER SUBSECTION (A) OF THIS**
8 **SECTION MAY REQUEST VOTING ORDER PRIORITY OF ANY ELECTION JUDGE**
9 **SERVING AT THE POLLING PLACE.**

10 **(2) THE CHIEF ELECTION JUDGE SHALL DETERMINE WHETHER AN**
11 **INDIVIDUAL QUALIFIES FOR VOTING ORDER PRIORITY BASED ON CRITERIA**
12 **ESTABLISHED IN REGULATIONS ADOPTED BY THE STATE BOARD.**

13 **(C) AN INDIVIDUAL WHO QUALIFIES FOR VOTING ORDER PRIORITY SHALL:**

14 **(1) BE BROUGHT TO THE FRONT OF THE LINE FOR CHECK-IN AND**
15 **BALLOT ISSUANCE;**

16 **(2) HAVE FIRST PREFERENCE FOR USING THE BALLOT MARKING**
17 **DEVICE OR A VOTING BOOTH; AND**

18 **(3) BE BROUGHT TO THE FRONT OF THE LINE FOR SCANNING A**
19 **COMPLETED BALLOT.**

20 **(D) THE STATE BOARD SHALL ADOPT REGULATIONS TO IMPLEMENT THIS**
21 **SECTION, INCLUDING:**

22 **(1) METHODS FOR PROVIDING NOTICE OF THE OPTION TO REQUEST**
23 **VOTING ORDER PRIORITY TO VOTERS BEFORE AN ELECTION AND AT EACH POLLING**
24 **PLACE ON ELECTION DAY;**

25 **(2) TRAINING GUIDELINES FOR ELECTION JUDGES; AND**

26 **(3) DATA COLLECTION PROCEDURES TO DETERMINE THE USE AND**
27 **EFFECTIVENESS OF VOTING ORDER PRIORITY FOR QUALIFYING INDIVIDUALS.**

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 January 1, 2021.
