## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Transportation – Potomac River Bridges Towing Compact – Inclusion of**  
3 **Additional Bridges**

4 FOR the purpose of making certain bridges subject to the provisions of the Potomac River  
5 Bridges Towing Compact; making this Act subject to ~~a certain contingency~~ certain  
6 contingencies; and generally relating to the Potomac River Bridges Towing Compact.

7 BY repealing and reenacting, with amendments,  
8 Article – Transportation  
9 Section 25–301  
10 Annotated Code of Maryland  
11 (2012 Replacement Volume and 2019 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Transportation**

1 This agreement shall be known as the Potomac River Bridges Towing Compact and  
2 the parties to this agreement are the Commonwealth of Virginia, the State of Maryland,  
3 and the District of Columbia.

## 4 Article II

### 5 Findings and Purpose

6 The Woodrow Wilson Memorial Bridge, Rochambeau Memorial Bridge, George  
7 Mason Memorial Bridge, Theodore Roosevelt Memorial Bridge, Francis Scott Key Bridge,  
8 Chain Bridge, **GOVERNOR HARRY W. NICE/SENATOR THOMAS "MAC" MIDDLETON**  
9 **BRIDGE, SANDY HOOK BRIDGE, BRUNSWICK BRIDGE, POINT OF ROCKS BRIDGE,**  
10 and American Legion Bridge all pass through the territorial jurisdiction of two or more of  
11 the three parties. Experience has shown that traffic back ups often prevent state troopers,  
12 state police officers, or police officers of the appropriate jurisdiction from arriving at the  
13 scene of a disabled or abandoned vehicle to take corrective action. The purpose of this  
14 Compact is to facilitate the prompt and orderly removal of disabled and abandoned vehicles  
15 from the bridges by giving all three parties jurisdiction to exercise appropriate authority  
16 anywhere on the bridges.

## 17 Article III

### 18 Authority to Direct Traffic and Authorize Removal of Vehicle

19 The parties hereby give one another all necessary power and authority to have their  
20 respective state troopers, state police officers, or local law enforcement officers direct traffic  
21 and authorize the removal of disabled or abandoned vehicles, trailers, semitrailers, or the  
22 parts or contents thereof, from any part of the Potomac River bridges, to the same extent  
23 and in the same manner that such state troopers, state police officers, and law enforcement  
24 officers may exercise such authority in their own jurisdictions. However, no party, acting  
25 through its state troopers, state police officers, or local law enforcement officers, shall have  
26 the authority to direct or authorize the towing or removal of any vehicle or other thing to a  
27 destination outside its own jurisdiction, unless the consent of a state trooper, state police  
28 officer, or law enforcement officer of the destination jurisdiction has been first obtained.

## 29 Article IV

### 30 Disposition of Towed Vehicles

31 All vehicles and their contents towed or removed from the Potomac River bridges  
32 pursuant to this Compact shall be subject to the exclusive jurisdiction of the place to which  
33 such vehicle and its contents are taken, and the handling and disposition of such vehicle  
34 and its contents shall be governed by the laws and procedures of that jurisdiction.

## 35 Article V

### 36 No Agency Relationship

1 Each of the parties shall act solely on its own authority within the jurisdiction  
2 granted. This Compact shall not be construed as creating any agency relationship between  
3 the parties.

4 Article VI

5 Effective Date

6 The provisions of this Compact shall take effect thirty days after the legislative  
7 bodies of parties having jurisdiction over one or several of the bridges identified in Article  
8 II have enacted compacts substantially identical to this Compact.

9 Article VII

10 Termination

11 The Governor of the Commonwealth of Virginia or the State of Maryland, or the  
12 Mayor of the District of Columbia may withdraw from this Compact at any time upon thirty  
13 days written notice to the other parties.

14 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
15 as follows:

18 Article I

19 Parties and Title

20 This agreement shall be known as the Potomac River Bridges Towing Compact and  
21 the parties to this agreement are the Commonwealth of Virginia, the State of Maryland,

23 Article II

24 Findings and Purpose

25 The Woodrow Wilson Memorial Bridge, Rochambeau Memorial Bridge, George

31 disabled or abandoned vehicle to take corrective action. The purpose of this Compact is to

2 bridges by giving all three parties jurisdiction to exercise appropriate authority anywhere  
3 on the bridges.

#### 4 Article III

##### 5 Authority to Direct Traffic and Authorize Removal of Vehicle

6 The parties hereby give one another all necessary power and authority to have their  
7 respective state troopers, state police officers, or local law enforcement officers direct traffic  
8 and authorize the removal of disabled or abandoned vehicles, trailers, semitrailers, or the  
9 parts or contents thereof, from any part of the Potomac River bridges, to the same extent  
10 and in the same manner that such state troopers, state police officers, and law enforcement  
11 officers may exercise such authority in their own jurisdictions. However, no party, acting  
12 through its state troopers, state police officers, or local law enforcement officers, shall have  
13 the authority to direct or authorize the towing or removal of any vehicle or other thing to a  
14 destination outside its own jurisdiction, unless the consent of a state trooper, state police  
15 officer, or law enforcement officer of the destination jurisdiction has been first obtained.

#### 16 Article IV

##### 17 Disposition of Towed Vehicles

18 All vehicles and their contents towed or removed from the Potomac River bridges  
19 pursuant to this Compact shall be subject to the exclusive jurisdiction of the place to which  
20 such vehicle and its contents are taken, and the handling and disposition of such vehicle  
21 and its contents shall be governed by the laws and procedures of that jurisdiction.

#### 22 Article V

##### 23 No Agency Relationship

24 Each of the parties shall act solely on its own authority within the jurisdiction  
25 granted. This Compact shall not be construed as creating any agency relationship between  
26 the parties.

#### 27 Article VI

##### 28 Effective Date

29 The provisions of this Compact shall take effect thirty days after the legislative  
30 bodies of parties having jurisdiction over one or several of the bridges identified in Article  
31 II have enacted compacts substantially identical to this Compact.

#### 32 Article VII

##### 33 Termination

1 The Governor of the Commonwealth of Virginia or the State of Maryland, or the  
2 Mayor of the District of Columbia may withdraw from this Compact at any time upon thirty  
3 days written notice to the other parties.

4 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That:

5 (a) ~~This Section 1 of this Act~~ may not take effect until a similar Act is enacted by  
6 the District of Columbia and the Commonwealth of Virginia.

7 (b) The District of Columbia and the Commonwealth of Virginia are requested to  
8 concur in Section 1 of this Act of the General Assembly of Maryland by the enactment of a  
9 similar Act.

10 (c) The Department of Legislative Services shall notify the appropriate officials  
11 of the District of Columbia and the Commonwealth of Virginia of the enactment of Section  
12 1 of this Act.

13 (d) On the concurrence in Section 1 of this Act by the District of Columbia and the  
14 Commonwealth of Virginia, the Governor of the State of Maryland shall issue a  
15 proclamation declaring Section 1 of this Act valid and effective and shall forward a copy of  
16 the proclamation to the Executive Director of the Department of Legislative Services.

17 SECTION 4. AND BE IT FURTHER ENACTED, That:

18 (a) Section 2 of this Act may not take effect until a similar Act is enacted by the  
19 District of Columbia and the Commonwealth of Virginia.

20 (b) The District of Columbia and the Commonwealth of Virginia are requested to  
21 concur in Section 2 of this Act of the General Assembly of Maryland by the enactment of a  
22 similar Act.

23 (c) The Department of Legislative Services shall notify the appropriate officials  
24 of the District of Columbia and the Commonwealth of Virginia of the enactment of Section  
25 2 of this Act.

26 (d) On the concurrence in Section 2 of this Act by the District of Columbia and the  
27 Commonwealth of Virginia, the Governor of the State of Maryland shall issue a  
28 proclamation declaring Section 2 of this Act valid and effective and shall forward a copy of  
29 the proclamation to the Executive Director of the Department of Legislative Services.

30 SECTION ~~2~~ 5. AND BE IT FURTHER ENACTED, That, subject to ~~Section 2~~  
31 Sections 3 and 4 of this Act, this Act shall take effect June 1, 2020.
