A BILL ENTITLED

1 AN ACT concerning

2 **Real Property – Ground Leases – Past Due Ground Rent**

3 FOR the purpose of clarifying that a ground lease holder may not bring any suit, action, or
4 proceeding against the current leasehold tenant or a former leasehold tenant to
5 recover the ground rent that was due and owing before the date the current leasehold
6 tenant acquired title to the leasehold interest if the ground lease was not registered
7 before the date the current leasehold tenant acquired title under certain
8 circumstances; making a stylistic change; and generally relating to past due ground
9 rent under a ground lease.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Real Property**

23 8–707.

24 If a ground lease is not registered in accordance with this subtitle, the ground lease
25 holder may not:

1 (1) Collect any ground rent payments due under the ground lease;

2 (2) Bring a civil action against the leasehold tenant to enforce any rights
3 the ground lease holder may have under the ground lease; or

4 (3) Bring an action against the leasehold tenant under Subtitle 8 of this
5 title.

7 (a) (1) In any suit, action, or proceeding by a ground lease holder, or the
8 transferee of the reversion in property subject to a ground lease, to recover past due ground
9 rent, the ground lease holder, or the transferee of the reversion is entitled to demand or
10 recover not more than 3 years' past due ground rent, calculated from the date notice was
11 sent under § 8–807(c)(1) of this subtitle.

12 (2) **NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A GROUND**
13 **LEASE HOLDER MAY NOT BRING ANY SUIT, ACTION, OR PROCEEDING AGAINST THE**
14 **CURRENT LEASEHOLD TENANT OR A FORMER LEASEHOLD TENANT TO RECOVER THE**
15 **GROUND RENT THAT WAS DUE AND OWING BEFORE THE DATE THE CURRENT**
16 **LEASEHOLD TENANT ACQUIRED TITLE TO THE LEASEHOLD INTEREST IF THE**
17 **GROUND LEASE WAS NOT REGISTERED IN ACCORDANCE WITH SUBTITLE 7 OF THIS**
18 **TITLE BEFORE THE DATE THE CURRENT LEASEHOLD TENANT ACQUIRED TITLE.**

19 (b) If authorized under the ground lease, a ground lease holder may be
20 reimbursed for reasonable late fees, interest, collection costs, and expenses, subject to the
21 same limitations as provided in § 8–807 of this subtitle.

22 (c) (1) Notwithstanding any other provision of law, in any suit, action, or
23 proceeding to recover past due ground rent, a ground lease holder may only recover not
24 more than 3 years' past due ground rent, calculated from the date notice was sent under §
25 8–807(c)(1) of this subtitle, if the property is:

26 (i) Owned or acquired by any means by the Mayor and City Council
27 of Baltimore; and

28 (ii) Distressed property, as defined in § 21–17(a)(3) of the Public
29 Local Laws of Baltimore City.

30 (2) Notwithstanding any other provision of law, a ground lease holder may
31 not bring any suit, action, or proceeding against the current leasehold tenant to recover the
32 ground rent that was due and owing from a former leasehold tenant before the date that
33 the current leasehold tenant acquired title, if the property is:

34 (i) Owned or acquired by any means by the current leasehold

1 tenant; and

2 (ii) Abandoned property, as defined in § 21-17(a)(2) of the Public
3 Local Laws of Baltimore City.

4 (3) With regard to property described under paragraphs (1) and (2) of this
5 subsection, a ground lease holder may request in writing that the current leasehold tenant
6 acquire the reversionary interest under the ground lease for the market value established
7 at the time of the acquisition by the current leasehold tenant under the ground lease.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2020.
