## A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County Board of Education – Annual Meeting – Date**

3 FOR the purpose of altering the date on which the Anne Arundel County Board of  
4 Education is required to hold its annual meeting; and generally relating to the  
5 annual meeting of the Anne Arundel County Board of Education.

6 BY repealing and reenacting, with amendments,  
7 Article – Education  
8 Section 4–107(a)  
9 Annotated Code of Maryland  
10 (2018 Replacement Volume and 2019 Supplement)

11 BY repealing and reenacting, without amendments,  
12 Article – Education  
13 Section 4–107(c)  
14 Annotated Code of Maryland  
15 (2018 Replacement Volume and 2019 Supplement)

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 4–107.

20 (a) Each county board shall hold an annual meeting on or as near as possible to  
21 the second Tuesday in July, except that:

22 (1) In Allegany County, the annual meeting shall be held on the second  
23 Tuesday in January;

1                   **(2) IN ANNE ARUNDEL COUNTY, THE ANNUAL MEETING SHALL BE**  
2 **HELD ON OR AS NEAR AS POSSIBLE TO THE FIRST WEDNESDAY IN DECEMBER;**

3                   ~~[(2)]~~ **(3)**       In Montgomery County, the annual meeting shall be held on or  
4 before January 10;

5                   ~~[(3)]~~ **(4)**       In Prince George's County, the annual meeting shall be held on  
6 the first Monday in December;

7                   ~~[(4)]~~ **(5)**       In St. Mary's County, the annual meeting shall be held following  
8 the first Monday in December; and

9                   ~~[(5)]~~ **(6)**       In Washington County, the annual meeting shall be held in  
10 December, on or before the 16th day.

11               (c)       Except as provided in Title 3 of this article, each county board, at its annual  
12 meeting, shall elect a president and a vice president from among its members by means of  
13 an individually recorded vote.

14               SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
15 1, 2020.
