### **Redistricting Reform Act of 2020 – Constitutional Amendment**

3 FOR the purpose of proposing an amendment to the Maryland Constitution to require 4 single-member delegate districts; altering certain standards for the drawing of legislative districts; proposing a new article to the Maryland Constitution to  $\mathbf{5}$ 6 establish standards for the drawing of congressional districts; establishing a 7 Legislative and Congressional Redistricting and Apportionment Commission as an 8 independent unit of State government consisting of certain members; requiring the 9 Redistricting Commission to divide the State into certain legislative districts and 10 congressional districts; requiring legislative districts and congressional districts to 11 meet a certain standard for population size; providing for the duties of the 12Redistricting Commission; requiring the presiding officers of the General Assembly 13 to introduce certain redistricting plans in a certain manner for consideration by the General Assembly; requiring the Governor, if necessary, to convene a special session 14 15of the General Assembly to consider certain redistricting plans; requiring the 16General Assembly to consider only the certified legislative district plan and the 17certified congressional district plan during a certain special session; prohibiting the 18 General Assembly from considering certain legislation during a certain special session; requiring the presiding officers to introduce certain certified redistricting 19 20plans on certain days during certain types of sessions of the General Assembly; 21prohibiting members of the General Assembly from introducing bills proposing 22certain plans; prohibiting certain plans from being amended except under certain 23circumstances; requiring certain plans to be passed by a certain number of votes of 24the members of each House of the General Assembly by a certain day of the session; 25requiring certain plans passed by the General Assembly to be presented to the 26Governor within a certain number of days; requiring the presiding officers to, within 27a certain number of days, provide to the Redistricting Commission a certain notice

### 38 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

39 (Three-fifths of all the members elected to each of the two Houses concurring). That it be

### Article III - Legislative Department

3 The State shall be divided by law into legislative districts for the election of members of the Senate and the House of Delegates. Each legislative district shall contain one (1) 4  $\mathbf{5}$ Senator and three (3) Delegates. [Nothing herein shall prohibit the subdivision of any one or more of the legislative districts for the purpose of electing members of the House of 6 7 Delegates into three (3) single-member delegate districts or one (1) single-member 8 delegate district and one (1) multi-member delegate district.] EACH LEGISLATIVE DISTRICT SHALL BE SUBDIVIDED INTO THREE (3) SINGLE-MEMBER DELEGATE 9 10 DISTRICTS.

Each legislative district [shall consist of adjoining territory, be compact in form, and of substantially equal population. Due regard shall be given to natural boundaries and the boundaries of political subdivisions]:

## 15 (1) SHALL RESPECT NATURAL BOUNDARIES AND THE GEOGRAPHIC 16 INTEGRITY AND CONTINUITY OF ANY MUNICIPAL CORPORATION, COUNTY, OR 17 OTHER POLITICAL SUBDIVISION TO THE EXTENT PRACTICABLE;

18 (2) SHALL BE GEOGRAPHICALLY COMPACT AND INCLUDE NEARBY 19 AREAS OF POPULATION TO THE EXTENT PRACTICABLE;

## 20 (3) MAY NOT ACCOUNT FOR HOW INDIVIDUALS ARE REGISTERED TO 21 VOTE, HOW INDIVIDUALS VOTED IN THE PAST, OR THE POLITICAL PARTY TO WHICH 22 INDIVIDUALS BELONG; AND

# (4) MAY NOT ACCOUNT FOR THE DOMICILE OR RESIDENCE OF ANY individual, including an incumbent officeholder or a potential candidate for office.

Following each decennial census of the United States and after public hearings, the Governor shall prepare a plan setting forth the boundaries of the legislative districts for electing of the members of the Senate and the House of Delegates.

The Governor shall present the plan to the President of the Senate and Speaker of the House of Delegates who shall introduce the Governor's plan as a joint resolution to the General Assembly, not later than the first day of its regular session in the second year following every census, and the Governor may call a special session for the presentation of his plan prior to the regular session. The plan shall conform to Sections 2, 3 and 4 of this

1 Article. Following each decennial census the General Assembly may by joint resolution  $\mathbf{2}$ adopt a plan setting forth the boundaries of the legislative districts for the election of 3 members of the Senate and the House of Delegates, which plan shall conform to Sections 4 2, 3 and 4 of this Article. If a plan has been adopted by the General Assembly by the 45th  $\mathbf{5}$ day after the opening of the regular session of the General Assembly in the second year 6 following every census, the plan adopted by the General Assembly shall become law. If no  $\mathbf{7}$ plan has been adopted by the General Assembly for these purposes by the 45th day after 8 the opening of the regular session of the General Assembly in the second year following 9 every census, the Governor's plan presented to the General Assembly shall become law.

10 Upon petition of any registered voter, the Court of Appeals shall have original 11 jurisdiction to review the legislative districting of the State and may grant appropriate 12 relief, if it finds that the districting of the State is not consistent with requirements of either 13 the Constitution of the United States of America, or the Constitution of Maryland.]

### **Article IV – Judiciary Department**

16 The Court of Appeals shall be composed of seven judges, one from the First Appellate 17Judicial Circuit consisting of Caroline, Cecil, Dorchester, Kent, Queen Anne's, Somerset, 18 Talbot, Wicomico, and Worcester Counties; one from the Second Appellate Judicial Circuit 19consisting of Baltimore and Harford Counties; one from the Third Appellate Judicial 20Circuit, consisting of Allegany, Carroll, Frederick, Garrett, Howard, and Washington 21Counties; one from the Fourth Appellate Judicial Circuit, consisting of Prince George's 22County; one from the Fifth Appellate Judicial Circuit, consisting of Anne Arundel, Calvert, 23Charles, and St. Mary's Counties; one from the Sixth Appellate Judicial Circuit, consisting of Baltimore City; and one from the Seventh Appellate Judicial Circuit, consisting of 2425Montgomery County. The Judges of the Court of Appeals shall be residents of their 26respective Appellate Judicial Circuits. The term of each Judge of the Court of Appeals shall 27begin on the date of his qualification. One of the Judges of the Court of Appeals shall be 28designated by the Governor as the Chief Judge. The jurisdiction of the Court of Appeals 29shall be co-extensive with the limits of the State and such as now is or may hereafter be 30 prescribed by law. EXCLUSIVE AMONG THE STATE COURTS, THE COURT OF APPEALS SHALL HAVE ORIGINAL JURISDICTION: (1) TO ESTABLISH THE LEGISLATIVE 31 32DISTRICT PLAN AND THE CONGRESSIONAL DISTRICT PLAN IN THE EVENT THAT A PLAN IS NOT ENACTED UNDER ARTICLE XX, SECTION 2 OF THIS CONSTITUTION; 33 34AND (2) TO CONSIDER A PETITION SEEKING REVIEW OF THE LEGALITY OF A PLAN TO ESTABLISH LEGISLATIVE OR CONGRESSIONAL DISTRICTS ENACTED UNDER 3536 **ARTICLE XX, SECTION 2 OF THIS CONSTITUTION.** It shall hold its sessions in the City 37of Annapolis at such time or times as it shall from time to time by rule prescribe. Its session or sessions shall continue not less than ten months in each year, if the business before it 38 39 shall so require, and it shall be competent for the judges temporarily to transfer their 40 sittings elsewhere upon sufficient cause. The salary of each Judge of the Court of Appeals 41 shall be that now or hereafter prescribed by the General Assembly and shall not be 42diminished during his continuance in office. Five of the judges shall constitute a quorum,

and five judges shall sit in each case unless the Court shall direct that an additional judge or judges sit for any case. The concurrence of a majority of those sitting shall be sufficient for the decision of any cause, and an equal division of those sitting in a case has the effect of affirming the decision appealed from if there is no application for reargument as hereinafter provided. In any case where there is an equal division or a three to two division of the Court a reargument before the full Court of seven judges shall be granted to the losing party upon application as a matter of right.

- 10 (a) The Attorney General shall:

[Prosecute] EXCEPT FOR PROCEEDINGS TO ESTABLISH THE 11 (1)12LEGISLATIVE DISTRICT PLAN AND THE CONGRESSIONAL DISTRICT PLAN IN THE EVENT THAT A PLAN IS NOT ENACTED UNDER ARTICLE XX, SECTION 2 OF THIS 1314 CONSTITUTION OR A PETITION SEEKING REVIEW OF THE LEGALITY OF A PLAN TO ESTABLISH LEGISLATIVE DISTRICTS OR CONGRESSIONAL DISTRICTS ENACTED 15UNDER ARTICLE XX, SECTION 2 OF THIS CONSTITUTION, PROSECUTE and defend on 16 17the part of the State all cases pending in the appellate courts of the State, in the Supreme Court of the United States or the inferior Federal Courts, by or against the State, or in 18 19which the State may be interested, except those criminal appeals otherwise prescribed by 20the General Assembly.

21 (2) Investigate, commence, and prosecute or defend any civil or criminal 22 suit or action or category of such suits or actions in any of the Federal Courts or in any 23 Court of this State, or before administrative agencies and quasi legislative bodies, on the 24 part of the State or in which the State may be interested, which the General Assembly by 25 law or joint resolution, or the Governor, shall have directed or shall direct to be 26 investigated, commenced and prosecuted or defended.

(3) When required by the General Assembly by law or joint resolution, or
by the Governor, aid any State's Attorney or other authorized prosecuting officer in
investigating, commencing, and prosecuting any criminal suit or action or category of such
suits or actions brought by the State in any Court of this State.

31 (4) Give his opinion in writing whenever required by the General Assembly
32 or either branch thereof, the Governor, the Comptroller, the Treasurer or any State's
33 Attorney on any legal matter or subject.

34 (b) The Attorney General shall have and perform any other duties and possess 35 any other powers, and appoint the number of deputies or assistants, as the General 36 Assembly from time to time may prescribe by law.

15 (3) MAY NOT ACCOUNT FOR HOW INDIVIDUALS ARE REGISTERED TO

IMPARTIAL AND REASONABLY REPRESENTATIVE OF THE STATE'S GEOGRAPHICAL,
 RACIAL, AND GENDER MAKEUP.

3 (D) IN THE YEAR FOLLOWING EACH DECENNIAL CENSUS OF THE UNITED 4 STATES, THE REDISTRICTING COMMISSION SHALL:

5 (1) DIVIDE THE STATE INTO CONSECUTIVELY NUMBERED 6 LEGISLATIVE DISTRICTS THAT CONFORM TO ARTICLE III, SECTIONS 2, 3, AND 4 OF 7 THIS CONSTITUTION; AND

8 (2) DIVIDE THE STATE INTO AS MANY CONGRESSIONAL DISTRICTS 9 THAT CONFORM TO SECTION 1 OF THIS ARTICLE AS THERE ARE REPRESENTATIVES 10 IN CONGRESS APPORTIONED TO THE STATE.

11 (E) (1) LEGISLATIVE DISTRICTS SHALL BE AS NEARLY EQUAL IN 12 POPULATION AS PRACTICABLE BUT MAY NOT DEVIATE MORE THAN 2% IN 13 POPULATION BETWEEN LEGISLATIVE DISTRICTS.

14 (2) EACH DELEGATE DISTRICT SHALL BE AS NEARLY EQUAL IN 15 POPULATION AS PRACTICABLE BUT MAY NOT DEVIATE MORE THAN 2% IN 16 POPULATION BETWEEN THE OTHER DELEGATE DISTRICTS IN THE LEGISLATIVE 17 DISTRICT.

18 (F) THE REDISTRICTING COMMISSION SHALL:

19(1) ADOPT ONE PLAN FOR LEGISLATIVE DISTRICTS AND ONE PLAN20FOR CONGRESSIONAL DISTRICTS;

21 (2) CERTIFY THAT EACH PLAN IS THE PLAN ADOPTED BY THE 22 REDISTRICTING COMMISSION; AND

23 (3) SEND EACH CERTIFIED PLAN TO THE PRESIDING OFFICERS OF 24 THE GENERAL ASSEMBLY.

25 (G) ON RECEIPT OF THE CERTIFIED LEGISLATIVE DISTRICT PLAN AND THE 26 CERTIFIED CONGRESSIONAL DISTRICT PLAN FROM THE REDISTRICTING 27 COMMISSION, THE PRESIDING OFFICERS SHALL INTRODUCE EACH PLAN 28 SEPARATELY FOR CONSIDERATION BY THE GENERAL ASSEMBLY.

7 (II) MAY NOT CONSIDER ANY LEGISLATION, INCLUDING BILLS 8 THAT HAVE BEEN VETOED.

9 (I) THE PRESIDING OFFICERS SHALL INTRODUCE THE CERTIFIED 10 LEGISLATIVE DISTRICT PLAN AND THE CERTIFIED CONGRESSIONAL DISTRICT PLAN 11 AT THE FOLLOWING TIME:

12 (1) IF THE GOVERNOR DOES NOT CONVENE A SPECIAL SESSION, ON 13 THE FIRST DAY OF THE REGULAR SESSION OF THE GENERAL ASSEMBLY IN THE YEAR 14 ENDING IN THE NUMERAL 2; OR

15(2)IF THE GOVERNOR CONVENES A SPECIAL SESSION, ON THE FIRST16DAY OF THE SPECIAL SESSION.

17 (J) EXCEPT FOR THE PLANS REQUIRED TO BE INTRODUCED BY THE 18 PRESIDING OFFICERS UNDER SUBSECTION (G) OF THIS SECTION, A MEMBER OF THE 19 GENERAL ASSEMBLY MAY NOT INTRODUCE A BILL PROPOSING A PLAN FOR 20 LEGISLATIVE DISTRICTS OR CONGRESSIONAL DISTRICTS.

(K) EXCEPT FOR AN AMENDMENT PREPARED BY THE PRESIDING OFFICERS
 UNDER SUBSECTION (N) OF THIS SECTION, A LEGISLATIVE DISTRICT PLAN OR A
 CONGRESSIONAL DISTRICT PLAN MAY NOT BE AMENDED.

(L) (1) (I) DURING A REGULAR SESSION OF THE GENERAL ASSEMBLY,
EACH HOUSE OF THE GENERAL ASSEMBLY SHALL PASS A LEGISLATIVE DISTRICT
PLAN AND A CONGRESSIONAL DISTRICT PLAN BY A VOTE OF THREE–FIFTHS OF THE
MEMBERS ELECTED TO THAT HOUSE BY THE 45TH DAY AFTER THE OPENING OF THE
REGULAR SESSION.

(II) DURING A SPECIAL SESSION OF THE GENERAL ASSEMBLY,
 EACH HOUSE OF THE GENERAL ASSEMBLY SHALL PASS A LEGISLATIVE DISTRICT

19 (2) (I) ON RECEIPT OF THE NOTICE FROM THE GENERAL 20 ASSEMBLY UNDER PARAGRAPH (1)(I) OF THIS SUBSECTION, THE REDISTRICTING 21 COMMISSION SHALL REVIEW THE LEGISLATIVE DISTRICT PLAN OR THE 22 CONGRESSIONAL DISTRICT PLAN AND CONSIDER ANY RECOMMENDATIONS FOR 23 CHANGES TO A PLAN FROM THE GENERAL ASSEMBLY AND THE OBJECTIONS OF THE 24 GOVERNOR, IF ANY.

(II) THE REDISTRICTING COMMISSION SHALL SEND THE
LEGISLATIVE DISTRICT PLAN OR THE CONGRESSIONAL DISTRICT PLAN, INCLUDING
ANY CHANGES APPROVED BY THE REDISTRICTING COMMISSION, TO THE PRESIDING
OFFICERS WITHIN 20 DAYS AFTER RECEIVING THE NOTIFICATION OF THE GENERAL
