1 AN ACT concerning

2 State House Trust – Lawyer's Mall – Thurgood Marshall Memorial Statues

3 FOR the purpose of requiring the State House Trust to ensure that the Thurgood Marshall 4 Memorial statues on Lawyer's Mall are maintained in the same material condition $\mathbf{5}$ in which they were on a certain date; providing that the Thurgood Marshall 6 Memorial statues on Lawyer's Mall may be removed as necessary only under certain 7 conditions; prohibiting, except under certain circumstances, the Thurgood Marshall 8 Memorial statues from being removed from Lawyer's Mall; defining a certain term; 9 making this Act subject to a certain contingency; and generally relating to the 10 maintenance of the Thurgood Marshall Memorial statues on Lawyer's Mall by the 11 State House Trust.

4 (2) SUBJECT TO PARAGRAPH (4) OF THIS SUBSECTION, THE TRUST 5 SHALL ENSURE THAT THE THURGOOD MARSHALL MEMORIAL STATUES ARE 6 MAINTAINED IN THE SAME MATERIAL CONDITION IN WHICH THEY WERE ON JULY 1, 7 2018.

8 (3) EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS SUBSECTION, 9 THE THURGOOD MARSHALL MEMORIAL STATUES MAY NOT BE REMOVED FROM 10 LAWYER'S MALL.

11 (4) THE THURGOOD MARSHALL MEMORIAL STATUES MAY BE 12 REMOVED AS NECESSARY ONLY IF THEY ARE RETURNED AT THE EARLIEST 13 PRACTICABLE TIME TO THE SAME MATERIAL CONDITION IN WHICH THEY WERE 14 BEFORE THE REPAIR OR MAINTENANCE OCCURRED.

15 (5) FOR THE PURPOSES OF PARAGRAPH (4) OF THIS SUBSECTION, 16 THE THURGOOD MARSHALL MEMORIAL STATUES ARE IN THE SAME MATERIAL 17 CONDITION IF:

18 (I) THE STATUE OF SUPREME COURT JUSTICE THURGOOD 19 MARSHALL IS RETURNED TO THE EXACT LOCATION ON LAWYER'S MALL ON WHICH 20 IT STOOD ON JULY 1, 2018; AND

(II) THE THURGOOD MARSHALL MEMORIAL STATUES NOT
DESCRIBED IN ITEM (I) OF THIS PARAGRAPH ARE RETURNED TO THE EXACT
LOCATION ON LAWYER'S MALL ON WHICH THEY STOOD ON JULY 1, 2018, IF
PRACTICABLE.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent on the 26 completion of the construction that the Department of General Services began on Lawyer's 27 Mall in August 2018. The Department of General Services shall notify the Department of 28 Legislative Services within 5 days after the construction has ended.

29 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of this 30 Act, this Act shall take effect October 1, 2020.
