A BILL ENTITLED

1 AN ACT concerning

3 FOR the purpose of altering the membership of the Correctional Officers' Retirement 4 System to include certain individuals serving in a certain position in the Department $\mathbf{5}$ of Public Safety and Correctional Services; providing for the calculation of a certain 6 benefit from the Correctional Officers' Retirement System for individuals serving in 7 a certain position on or before a certain date; requiring the State Retirement Agency, 8 on or before a certain date, to notify certain individuals affected by this Act of their 9 right to transfer service credit to the Correctional Officers' Retirement System; providing for the application of this Act: requiring a certain transfer and combination 1011 of certain service credit for certain individuals; requiring the Board of Trustees for 12the State Retirement and Pension System to calculate a certain disability benefit for 13 certain individuals and to grant a certain benefit under certain circumstances; and 14generally relating to membership in the Correctional Officers' Retirement System.

AND BE IT FURTHER ENACTED, That, on or before January 1, 2021, 18 the State Retirement Agency shall notify the individuals who are affected by this Act of 19 their right to transfer service credit from the Employees' Retirement System or the 20Employees' Pension System to the Correctional Officers' Retirement System. 21SECTION 3. AND BE IT FURTHER ENACTED. That § 37–203(f)(3) of the State 22Personnel and Pensions Article does not apply to an individual who transfers service credit 23to the Correctional Officers' Retirement System under Title 37 of the State Personnel and 24Pensions Article in accordance with this Act. 25SECTION 4. AND BE IT FURTHER ENACTED, That: 26(a) This section applies to an individual who: 27is employed in a position affected by this Act on July 1, 2020; and (1)28(2)has no creditable service in the Employees' Pension System before July 291, 2008. 30 (b) An individual described under subsection (a) of this section shall have the individual's service credit from the Employees' Pension System transferred and combined 31with the individual's service in the Correctional Officers' Retirement System. 3233 (c) If an individual described under subsection (a) of this section is granted an

- ordinary disability benefit under Title 29, Subtitle 1 of the State Personnel and Pensions
 Article, the Board of Trustees for the State Retirement and Pension System shall calculate
 the ordinary disability benefit under §§ 29–106 and 29–108 of the State Personnel and
 Pensions Article and grant the individual the greater benefit.
