Court of Appeals and Court of Special Appeals – Renaming

3 FOR the purpose of proposing an amendment to the Maryland Constitution to change the 4 name of the Court of Appeals to be the Supreme Court of Maryland, to change the $\mathbf{5}$ name of the Court of Special Appeals to be the Maryland Appellate Court, to change 6 the name of a Judge of the Court of Appeals to be a Justice of the Supreme Court of 7 Maryland, and to change the name of the Chief Judge of the Court of Appeals to be 8 the Chief Justice of the Supreme Court of Maryland; providing that the Supreme 9 Court of Maryland is the successor to the Court of Appeals; providing that the 10 Maryland Appellate Court is the successor to the Court of Special Appeals; providing 11 that a Justice of the Supreme Court of Maryland is the successor to a Judge of the 12Court of Appeals; providing that the Chief Justice of the Supreme Court of Maryland 13is the successor to the Chief Judge of the Court of Appeals; providing that certain names and titles of a certain unit and officials in laws and other documents mean 14the names and titles of the successor unit and officials; providing for the continuity 1516of certain matters and persons; providing that letterhead, business cards, and other 17documents reflecting the renaming of the Court of Appeals, the Court of Special 18Appeals, a Judge of the Court of Appeals, and the Chief Judge of the Court of Appeals 19may not be used until all letterhead, business cards, and other documents already in 20print and reflecting the name of the Court of Appeals, the Court of Special Appeals, 21a Judge of the Court of Appeals, and the Chief Judge of the Court of Appeals before 22the effective date of this Act are used; changing references to the Court of Appeals, 23the Court of Special Appeals, a Judge of the Court of Appeals, and the Chief Judge 24of the Court of Appeals in the Annotated Code of Maryland to the Supreme Court of 25Maryland, the Maryland Appellate Court, a Justice of the Supreme Court of 26Maryland, and the Chief Justice of the Supreme Court of Maryland, respectively, on 27the passage and ratification of a certain constitutional amendment; making stylistic 28changes; requiring the publisher of the Annotated Code of Maryland, in consultation 29with and subject to the approval of the Department of Legislative Services, to correct

Article II – Executive Department

24 **6**.

(a) If the Governor-elect is disqualified, resigns, or dies, the Lieutenant
Governor-elect shall become Governor for the full term. If the Governor-elect fails to
assume office for any other reason, the newly elected Lieutenant Governor shall become
Lieutenant Governor and shall serve as acting Governor until the Governor-elect assumes
office or until the office becomes vacant.

30 The Lieutenant Governor shall serve as acting Governor when notified in (b)31 writing by the Governor that the Governor will be temporarily unable to perform the duties 32of [his] THE GOVERNOR'S office. The Lieutenant Governor also shall serve as acting 33 Governor when the Governor is disabled but is unable to communicate to the Lieutenant Governor the fact of [his] THE GOVERNOR'S inability to perform the duties of [his] THE 3435 GOVERNOR'S office. In either event the Lieutenant Governor shall serve as acting 36 Governor until notified in writing by the Governor that [he] THE GOVERNOR is able to 37 resume the duties of [his] THE GOVERNOR'S office or until the office becomes vacant.

The General Assembly, by the affirmative vote of three-fifths of all its 1 (c) $\mathbf{2}$ members in joint session, may adopt a resolution declaring that the Governor or Lieutenant 3 Governor is unable by reason of physical or mental disability to perform the duties of [his] 4 **THEIR** office. When action is undertaken pursuant to this subsection of the Constitution, $\mathbf{5}$ the officer who concludes that the other officer is unable, by reason of disability to perform 6 the duties of [his] THE office shall have the power to call the General Assembly into Joint 7 Session. The resolution, if adopted, shall be delivered to the [Court of Appeals] SUPREME 8 COURT OF MARYLAND, which then shall have exclusive jurisdiction to determine whether 9 that officer is unable by reason of the disability to perform the duties of [his] THE office. If 10 the [Court of Appeals] SUPREME COURT OF MARYLAND determines that such officer is unable to discharge the duties of [his] THE office by reason of a permanent disability, the 11 12office shall be vacant. If the [Court of Appeals] SUPREME COURT OF MARYLAND 13determines that such officer is unable to discharge the duties of [his] THE office by reason 14of a temporary disability, it shall declare the office to be vacant during the time of the 15disability and the Court shall have continuing jurisdiction to determine when the disability 16 has terminated. If the General Assembly and the [Court of Appeals] SUPREME COURT 17OF MARYLAND, acting in the same manner as described above, determine that the 18Governor-elect or Lieutenant Governor-elect is unable by reason of physical or mental 19disability to perform the duties of the **ELECTED** office [to which he has been elected], [he] 20THE ELECTED OFFICER shall be disgualified to assume office.

(d) When a vacancy occurs in the office of Governor, the Lieutenant Governor shall succeed to that office for the remainder of the term. When a vacancy occurs in the office of Lieutenant Governor, the Governor shall nominate a person who shall succeed to that office upon confirmation by the affirmative vote of a majority of all members of the General Assembly in joint session.

26If vacancies in the offices of Governor and Lieutenant Governor exist at the (e) 27same time, the General Assembly shall convene forthwith, and the office of Governor shall 28be filled for the remainder of the term by the affirmative vote of a majority of all members 29of the General Assembly in joint session. The person so chosen as Governor by the General 30 Assembly shall then nominate a person to succeed to the office of Lieutenant Governor, upon confirmation by the affirmative vote of a majority of all members of the General 31 32Assembly in the same joint session. The President of the Senate shall serve as acting 33 Governor until the newly elected Governor has qualified. If a vacancy exists in the office of Lieutenant Governor, at a time when the Lieutenant Governor is authorized to serve as 34 35acting Governor, the President of the Senate shall serve as acting Governor. If there is a 36 vacancy in the office of the President of the Senate at a time when [he] THE PRESIDENT 37 is authorized to serve as acting Governor, the Senate shall forthwith convene and fill the 38 vacancy.

(f) When the Lieutenant Governor or a person elected by the General Assembly succeeds to the office of Governor, [he] THE PERSON WHO SUCCEEDS TO THE OFFICE shall have the title, powers, duties, and emoluments of that office; but when the Lieutenant Governor or the President of the Senate serves as acting Governor, [he] THE LIEUTENANT

GOVERNOR shall have only the powers and duties of that office. When the President of the Senate serves as acting Governor, **[he] THE PRESIDENT** shall continue to be President of the Senate, but **[his] THE PRESIDENT'S** duties as president shall be performed by such other person as the Senate shall select.

5 (g) The [Court of Appeals] **SUPREME COURT OF MARYLAND** shall have 6 original and exclusive jurisdiction to adjudicate disputes or questions arising from the 7 failure of the Governor–elect to take office, or the service of the Lieutenant Governor or 8 President of the Senate as acting Governor, or the creation of a vacancy in the office of 9 Governor or Lieutenant Governor by reason of disability, or the succession to the office of 10 Governor or Lieutenant Governor, or the exercise of the powers and duties of a successor to 11 the office of Governor.

Article III – Legislative Department

13 5.

Following each decennial census of the United States and after public hearings, the Governor shall prepare a plan setting forth the boundaries of the legislative districts for electing of the members of the Senate and the House of Delegates.

17The Governor shall present the plan to the President of the Senate and Speaker of 18the House of Delegates who shall introduce the Governor's plan as a joint resolution to the 19General Assembly, not later than the first day of its regular session in the second year 20following every census, and the Governor may call a special session for the presentation of 21[his] THE plan prior to the regular session. The plan shall conform to Sections 2, 3 and 4 of 22this Article. Following each decennial census the General Assembly may by joint resolution 23adopt a plan setting forth the boundaries of the legislative districts for the election of 24members of the Senate and the House of Delegates, which plan shall conform to Sections 252, 3 and 4 of this Article. If a plan has been adopted by the General Assembly by the 45th 26day after the opening of the regular session of the General Assembly in the second year following every census, the plan adopted by the General Assembly shall become law. If no 2728plan has been adopted by the General Assembly for these purposes by the 45th day after 29the opening of the regular session of the General Assembly in the second year following 30 every census, the Governor's plan presented to the General Assembly shall become law.

Upon petition of any registered voter, the [Court of Appeals] **SUPREME COURT OF** MARYLAND shall have original jurisdiction to review the legislative districting of the State and may grant appropriate relief, if it finds that the districting of the State is not consistent with requirements of either the Constitution of the United States of America, or the Constitution of Maryland.

Every bill, when passed by the General Assembly, and sealed with the Great Seal, shall be presented by the presiding officer of the House in which it originated to the

1 Governor for [his] THE GOVERNOR'S approval. All bills passed during a regular or special $\mathbf{2}$ session shall be presented to the Governor for [his] THE GOVERNOR'S approval no later 3 than 20 days after adjournment. Within 30 days after presentment, if the Governor 4 approves the bill. [he] THE GOVERNOR shall sign the same in the presence of the presiding officers and Chief Clerks of the Senate and House of Delegates. Every Law shall be recorded $\mathbf{5}$ 6 in the office of the [Court of Appeals] SUPREME COURT OF MARYLAND, and in due time, 7 be printed, published and certified under the Great Seal, to the several Courts, in the same 8 manner as has been heretofore usual in this State.

10 (1) The General Assembly shall not appropriate any money out of the Treasury 11 except in accordance with the provisions of this section.

12 (2) Every appropriation bill shall be either a Budget Bill, or a Supplementary 13 Appropriation Bill, as hereinafter provided.

14(3)On the third Wednesday in January in each year, (except in the case of a newly 15elected Governor, and then not later than ten days after the convening of the General 16Assembly), unless such time shall be extended by the General Assembly, the Governor shall 17submit to the General Assembly a Budget for the next ensuing fiscal year. Each Budget 18 shall contain a complete plan of proposed expenditures and estimated revenues for said 19 fiscal year and shall show the estimated surplus or deficit of revenues at the end of the 20preceding fiscal year. Accompanying each Budget shall be a statement showing: (a) the 21revenues and expenditures for the preceding fiscal year; (b) the current assets, liabilities, 22reserves and surplus or deficit of the State; (c) the debts and funds of the State; (d) an 23estimate of the State's financial condition as of the beginning and end of the preceding fiscal 24year; (e) any explanation the Governor may desire to make as to the important features of 25the Budget and any suggestions as to methods for reduction or increase of the State's 26revenue.

27(4)Each Budget shall embrace an estimate of all appropriations in such form and 28detail as the Governor shall determine or as may be prescribed by law, as follows: (a) for 29the General Assembly as certified to the Governor in the manner hereinafter provided; (b) 30 for the Executive Department; (c) for the Judiciary Department, as provided by law, as 31certified to the Governor; (d) to pay and discharge the principal and interest of the debt of 32the State in conformity with Section 34 of Article III of the Constitution, and all laws 33 enacted in pursuance thereof; (e) for the salaries payable by the State and under the 34Constitution and laws of the State; (f) for the establishment and maintenance throughout 35 the State of a thorough and efficient system of public schools in conformity with Article 8 36 of the Constitution and with the laws of the State; and (g) for such other purposes as are 37 set forth in the Constitution or laws of the State.

38 (5) The Governor shall deliver to the presiding officer of each House the Budget 39 and a bill for all the proposed appropriations of the Budget classified and in such form and 40 detail as [he] **THE GOVERNOR** shall determine or as may be prescribed by law; and the 41 presiding officer of each House shall promptly cause said bill to be introduced therein, and

such bill shall be known as the "Budget Bill." The Governor may, with the consent of the 1 $\mathbf{2}$ General Assembly, before final action thereon by the General Assembly, amend or 3 supplement said Budget to correct an oversight, provide funds contingent on passage of 4 pending legislation or, in case of an emergency, by delivering such an amendment or $\mathbf{5}$ supplement to the presiding officers of both Houses; and such amendment or supplement 6 shall thereby become a part of said Budget Bill as an addition to the items of said bill or as 7a modification of or a substitute for any item of said bill such amendment or supplement 8 may affect.

9 The Budget and the Budget Bill as submitted by the Governor to the General (5a)10 Assembly shall have a figure for the total of all proposed appropriations and a figure for 11 the total of all estimated revenues available to pay the appropriations, and the figure for 12total proposed appropriations shall not exceed the figure for total estimated revenues. 13Neither the Governor in submitting an amendment or supplement to the Budget Bill nor 14the General Assembly in amending the Budget Bill shall thereby cause the figure for total proposed appropriations to exceed the figure for total estimated revenues, including any 1516 revisions, and in the Budget Bill as enacted the figure for total estimated revenues always 17shall be equal to or exceed the figure for total appropriations.

18 (6)The General Assembly shall not amend the Budget Bill so as to affect either the obligations of the State under Section 34 of Article III of the Constitution, or the 1920provisions made by the laws of the State for the establishment and maintenance of a system 21of public schools or the payment of any salaries required to be paid by the State of Maryland 22by the Constitution thereof; and the General Assembly may amend the bill by increasing 23or diminishing the items therein relating to the General Assembly, and by increasing or 24diminishing the items therein relating to the judiciary, but except as hereinbefore specified, 25may not alter the said bill except to strike out or reduce items therein, provided, however, 26that the salary or compensation of any public officer shall not be decreased during [his] 27THE PUBLIC OFFICER'S term of office; and such bill, when and as passed by both Houses, 28shall be a law immediately without further action by the Governor.

(7) The Governor and such representatives of the executive departments, boards, officers and commissions of the State expending or applying for State's moneys, as have been designated by the Governor for this purpose, shall have the right, and when requested by either House of the General Assembly, it shall be their duty to appear and be heard with respect to any Budget Bill during the consideration thereof, and to answer inquiries relative thereto.

35Supplementary Appropriation Bill. Either House may consider other (8)36 appropriations but both Houses shall not finally act upon such appropriations until after 37 the Budget Bill has been finally acted upon by both Houses, and no such other 38 appropriation shall be valid except in accordance with the provisions following: (a) Every 39 such appropriation shall be embodied in a separate bill limited to some single work, object 40 or purpose therein stated and called herein a Supplementary Appropriation Bill: (b) Each Supplementary Appropriation Bill shall provide the revenue necessary to pay the 41 appropriation thereby made by a tax, direct or indirect, to be levied and collected as shall 4243be directed in said bill; (c) No Supplementary Appropriation Bill shall become a law unless

1 it be passed in each House by a vote of a majority of the whole number of the members
2 elected, and the yeas and nays recorded on its final passage; (d) Each Supplementary
3 Appropriation Bill shall be presented to the Governor of the State as provided in Section
4 17 of Article 2 of the Constitution and thereafter all the provisions of said section shall
5 apply.

6 (9) Nothing in this section shall be construed as preventing the General Assembly 7 from passing at any time, in accordance with the provisions of Section 28 of Article 3 of the 8 Constitution and subject to the Governor's power of approval as provided in Section 17 of 9 Article 2 of the Constitution, an appropriation bill to provide for the payment of any 10 obligation of the State within the protection of Section 10 of Article 1 of the Constitution of 11 the United States.

(10) If the Budget Bill shall not have been finally acted upon by the Legislature seven days before the expiration of the regular session, the Governor shall issue a proclamation extending the session for some further period as may, in [his] THE **GOVERNOR'S** judgment, be necessary for the passage of such bill; but no matter other than such bill shall be considered during such extended session except a provision for the cost thereof.

18(11)For the purpose of making up the Budget, the Governor shall require from the 19 proper State officials (including all executive departments, all executive and administrative 20offices, bureaus, boards, commissions and agencies that expend or supervise the 21expenditure of, and all institutions applying, for State moneys and appropriations) such 22itemized estimates and other information, in such form and at such times as directed by 23the Governor. An estimate for a program required to be funded by a law which will be in 24effect during the fiscal year covered by the Budget and which was enacted before July 1 of 25the fiscal year prior to that date shall provide a level of funding not less than that prescribed 26in the law. The estimates for the Legislative Department, certified by the presiding officer 27of each House, of the Judiciary, as provided by law, certified by the [Chief Judge] CHIEF 28JUSTICE of the [Court of Appeals] SUPREME COURT OF MARYLAND, and for the public 29schools, as provided by law, shall be transmitted to the Governor, in such form and at such 30 times as directed by the Governor, and shall be included in the Budget without revision.

31The Governor may provide for public hearings on all estimates and may (12)32require the attendance at such hearings of representatives of all agencies, and for all 33 institutions applying for State moneys. After such public hearings [he] THE GOVERNOR may, in [his] THE GOVERNOR'S discretion, revise all estimates except those for the 34legislative and judiciary departments, and for the public schools, as provided by law, and 35except that [he] THE GOVERNOR may not reduce an estimate for a program below a level 36 37 of funding prescribed by a law which will be in effect during the fiscal year covered by the 38 Budget, and which was enacted before July 1 of the fiscal year prior thereto.

39 (13) The General Assembly may, from time to time, enact such laws not 40 inconsistent with this section, as may be necessary and proper to carry out its provisions.

1 In the event of any inconsistency between any of the provisions of this Section (14) $\mathbf{2}$ and any of the other provisions of the Constitution, the provisions of this Section shall 3 prevail. But nothing herein shall in any manner affect the provisions of Section 34 of Article 4 3 of the Constitution or of any laws heretofore or hereafter passed in pursuance thereof, or $\mathbf{5}$ be construed as preventing the Governor from calling extraordinary sessions of the General 6 Assembly, as provided by Section 16 of Article 2, or as preventing the General Assembly at $\mathbf{7}$ such extraordinary [extraordinary] sessions from considering any emergency appropriation 8 or appropriations.

9 (15) If any item of any appropriation bill passed under the provisions of this 10 Section shall be held invalid upon any ground, such invalidity shall not affect the legality 11 of the bill or of any other item of such bill or bills.

Article IV – Judiciary Department

13 1.

The Judicial power of this State is vested in a [Court of Appeals] **SUPREME COURT OF MARYLAND**, such intermediate courts of appeal as the General Assembly may create by law, Circuit Courts, Orphans' Courts, and a District Court. These Courts shall be Courts of Record, and each shall have a seal to be used in the authentication of all process issuing from it.

19 3.

20Except for the Judges of the District Court, the Judges of the several Courts other than the [Court of Appeals] SUPREME COURT OF MARYLAND or any intermediate courts 2122of appeal shall, subject to the provisions of Section 5 of this Article of the Constitution, be 23elected in Baltimore City and in each county, by the gualified voters of the city and of each 24county, respectively, all of the said Judges to be elected at the general election to be held 25on the Tuesday after the first Monday in November, as now provided for in the Constitution. 26Each of the said Judges shall hold [his] THE office for the term of fifteen years from the 27time of [his] THE election, and until [his] THE JUDGE'S successor is elected and qualified, 28or until [he] THE JUDGE shall have attained the age of seventy years, whichever may first 29happen, and be reeligible thereto until [he] THE JUDGE shall have attained the age of 30 seventy years, and not after. In case of the inability of any of said Judges to discharge [his] 31 THE JUDGE'S duties with efficiency, by reason of continued sickness, or of physical or 32mental infirmity, it shall be in the power of the General Assembly, two-thirds of the 33 members of each House concurring, with the approval of the Governor to retire said Judge from office. 34

35 3A.

(a) (1) Except as provided in paragraph (2) of this subsection, any former
 judge, except a former judge of the Orphans' Court, may be assigned by the [Chief Judge]
 CHIEF JUSTICE of the [Court of Appeals] SUPREME COURT OF MARYLAND, upon

approval of a majority of the court, to sit temporarily in any court of this State, except an
 Orphans' Court, as provided by law.

3 (2) (i) A retired judge of the Circuit Court for Montgomery County that 4 sits as the Orphans' Court for Montgomery County may be assigned by the [Chief Judge] 5 CHIEF JUSTICE of the [Court of Appeals] SUPREME COURT OF MARYLAND, upon 6 approval of a majority of the [Court of Appeals] SUPREME COURT OF MARYLAND, to do 7 an act that a judge of the Orphans' Court for Montgomery County is authorized to perform.

8 (ii) A retired judge of the Circuit Court for Harford County that sits 9 as the Orphans' Court for Harford County may be assigned by the [Chief Judge] CHIEF 10 JUSTICE of the [Court of Appeals] SUPREME COURT OF MARYLAND, upon approval of 11 a majority of the [Court of Appeals] SUPREME COURT OF MARYLAND, to do an act that 12 a judge of the Orphans' Court for Harford County is authorized to perform.

13 (b) The provisions of this section apply, notwithstanding provisions appearing 14 elsewhere in this Article pertaining to retirement of judges upon attaining age 70.

15 4B.

16 (a) (1) The Commission on Judicial Disabilities has the power to:

(i) Investigate complaints against any JUSTICE OR judge of the
[Court of Appeals] SUPREME COURT OF MARYLAND, any intermediate courts of appeal,
the circuit courts, the District Court of Maryland, or the orphans' court; and

(ii) Conduct hearings concerning such complaints, administer oaths and affirmations, issue process to compel the attendance of witnesses and the production of evidence, and require persons to testify and produce evidence by granting them immunity from prosecution or from penalty or forfeiture.

(2) The Commission has the power to issue a reprimand and the power to
 recommend to the [Court of Appeals] SUPREME COURT OF MARYLAND the removal,
 censure, or other appropriate disciplining of a JUSTICE OR judge or, in an appropriate case,
 retirement.

(3) All proceedings, testimony, and evidence before the Commission shall
be confidential and privileged, except as provided by rule of the [Court of Appeals] **SUPREME COURT OF MARYLAND**; the record and any proceeding filed with the [Court of
Appeals] SUPREME COURT OF MARYLAND shall lose its confidential character, except
as ordered by the [Court of Appeals] SUPREME COURT OF MARYLAND.

33 (4) No **JUSTICE OR** judge shall participate as a member of the Commission 34 in any proceedings involving that **JUSTICE'S OR** judge's own conduct, and the Governor 35 shall appoint another **JUSTICE OR** judge as a substitute member of the Commission for 36 those proceedings.

1 (5) The [Court of Appeals] **SUPREME COURT OF MARYLAND** shall 2 prescribe by rule the means to implement and enforce the powers of the Commission and 3 the practice and procedure before the Commission.

4 (b) (1)Upon any recommendation of the Commission, the [Court of Appeals] $\mathbf{5}$ SUPREME COURT OF MARYLAND, after a hearing and upon a finding of misconduct while 6 in office, or of persistent failure to perform the duties of the office, or of conduct prejudicial 7 to the proper administration of justice, may remove the JUSTICE OR judge from office or 8 may censure or otherwise discipline the JUSTICE OR judge, or the [Court of Appeals] SUPREME COURT OF MARYLAND, after hearing and upon a finding of disability which is 9 10 or is likely to become permanent and which seriously interferes with the performance of 11 the JUSTICE'S OR judge's duties, may retire the JUSTICE OR judge from office.

12 (2) A JUSTICE OR judge removed under this section, and the JUSTICE'S 13 OR judge's surviving spouse, shall have the rights and privileges accruing from the 14 JUSTICE'S OR judge's judicial service only to the extent prescribed by the order of removal.

15 (3) A JUSTICE OR judge retired under this section shall have the rights 16 and privileges prescribed by law for other retired JUSTICES OR judges.

17 (4) No [judge] JUSTICE of the [Court of Appeals] SUPREME COURT OF
 MARYLAND shall sit in judgment in any hearing involving that [judge's] JUSTICE'S own
 19 conduct.

20 (c) This section is alternative to, and cumulative with, the methods of retirement 21 and removal provided in Sections 3 and 4 of this Article, and in Section 26 of Article III of 22 this Constitution.

(a) A vacancy in the office of a JUSTICE OR judge of an appellate court, whether
occasioned by the death, resignation, removal, retirement, disqualification by reason of age,

All State and county officers elected by qualified voters (except judges of the Circuit Courts, [judges of the Supreme Bench of Baltimore City, judges of the Court of Appeals] JUSTICES OF THE SUPREME COURT OF MARYLAND and judges of any intermediate courts of appeal) shall hold office for terms of four years, and until their successors shall qualify.

12 SECTION 2. AND BE IT FURTHER ENACTED, That, as provided in this Act:

13 (a) The Supreme Court of Maryland is the successor to the Court of Appeals.

14 (b) The Maryland Appellate Court is the successor to the Court of Special 15 Appeals.

16 (c) A Justice of the Supreme Court of Maryland is the successor to a Judge of the 17 Court of Appeals.

18 (d) The Chief Justice of the Supreme Court of Maryland is the successor to the19 Chief Judge of the Court of Appeals.

20 (e) In every law, executive order, rule, regulation, policy, or document created by 21 an official, an employee, or a unit of this State, the names and titles of those units and 22 officials mean the names and titles of the successor unit or official.

SECTION 3. AND BE IT FURTHER ENACTED, That nothing in this Act affects the term of office of an appointed or elected member of any commission, office, department, agency, or other unit. An individual who is a member of a unit on the effective date of this Act shall remain a member for the balance of the term to which appointed or elected unless the member sooner dies, resigns, or is removed under provisions of law.

28SECTION 4.
