2 **Public Schools – Staff Members – Report**

3 FOR the purpose of requiring each county board of education to submit a certain report to
4 the State Board of Education on the ratio of students to certain staff members in the
5 school; requiring each county board to submit a certain report to the State Board,
6 the Governor, and certain legislative committees on or before a certain date each
7 year; and generally relating to staff in public schools.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **6–124.**

17 **(A) ON OR BEFORE JULY 1, 2021, AND EACH JULY 1 THEREAFTER, EACH**
18 **COUNTY BOARD SHALL SUBMIT A REPORT ON THE RATIO OF STUDENTS TO STAFF**

7 (1) STUDENTS TO EACH OF THE FOLLOWING STAFF MEMBERS FOR
 8 EACH SCHOOL IN THE LOCAL SCHOOL SYSTEM:

9 (I) SCHOOL COUNSELOR;

10 (II) SCHOOL PSYCHOLOGIST;

11 (III) SOCIAL WORKER;

12 (IV) OCCUPATIONAL THERAPIST;

13 (V) SPEECH PATHOLOGIST; AND

14 (VI) BILINGUAL FACILITATOR; AND

15 (2) STUDENTS TO EACH OF THE STAFF MEMBERS LISTED IN
 16 ~~PARAGRAPH ITEM~~ (1)(I) THROUGH (IV) OF THIS SUBSECTION IN THE LOCAL SCHOOL
 17 SYSTEM IN TOTAL.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 19 1, 2020.
