## A BILL ENTITLED

1 AN ACT concerning

2 **Public Schools – Staff Members – Report**

3 FOR the purpose of requiring each county board of education to submit a certain report to  
4 the State Board of Education on the ratio of students to certain staff members in the  
5 school; requiring each county board to submit a certain report to the State Board,  
6 the Governor, and certain legislative committees on or before a certain date each  
7 year; and generally relating to staff in public schools.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **6–124.**

17 **(A) ON OR BEFORE JULY 1, 2021, AND EACH JULY 1 THEREAFTER, EACH**  
18 **COUNTY BOARD SHALL SUBMIT A REPORT ON THE RATIO OF STUDENTS TO STAFF**  
19 **MEMBERS TO THE STATE BOARD, THE GOVERNOR, AND, IN ACCORDANCE WITH §**  
20 **2–1257 OF THE STATE GOVERNMENT ARTICLE, THE SENATE EDUCATION, HEALTH,**  
21 **AND ENVIRONMENTAL AFFAIRS COMMITTEE AND THE HOUSE COMMITTEE ON**  
22 **WAYS AND MEANS.**

1 SHALL INCLUDE THE RATIO, AT THE END OF THE PREVIOUS SCHOOL YEAR, OF:

2 (1) STUDENTS TO EACH OF THE FOLLOWING STAFF MEMBERS FOR  
3 EACH SCHOOL IN THE LOCAL SCHOOL SYSTEM:

4 (I) SCHOOL COUNSELOR;

5 (II) SCHOOL PSYCHOLOGIST;

6 (III) SOCIAL WORKER;

7 (IV) OCCUPATIONAL THERAPIST;

8 (V) SPEECH PATHOLOGIST; AND

9 (VI) BILINGUAL FACILITATOR; AND

10 (2) STUDENTS TO EACH OF THE STAFF MEMBERS LISTED IN  
11 PARAGRAPH (1)(I) THROUGH (IV) OF THIS SUBSECTION IN THE LOCAL SCHOOL  
12 SYSTEM IN TOTAL.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
14 1, 2020.
