- 3 ESTABLISHMENT THAT IS REQUIRED TO BE IN COMPLIANCE WITH THE TRANSIENT
- 4 LODGING REQUIREMENTS OF THE AMERICANS WITH DISABILITIES ACT.
- 5 (B) ON OR BEFORE APRIL 1, 2021, EACH ACCESSIBLE ROOM IN A LODGING
- 6 ESTABLISHMENT SHALL BE FURNISHED WITH A BED THAT:
- 7 (1) MEASURES AT LEAST 20 INCHES BUT NOT MORE THAN 23 INCHES
- 8 HIGH FROM THE FLOOR TO THE TOP OF THE MATTRESS, WHETHER OR NOT THE
- 9 MATTRESS IS COMPRESSED; AND
- 10 (2) HAS AT LEAST A 7-INCH VERTICAL CLEARANCE UNDER THE BED
