Public Health – Unborn Child Protection From Dismemberment Abortion Act

3 FOR the purpose of prohibiting, except under certain circumstances, the performance of or 4 the attempt to perform a dismemberment abortion that kills an unborn child on a 5 pregnant woman; authorizing a certain individual to seek a hearing before the State 6 Board of Physicians on a certain issue; providing that certain findings of the Board 7 from a certain hearing are admissible on that issue at a certain trial; providing for 8 the delay of a certain trial for a certain purpose for a certain number of days; 9 exempting certain individuals from liability for performing or attempting to perform 10 a dismemberment abortion; authorizing certain individuals to bring a civil action 11 under certain circumstances; authorizing certain individuals to apply to a certain 12 court for permanent injunctive relief against a certain individual under certain 13 circumstances; authorizing a certain court to award certain damages; providing that 14 no damages may be awarded under certain circumstances; providing for the award 15 of certain attorney's fees under certain circumstances; requiring a court to issue 16 certain orders under certain circumstances; requiring certain individuals to use a 17 pseudonym to bring a certain action in court under certain circumstances; providing 18 for the construction of various provisions of this Act; establishing a certain short 19 title; defining certain terms; and generally relating to the Unborn Child Protection 20 From Dismemberment Abortion Act.

- 21 (C) IN THE ABSENCE OF THE WRITTEN CONSENT OF THE WOMAN ON WHOM
- 22 A DISMEMBERMENT ABORTION WAS PERFORMED OR ATTEMPTED, ANY INDIVIDUAL
- 23 OTHER THAN A PUBLIC OFFICIAL WHO BRINGS AN ACTION UNDER § 20–220 OF THIS
- 24 SUBTITLE SHALL DO SO UNDER A PSEUDONYM.
