A BILL ENTITLED

1 AN ACT concerning

2 **Washington County – Adult Public Guardianship Review Board – Membership**

3 FOR the purpose of altering the membership of the Adult Public Guardianship Review
4 Board of Washington County to require one member to be a psychiatrist or
5 psychologist; and generally relating to the Adult Public Guardianship Review Board
6 of Washington County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Family Law**

20 14–101.

21 (a) In this title the following words have the meanings indicated.

22 (n) “Review board” means the adult public guardianship review board.

- 1 (a) (1) Each review board consists of 11 members appointed:
- 2 (i) by the county commissioners;
- 3 (ii) in Baltimore City, by the Mayor with the advice and consent of
4 the City Council;
- 5 (iii) in any county that has a county executive, by the county
6 executive with the advice and consent of the county council; or
- 7 (iv) if 2 or more counties have agreed to establish a multicounty
8 review board, jointly by the appropriate officials of the counties served by the board.
- 9 (2) Of the 11 members:
- 10 (i) 1 shall be a professional representative of a local department;
- 11 (ii) 1. in counties other than St. Mary's County **OR**
12 **WASHINGTON COUNTY:**
- 13 A. 1 shall be a physician's assistant, nurse practitioner, or
14 physician who is not a psychiatrist; and
- 15 B. 1 shall be a psychiatrist; and
- 16 2. in St. Mary's County **AND WASHINGTON COUNTY:**
- 17 A. 1 shall be a physician's assistant, nurse practitioner, or
18 physician who is not a psychiatrist; and
- 19 B. 1 shall be a psychiatrist or psychologist;
- 20 (iii) 1 shall be a representative of a local commission on aging;
- 21 (iv) 1 shall be a professional representative of a local nonprofit social
22 service organization;
- 23 (v) 1 shall be a lawyer;
- 24 (vi) 2 shall be lay individuals;
- 25 (vii) 1 shall be a registered nurse;
- 26 (viii) 1 shall be a professional in the field of disabilities; and
- 27 (ix) 1 shall be a person with a physical disability.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2020.
