3 FOR the purpose of altering the membership of the Adult Public Guardianship Review
4 Board of Washington County to require one member to be a psychiatrist or
5 psychologist; and generally relating to the Adult Public Guardianship Review Board

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Family Law**

20 14–101.

1 (a) In this title the following words have the meanings indicated.

2 (n) "Review board" means the adult public guardianship review board.

3 14-402.

4 (a) (1) Each review board consists of 11 members appointed:

5 (i) by the county commissioners;

6 (ii) in Baltimore City, by the Mayor with the advice and consent of
7 the City Council;

8 (iii) in any county that has a county executive, by the county
9 executive with the advice and consent of the county council; or

10 (iv) if 2 or more counties have agreed to establish a multicounty
11 review board, jointly by the appropriate officials of the counties served by the board.

12 (2) Of the 11 members:

13 (i) 1 shall be a professional representative of a local department;

14 (ii) 1. in counties other than St. Mary's County **OR**
15 **WASHINGTON COUNTY:**

16 A. 1 shall be a physician's assistant, nurse practitioner, or
17 physician who is not a psychiatrist; and

18 B. 1 shall be a psychiatrist; and

19 2. in St. Mary's County **AND WASHINGTON COUNTY:**

20 A. 1 shall be a physician's assistant, nurse practitioner, or
21 physician who is not a psychiatrist; and

22 B. 1 shall be a psychiatrist or psychologist;

23 (iii) 1 shall be a representative of a local commission on aging;

24 (iv) 1 shall be a professional representative of a local nonprofit social
25 service organization;

26 (v) 1 shall be a lawyer;

27 (vi) 2 shall be lay individuals;

- 1 (vii) 1 shall be a registered nurse;
- 2 (viii) 1 shall be a professional in the field of disabilities; and
- 3 (ix) 1 shall be a person with a physical disability.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2020.
