1 AN ACT concerning

2 **Public Safety – 9–1–1 Emergency Telephone System**

3 FOR the purpose of altering references to the terms “9–1–1 fee” and “additional charge”,
4 respectively, to be “State 9–1–1 fee” and “county 9–1–1 fee”, respectively, and
5 altering the definition of “public safety answering point” for purposes of provisions
6 of law concerning the 9–1–1 emergency telephone system; requiring certain
7 educational information made available by the State or a county to include
8 information on certain requirements for certain multiple–line telephone systems;
9 requiring certain public safety answering points to employ certain protocols for the
10 processing of 9–1–1 requests for emergency assistance; requiring a public safety
11 answering point to ensure each 9–1–1 specialist employed by the public safety
12 answering point is certified in certain disciplines; authorizing a public safety
13 answering point to establish a telecommunicator emergency response team for a
14 certain purpose; requiring each public safety answering point to adopt and
15 implement certain occupational wellness programs; renaming the Emergency
16 Number Systems Board to be the Maryland 9–1–1 Board; ~~altering the composition~~
17 ~~of the Board;~~ requiring the Board to establish certain training standards for public
18 safety answering point personnel concerning Next Generation 9–1–1 topics;
19 requiring certain standards established by the Board to include minimum standards
20 for 9–1–1 specialists to obtain continuing education; requiring the Board, at least
21 once each year, to conduct a certain audit of each public safety answering point;
22 authorizing the audit to be conducted concurrently with a certain inspection of the
23 public safety answering point; requiring the Board to establish certain standards
24 governing the processing of 9–1–1 requests for assistance; prohibiting money

39 (a) In this subtitle the following words have the meanings indicated.

1 (b) [“Additional charge” means the charge imposed by a county in accordance
2 with § 1–311 of this subtitle.

3 (c) “Board” means the [Emergency Number Systems] **MARYLAND 9–1–1** Board.

4 [(d)] (C) “Commercial mobile radio service” or “CMRS” means mobile
5 telecommunications service that is:

6 (1) provided for profit with the intent of receiving compensation or
7 monetary gain;

8 (2) an interconnected, two–way voice service; and

9 (3) available to the public.

10 [(e)] (D) “Commercial mobile radio service provider” or “CMRS provider” means
11 a person authorized by the Federal Communications Commission to provide CMRS in the
12 State.

13 (E) **“COUNTY 9–1–1 FEE” MEANS THE FEE IMPOSED BY A COUNTY IN**
14 **ACCORDANCE WITH § 1–311 OF THIS SUBTITLE.**

15 (f) “County plan” means a plan for a 9–1–1 system or enhanced 9–1–1 system, or
16 an amendment to the plan, developed by a county or several counties together under this
17 subtitle.

18 (g) (1) “Customer” means:

19 (i) the person that contracts with a home service provider for CMRS;
20 or

21 (ii) the end user of the CMRS if the end user of the CMRS is not the
22 contracting party.

23 (2) “Customer” does not include:

24 (i) a reseller of CMRS; or

25 (ii) a serving carrier under an arrangement to serve the customer
26 outside the home service provider’s licensed service area.

27 (h) “Enhanced 9–1–1 system” means a 9–1–1 system that provides:

28 (1) automatic number identification;

29 (2) automatic location identification; and

1 (3) any other technological advancements that the Board requires.

2 (i) "FCC order" means an order issued by the Federal Communications
3 Commission under proceedings regarding the compatibility of enhanced 9-1-1 systems and
4 delivery of wireless enhanced 9-1-1 service.

5 (j) "Home service provider" means the facilities-based carrier or reseller that
6 contracts with a customer to provide CMRS.

7 (k) "Next Generation 9-1-1 services" means an Internet Protocol (IP)-based
8 system, comprised of hardware, software, data, and operational policies and procedures,
9 that:

10 (1) provides standardized interfaces from emergency call and message
11 services to support emergency communications;

12 (2) processes all types of requests for emergency services, including voice,
13 text, data, and multimedia information;

14 (3) acquires and integrates additional emergency call data useful to
15 routing and handling of requests for emergency services;

16 (4) delivers the emergency calls, messages, and data to the appropriate
17 public safety answering point and other appropriate emergency entities;

18 (5) supports data or video communications needs for coordinated incident
19 response and management; and

20 (6) provides broadband service to public safety answering points or other
21 first responder entities.

22 (l) "9-1-1-accessible service" means telephone service or another
23 communications service that connects an individual dialing the digits 9-1-1 to an
24 established public safety answering point.

25 (m) ["9-1-1 fee" means the fee imposed in accordance with § 1-310 of this subtitle.

26 (n)] (1) "9-1-1 service carrier" means a provider of CMRS or other
27 9-1-1-accessible service.

28 (2) "9-1-1 service carrier" does not include a telephone company.

29 [(o)] (N) "9-1-1 specialist" means an employee of a county public safety
30 answering point, or an employee working in a county public safety answering point, whose
31 duties and responsibilities include:

1 (1) receiving and processing 9–1–1 requests for emergency services;

2 (2) other support functions directly related to 9–1–1 requests for
3 emergency services; or

4 (3) dispatching law enforcement officers, fire rescue services, emergency
5 medical services, and other public safety services to the scene of an emergency.

6 **[(p)] (O)** (1) “9–1–1 system” means telephone service that:

7 (i) meets the planning guidelines established under this subtitle;
8 and

9 (ii) automatically connects an individual dialing the digits 9–1–1 to
10 an established public safety answering point.

11 (2) “9–1–1 system” includes:

12 (i) equipment for connecting and outswitching 9–1–1 calls within a
13 telephone central office;

14 (ii) trunking facilities from a telephone central office to a public
15 safety answering point; and

16 (iii) equipment to connect 9–1–1 calls to the appropriate public safety
17 agency.

18 **[(q)] (P)** “9–1–1 Trust Fund” means the fund established under § 1–308 of this
19 subtitle.

20 **[(r)] (Q)** “Prepaid wireless E 9–1–1 fee” means the fee that is required to be
21 collected by a seller from a consumer in the amount established under § 1–313 of this
22 subtitle.

23 **[(s)] (R)** “Prepaid wireless telecommunications service” means a commercial
24 mobile radio service that:

25 (1) allows a consumer to dial 9–1–1 to access the 9–1–1 system;

26 (2) must be paid for in advance; and

27 (3) is sold in predetermined units that decline with use in a known amount.

28 **[(t)] (S)** “Public safety agency” means:

29 (1) a functional division of a public agency that provides fire fighting,
30 police, medical, or other emergency services; or

1 (2) a private entity that provides fire fighting, police, medical, or other
2 emergency services on a voluntary basis.

3 **[(u)] (T)** “Public safety answering point” means a communications facility that:

4 (1) is operated on a 24-hour basis;

5 (2) first receives 9-1-1 requests for emergency services in a 9-1-1 service
6 area; and

7 (3) as appropriate[,];

8 **(I)** dispatches public safety services directly[,];

9 **(II) TRANSMITS INCIDENT DATA TO APPROPRIATE PUBLIC
10 SAFETY AGENCIES WITHIN THE STATE FOR THE DISPATCH OF PUBLIC SAFETY
11 SERVICES; or**

12 **(III) transfers 9-1-1 requests for emergency services OR TRANSMITS
13 INCIDENT DATA to [appropriate public safety agencies];**

22 service to another person.

23 **(W) “STATE 9-1-1 FEE” MEANS THE FEE IMPOSED IN ACCORDANCE WITH §
24 1-310 OF THIS SUBTITLE.**

25 (x) “Wireless enhanced 9-1-1 service” means enhanced 9-1-1 service under an
26 FCC order.

7 (a) On recommendation of the Board, each year the Secretary shall request an
8 appropriation from the 9-1-1 Trust Fund in an amount sufficient to:

- 9 (1) carry out the purposes of this subtitle;
- 10 (2) pay the administrative costs chargeable to the 9-1-1 Trust Fund; and
- 11 (3) reimburse counties for the cost of enhancing a 9-1-1 system.

12 (b) (1) Subject to the limitations under subsection (e) of this section, the
13 Comptroller shall disburse the money in the 9-1-1 Trust Fund as provided in this
14 subsection.

15 (2) Each July 1, the Comptroller shall allocate sufficient money from the
16 **STATE** 9-1-1 fee to pay the costs of administering the 9-1-1 Trust Fund.

17 (3) As directed by the Secretary and in accordance with the State budget,
18 the Comptroller, from the appropriate account, shall:

- 19 (i) reimburse counties for the cost of enhancing a 9-1-1 system;

28 operation costs on September 30, December 31, March 31, and June 30 of each year.

30 this subsection.

- 1 (2) Money collected from the **STATE 9-1-1** fee may be used only to:
- 2 (i) pay the administrative costs chargeable to the 9-1-1 Trust Fund;
- 3 (ii) reimburse counties for the cost of enhancing a 9-1-1 system;
- 4 (iii) pay contractors in accordance with § 1-306(b)(12) of this subtitle;

- 6 (iv) pay the costs associated with maintenance, operations, and
- 7 programs approved by the Board in accordance with § 1-308(b) of this subtitle.

8 (3) Money collected from the [additional charge] **COUNTY 9-1-1 FEE** may

9 be used by the counties only for the maintenance and operation costs of the 9-1-1 system.

10 (4) Money collected from the prepaid wireless E 9-1-1 fee shall be used as

11 follows:

12 (i) 25% for the same purpose as the 9-1-1 fee under paragraph (2)

13 of this subsection; and

14 (ii) 75% for the same purpose as the [additional charge] **COUNTY**
