## A BILL ENTITLED

1 AN ACT concerning

### 2 **Child Support – Guidelines**

3 FOR the purpose of authorizing a court, in determining whether the application of the child  
4 support guidelines would be unjust or inappropriate in a particular case, to consider  
5 whether an obligor's monthly obligation would leave the obligor with a monthly  
6 actual income below the 2019 federal poverty level for an individual; authorizing the  
7 court to decline to establish a child support order under certain circumstances;  
8 specifying that the fact that a parent meets or ceases to meet certain criteria shall  
9 constitute a material change of circumstance for the purpose of a modification of a  
10 child support award; requiring the court to take certain actions if there is a dispute  
11 as to whether a parent is voluntarily impoverished; revising the schedule of basic  
12 child support obligations used to calculate the amount of a child support award under  
13 the child support guidelines; altering certain definitions; defining certain terms;  
14 providing for the application of this Act; providing for a delayed effective date; and  
15 generally relating to child support.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
27 That the Laws of Maryland read as follows:

**Article – Family Law**

2 12–201.

3 (a) In this subtitle the following words have the meanings indicated.

4 (b) (1) “Actual income” means income from any source.

5 (2) For income from self–employment, rent, royalties, proprietorship of a  
6 business, or joint ownership of a partnership or closely held corporation, “actual income”  
7 means gross receipts minus ordinary and necessary expenses required to produce income.

8 (3) “Actual income” includes:

9 (i) salaries;

10 (ii) wages;

11 (iii) commissions;

12 (iv) bonuses;

13 (v) dividend income;

14 (vi) pension income;

15 (vii) interest income;

16 (viii) trust income;

17 (ix) annuity income;

18 (x) Social Security benefits;

19 (xi) workers’ compensation benefits;

20 (xii) unemployment insurance benefits;

21 (xiii) disability insurance benefits;

22 (xiv) for the obligor, any third party payment paid to or for a minor  
23 child as a result of the obligor’s disability, retirement, or other compensable claim;

24 (xv) alimony or maintenance received; and

25 (xvi) expense reimbursements or in–kind payments received by a  
26 parent in the course of employment, self–employment, or operation of a business to the

1 extent the reimbursements or payments reduce the parent's personal living expenses.

2 (4) Based on the circumstances of the case, the court may consider the  
3 following items as actual income:

4 (i) severance pay;

5 (ii) capital gains;

6 (iii) gifts; or

7 (iv) prizes.

8 (5) "Actual income" does not include benefits received from means-tested  
9 public assistance programs, including temporary cash assistance, Supplemental Security  
10 Income, food stamps, and transitional emergency, medical, and housing assistance.

11 (c) "Adjusted actual income" means actual income minus:

12 (1) preexisting reasonable child support obligations actually paid; and

13 (2) except as provided in § 12–204(a)(2) of this subtitle, alimony or  
14 maintenance obligations actually paid.

15 (d) "Adjusted basic child support obligation" means an adjustment of the basic  
16 child support obligation for shared physical custody.

17 (e) "Basic child support obligation" means the base amount due for child support  
18 [based on] CALCULATED USING the combined adjusted actual incomes of both parents AS  
19 ADJUSTED BY THE SELF-SUPPORT RESERVE.

20 (f) "Combined adjusted actual income" means the combined monthly adjusted  
21 actual incomes of both parents.

22 (g) (1) "Extraordinary medical expenses" means uninsured costs for medical  
23 treatment in excess of \$250 in any calendar year.

24 (2) "Extraordinary medical expenses" includes uninsured, reasonable, and  
25 necessary costs for orthodontia, dental treatment, vision care, asthma treatment, physical  
26 therapy, treatment for any chronic health problem, and professional counseling or  
27 psychiatric therapy for diagnosed mental disorders.

28 (h) "Health insurance" includes medical insurance, dental insurance, prescription  
29 drug coverage, and vision insurance.

30 (i) "Income" means:

1                   (1) actual income of a parent, if the parent is employed to full capacity; or

2                   (2) potential income of a parent, if the parent is voluntarily impoverished.

3                   (j) "Obligee" means any person who is entitled to receive child support.

4                   (k) "Obligor" means an individual who is required to pay child support under a  
5 court order.

6                   (l) "Ordinary and necessary expenses" does not include amounts allowable by the  
7 Internal Revenue Service for the accelerated component of depreciation expenses or  
8 investment tax credits or any other business expenses determined by the court to be  
9 inappropriate for determining actual income for purposes of calculating child support.

10                  (m) "Potential income" means income attributed to a parent determined by:

11                   (1) the parent's employment potential and probable earnings level based  
12 on, but not limited to[, recent work history, occupational qualifications, prevailing job  
13 opportunities, and earnings levels in the community]:

14                   **(I) THE PARENT'S:**

15                   1. AGE;

16                   2. PHYSICAL AND BEHAVIORAL CONDITION;

17                   3. EDUCATIONAL ATTAINMENT;

18                   4. SPECIAL TRAINING OR SKILLS;

19                   5. LITERACY;

20                   6. RESIDENCE;

21                   7. OCCUPATIONAL QUALIFICATIONS AND JOB SKILLS;

22                   8. EMPLOYMENT AND EARNINGS HISTORY;

23                   9. RECORD OF EFFORTS TO OBTAIN AND RETAIN

24                  EMPLOYMENT; AND

25                   10. CRIMINAL RECORD AND OTHER EMPLOYMENT

26                  BARRIERS; AND

3                   1. THE STATUS OF THE JOB MARKET;

4                   2. PREVAILING EARNINGS LEVELS; AND

5                   3. THE AVAILABILITY OF EMPLOYERS WILLING TO HIRE

6 THE PARENT;

7                   (2) THE PARENT'S ASSETS;

8                   (3) THE PARENT'S ACTUAL INCOME FROM ALL SOURCES; AND

9                   (4) ANY OTHER FACTOR BEARING ON THE PARENT'S ABILITY TO

10 OBTAIN FUNDS FOR CHILD SUPPORT.

(N) "SELF-SUPPORT RESERVE" MEANS THE ADJUSTMENT TO A BASIC CHILD SUPPORT OBLIGATION ENSURING THAT A CHILD SUPPORT OBLIGOR MAINTAINS A MINIMUM AMOUNT OF MONTHLY INCOME, AFTER PAYMENT OF CHILD SUPPORT, FEDERAL AND STATE INCOME TAXES, AND FEDERAL INSURANCE CONTRIBUTION ACT TAXES, OF AT LEAST 110% OF THE 2019 FEDERAL POVERTY LEVEL FOR AN INDIVIDUAL.

17       [(n)] (o)     (1) "Shared physical custody" means that each parent keeps the  
18 child or children overnight for more than 35% of the year and that both parents contribute  
19 to the expenses of the child or children in addition to the payment of child support.

(2) Subject to paragraph (1) of this subsection, the court may base a child support award on shared physical custody:

(i) solely on the amount of visitation awarded; and

(ii) regardless of whether joint custody has been granted.

(P) "VOLUNTARILY IMPOVERISHED" MEANS THAT A PARENT HAS MADE THE FREE AND CONSCIOUS CHOICE, NOT COMPELLED BY FACTORS BEYOND THE PARENT'S CONTROL, TO RENDER THE PARENT WITHOUT ADEQUATE RESOURCES.

27 12-202.

(a) (1) Subject to the provisions of paragraph (2) of this subsection AND SUBSECTION (B) OF THIS SECTION, in any proceeding to establish or modify child support, whether pendente lite or permanent, the court shall use the child support guidelines set forth in this subtitle.

1                             (2) (i) There is a rebuttable presumption that the amount of child  
2 support which would result from the application of the child support guidelines set forth in  
3 this subtitle is the correct amount of child support to be awarded.

4                             (ii) The presumption may be rebutted by evidence that the  
5 application of the guidelines would be unjust or inappropriate in a particular case.

6                             (iii) In determining whether the application of the guidelines would  
7 be unjust or inappropriate in a particular case, the court may consider:

8                                 1. the terms of any existing separation or property  
9 settlement agreement or court order, including any provisions for payment of mortgages or  
10 marital debts, payment of college education expenses, the terms of any use and possession  
11 order or right to occupy the family home under an agreement, any direct payments made  
12 for the benefit of the children required by agreement or order, or any other financial  
13 considerations set out in an existing separation or property settlement agreement or court  
14 order; [and]

15                                 2. the presence in the household of either parent of other  
16 children to whom that parent owes a duty of support and the expenses for whom that parent  
17 is directly contributing; AND

18                             **3. WHETHER AN OBLIGOR'S MONTHLY CHILD SUPPORT  
19 OBLIGATION WOULD LEAVE THE OBLIGOR WITH A MONTHLY ACTUAL INCOME BELOW  
20 THE 2019 FEDERAL POVERTY LEVEL FOR AN INDIVIDUAL.**

21                             (iv) The presumption may not be rebutted solely on the basis of  
22 evidence of the presence in the household of either parent of other children to whom that  
23 parent owes a duty of support and the expenses for whom that parent is directly  
24 contributing.

25                             (v) 1. If the court determines that the application of the  
26 guidelines would be unjust or inappropriate in a particular case, the court shall make a  
27 written finding or specific finding on the record stating the reasons for departing from the  
28 guidelines.

29                                 2. The court's finding shall state:

30                                 A. the amount of child support that would have been required  
31 under the guidelines;

32                                 B. how the order varies from the guidelines;

33                                 C. how the finding serves the best interests of the child; and

1                   D.     in cases in which items of value are conveyed instead of a  
2 portion of the support presumed under the guidelines, the estimated value of the items  
3 conveyed.

4               **(B) (1) THE COURT MAY DECLINE TO ESTABLISH A CHILD SUPPORT**  
5 **ORDER IF THE PARENT WHO WOULD HAVE THE OBLIGATION TO PAY CHILD SUPPORT:**

6               **(I) LIVES WITH THE CHILD WHO WOULD BE THE SUBJECT OF**  
7 **THE CHILD SUPPORT ORDER AND IS CONTRIBUTING TO THE SUPPORT OF THE CHILD;**  
8 **OR**

9               **(II) 1. IS UNEMPLOYED;**

10              **2. HAS NO FINANCIAL RESOURCES FROM WHICH TO PAY**  
11 **CHILD SUPPORT; AND**

12              **3. A. IS INCARCERATED AND IS EXPECTED TO**  
13 **REMAIN INCARCERATED FOR THE REMAINDER OF THE TIME THAT THE PARENT**  
14 **WOULD HAVE A LEGAL DUTY TO SUPPORT THE CHILD;**

15              **B. IS INSTITUTIONALIZED IN A PSYCHIATRIC CARE**  
16 **FACILITY AND IS EXPECTED TO REMAIN INSTITUTIONALIZED FOR THE REMAINDER**  
17 **OF THE TIME THAT THE PARENT WOULD HAVE A LEGAL DUTY TO SUPPORT THE**  
18 **CHILD;**

19              **C. IS TOTALLY AND PERMANENTLY DISABLED, IS**  
20 **UNABLE TO OBTAIN OR MAINTAIN EMPLOYMENT, AND HAS NO INCOME OTHER THAN**  
21 **SUPPLEMENTAL SECURITY INCOME OR SOCIAL SECURITY DISABILITY INSURANCE**  
22 **BENEFITS; OR**

23              **D. IS UNABLE TO OBTAIN OR MAINTAIN EMPLOYMENT IN**  
24 **THE FORESEEABLE FUTURE DUE TO COMPLIANCE WITH CRIMINAL DETAINMENT,**  
25 **HOSPITALIZATION, OR A REHABILITATION TREATMENT PLAN.**

26              **(2) THE FACT THAT A PARENT MEETS OR CEASES TO MEET THE**  
27 **CRITERIA DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION SHALL CONSTITUTE**  
28 **A MATERIAL CHANGE OF CIRCUMSTANCE FOR THE PURPOSE OF A MODIFICATION OF**  
29 **A CHILD SUPPORT AWARD.**

30              **[(b)] (C)**   The adoption or revision of the guidelines set forth in this subtitle is not  
31 a material change of circumstance for the purpose of a modification of a child support  
32 award.

33              **[(c)] (D)**   On or before January 1, 1993, and at least every 4 years after that date,

1 the Child Support Administration of the Department of Human Services shall:

2                   (1) review the guidelines set forth in this subtitle to ensure that the  
3 application of the guidelines results in the determination of appropriate child support  
4 award amounts; and

5                   (2) report its findings and recommendations to the General Assembly,  
6 subject to § 2–1246 of the State Government Article.

7 12–204.

8                   (a) (1) The basic child support obligation shall be determined in accordance  
9 with the schedule of basic child support obligations in subsection (e) of this section. The  
10 basic child support obligation shall be divided between the parents in proportion to their  
11 adjusted actual incomes.

12                   (2) (i) If one or both parents have made a request for alimony or  
13 maintenance in the proceeding in which a child support award is sought, the court shall  
14 decide the issue and amount of alimony or maintenance before determining the child  
15 support obligation under these guidelines.

16                   (ii) If the court awards alimony or maintenance, the amount of  
17 alimony or maintenance awarded shall be considered actual income for the recipient of the  
18 alimony or maintenance and shall be subtracted from the income of the payor of the alimony  
19 or maintenance under § 12–201(c)(2) of this subtitle before the court determines the amount  
20 of a child support award.

21                   (b) (1) Except as provided in paragraph [(2)] (3) of this subsection, if a parent  
22 is voluntarily impoverished, child support may be calculated based on a determination of  
23 potential income.

24                   **(2) IF THERE IS A DISPUTE AS TO WHETHER A PARENT IS  
25 VOLUNTARILY IMPOVERISHED, THE COURT SHALL:**

26                   **(I) MAKE A FINDING AS TO WHETHER, BASED ON THE TOTALITY  
27 OF THE CIRCUMSTANCES, THE PARENT IS VOLUNTARILY IMPOVERISHED; AND**

28                   **(II) IF THE COURT FINDS THAT THE PARENT IS VOLUNTARILY  
29 IMPOVERISHED, CONSIDER THE FACTORS SPECIFIED IN § 12–201(M) OF THIS  
30 SUBTITLE IN DETERMINING THE AMOUNT OF POTENTIAL INCOME THAT SHOULD BE  
31 IMPUTED TO THE PARENT.**

32                   [(2)] (3) A determination of potential income may not be made for a  
33 parent who:

34                   (i) is unable to work because of a physical or mental disability; or

(e) Schedule of basic child support obligations[:]. AN ASTERISK (\*) INDICATES  
A CHILD SUPPORT OBLIGATION ADJUSTED BY THE SELF-SUPPORT RESERVE.
