A BILL ENTITLED

1 AN ACT concerning

2 **Racing and Community Development Act of 2020**

3 FOR the purpose of requiring the State Racing Commission to consider the health, safety,
4 and welfare of certain horses; requiring the Commission to establish the Equine
5 Health, Safety, and Welfare Advisory Committee; providing for the composition and
6 chair of the Advisory Committee; requiring the Advisory Committee to report on
7 certain activities and make certain recommendations; requiring the Commission to
8 include certain information in a certain report; altering the number of live racing
9 days the Commission is required to award each year; providing that certain
10 planning, zoning, and development regulations that apply to the Maryland Stadium
11 Authority do not apply to certain racing facilities; authorizing, subject to the
12 approval of the Board of Public Works, the Authority to issue up to a certain amount
13 of bonds for certain racing facilities; requiring the Authority to provide certain
14 committees of the General Assembly a certain report before seeking certain approval
15 of the Board of Public Works; requiring the Authority to obtain certain approval of
16 the Board of Public Works; requiring the Authority, before issuing certain bonds, to
17 ensure that certain long-term agreements are finalized; authorizing the Authority
18 to enter into a certain agreement with certain project entities; prohibiting the
19 Authority from having any responsibility for a racing facility after the completion of
20 a racing facility; authorizing the Authority to assist with enforcement of certain
21 warranties and claims; authorizing the Authority, if retained, to provide certain
22 services; establishing the Racing and Community Development Fund as a
23 continuing, nonlapsing fund; specifying the purpose of the Fund; requiring the
24 Authority to administer the Fund; requiring the State Treasurer to hold the Fund;
25 specifying the contents of the Fund; specifying the purpose for which the Fund may
26 be used; providing for the investment of money in and expenditures from the Fund;
27 requiring interest earnings of the Fund to be credited to the Fund; exempting the
28 Fund from a certain provision of law requiring interest earnings on State money to
29 accrue to the General Fund of the State; requiring the Comptroller to pay a certain
30 amount from a certain fund each year that certain bonds remain outstanding and
31 unpaid; altering the allocation of the Racetrack Facility Renewal Account; altering

1 the distribution of proceeds from video lottery terminals; requiring that certain local
2 impact grants are distributed in a certain manner for certain fiscal years; allowing a
3 subtraction modification under the Maryland income tax for gain received as a result
4 of the transfer of certain property and the amount of any income realized as the
5 result of an expenditure by certain governmental entities; providing an exemption
6 from the sales and use tax for the purchase of certain personal property used for
7 certain purposes; providing an exemption from certain property taxes for certain
8 improvements at certain locations; providing that transfers of certain property
9 between certain entities are not subject to certain recordation and transfer taxes;
10 establishing the Task Force on the Future of the Bowie Training Facility; providing
11 for the composition, chair, and staffing of the Task Force; prohibiting a member of
12 the Task Force from receiving certain compensation, but authorizing the
13 reimbursement of certain expenses; requiring the Task Force to study and make

19 memorandum of understanding that contains certain provisions; prohibiting the
20 Authority from beginning construction of a certain site until it receives a certain
21 memorandum of understanding; requiring that a certain memorandum of
22 understanding remain in place for a certain period of time; requiring the Maryland
23 Stadium Authority to conduct a certain feasibility study; making conforming
24 changes; defining certain terms; providing for the application and termination of
25 certain provisions of this Act; and generally relating to thoroughbred horse racing in
26 the State.

21 Preamble

22 WHEREAS, The thoroughbred horse racing and breeding industries in the State are
23 historically, culturally, and economically significant, and date back to the founding of the
24 Maryland Jockey Club in 1743; and

25 WHEREAS, The thoroughbred horse racing and breeding industries include the
26 agribusiness of hundreds of horse farms throughout the State, which preserve over 700,000
27 acres of open space; and

28 WHEREAS, The thoroughbred horse racing and breeding industries also provide
29 employment directly and indirectly for tens of thousands of Marylanders in various
30 capacities, including:

31 (1) owners, trainers, breeders, and others who raise and care for and train
32 horses for competition;

33 (2) employees at Pimlico Race Course in Baltimore City and Laurel Park
34 in Anne Arundel County; and

35 (3) a myriad of individuals and vendors that service the horse racing and
36 breeding industries, including veterinarians, farms, and others; and

1 WHEREAS, The Preakness Stakes, the middle jewel of thoroughbred racing's Triple
2 Crown, historically conducted at Pimlico, is a civic and culturally significant event and
3 brings national and international attention and substantial economic benefits to the State
4 annually; and

5 WHEREAS, The need for modernization of the Pimlico and Laurel Park racing
6 facilities has been recognized in master development plans adopted by the City of Baltimore
7 in 2006 and 2008 and by Anne Arundel County in 2007, 2008, and 2009, which master
8 development plans include but are not limited to a planned unit development plan and
9 related planned unit development plan sketches for Pimlico, and the Park Heights Plan,
10 and a 2008 approved sketch plan for Laurel Park; and

11 WHEREAS, The State has authorized funding and funded a number of the
12 improvements contemplated pursuant to master development plans through the Racetrack
13 Facilities Renewal Account in conjunction with industry and other funds; and

14 WHEREAS, The funding authorized by this Act will fund improvements arising from
15 and related to the aforementioned master development plans, with amounts attributable
16 to such funding being utilized pursuant to such master development plans; and

17 WHEREAS, It serves the State's interest in economic development, tourism,
18 community development, and other civic, cultural, and public activities and developments
19 to promote the Preakness Stakes and the thoroughbred horse racing and breeding
20 industries, which in turn are highly dependent on modern, state-of-the-art thoroughbred
21 racing facilities at Pimlico and Laurel Park; and

22 WHEREAS, The State's interest in advancing and promoting such activities will be
23 served by authorizing the funding and development of the racing, training, community
24 development, and related facilities, as set forth herein; now, therefore,

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
26 That the Laws of Maryland read as follows:

27 **Article – Business Regulation**

28 11–209.

29 (a) Besides its other powers under this title, the Commission has the powers
30 necessary or proper to carry out fully all the purposes of this title.

31 (b) (1) The jurisdiction, supervision, powers, and duties of the Commission
32 extend to each person who holds racing for a purse, reward, or stake.

33 (2) IN EXERCISING THE JURISDICTION, SUPERVISION, POWERS, AND
34 DUTIES OF THE COMMISSION UNDER THIS TITLE, THE COMMISSION SHALL
35 CONSIDER, IN ADDITION TO ANY OTHER FACTOR THE COMMISSION CONSIDERS

1 IMPORTANT, THE HEALTH, SAFETY, AND WELFARE OF HORSES ENGAGED IN RACING
2 AND TRAINING AT TRACKS AND TRAINING FACILITIES IN THE STATE.

3 (C) (1) THE COMMISSION SHALL ESTABLISH AN EQUINE HEALTH,
4 SAFETY, AND WELFARE ADVISORY COMMITTEE.

5 (2) THE EXECUTIVE DIRECTOR OF THE COMMISSION SHALL APPOINT
6 A MEMBER OF THE COMMISSION TO CHAIR THE ADVISORY COMMITTEE.

7 (3) THE ADVISORY COMMITTEE CONSISTS OF THE FOLLOWING
8 MEMBERS:

9 (I) THREE MEMBERS OF THE COMMISSION, APPOINTED BY THE
10 EXECUTIVE DIRECTOR OF THE COMMISSION;

11 (II) ONE REPRESENTATIVE OF THE RACING LICENSEES,
12 APPOINTED BY AN ORGANIZATION THAT REPRESENTS THE RACING LICENSEES;

13 (III) ONE REPRESENTATIVE OF THE HORSEMEN, APPOINTED BY
14 AN ORGANIZATION THAT REPRESENTS THE HORSEMEN;

15 (IV) ONE REPRESENTATIVE OF THE HORSE BREEDERS,
16 APPOINTED BY AN ORGANIZATION THAT REPRESENTS THE HORSE BREEDERS;

17 (V) THE COMMISSION'S EQUINE MEDICAL DIRECTOR;

18 (VI) A VETERINARIAN LICENSED IN THE STATE; AND

19 (VII) ANY OTHER INDIVIDUAL WITH EXPERTISE IN EQUINE OR
20 RACING INDUSTRIES THAT THE EXECUTIVE DIRECTOR OF THE COMMISSION
21 APPOINTS.

22 (4) THE EXECUTIVE DIRECTOR OF THE COMMISSION SHALL
23 DETERMINE THE TIME AND LOCATION OF ADVISORY COMMITTEE MEETINGS.

24 (5) THE ADVISORY COMMITTEE SHALL SERVE AS AN ADVISORY BODY
25 TO THE COMMISSION ON MATTERS RELATED TO THE HEALTH, SAFETY, AND
26 WELFARE OF HORSES ENGAGED IN RACING AND TRAINING AT TRACKS AND TRAINING
27 FACILITIES IN THE STATE.

28 (6) THE CHAIRMAN OF THE ADVISORY COMMITTEE SHALL REPORT
29 REGULARLY TO THE COMMISSION ON THE ACTIVITIES OF THE ADVISORY
30 COMMITTEE, INCLUDING ANY RECOMMENDATIONS FOR CHANGES TO RULES,

1 **REGULATIONS, LAWS, OR OTHER CONDITIONS OF RACING.**

2 11–213.

3 (a) On or before September 15 of each year, the Commission shall submit a report
4 to the Secretary and the Legislative Policy Committee about the preceding calendar year.

5 (b) Each report shall include:

6 (1) a statement of receipts and disbursements of the Commission;

7 (2) a summary of major events that occurred the preceding year that
8 affected horse racing in the State, including any significant changes at tracks in the region
9 as well as a discussion of legislative initiatives in the State;

10 (3) a 5–year assessment of each track regarding:

11 (i) attendance;

12 (ii) purse distributions;

13 (iii) live racing days that are allocated and used;

14 (iv) betting on live racing that is held at that track broken down by
15 the following categories:

16 1. betting conducted at the live track;

17 2. betting conducted at other Maryland tracks;

18 3. betting conducted at satellite simulcast facilities in the
19 State; and

20 4. betting conducted through out–of–state satellite
21 simulcasting;

22 (v) betting that is conducted at the live track on races simulcast from
23 other tracks in the State; and

24 (vi) betting that is conducted at the live track on races simulcast from
25 out–of–state tracks;

26 (4) information on all simulcast betting at satellite simulcast facilities in
27 the State, including information on how much is wagered on in–State races and how much
28 is bet on out–of–state races;

29 (5) information on all simulcast betting that is conducted out of state on

1 races being run live in this State;

2 (6) to the extent available, information on the breeding industry in the
3 State, including:

4 (i) the number of breeders in the State;

5 (ii) the number of foals registered in the State;

6 (iii) the average sales prices of foals; and

7 (iv) any other information pertaining to the regional and national
8 ranking of the State for breeding;

9 (7) all other information that is currently provided by the Commission in
10 its annual report;

11 (8) additional information on satellite simulcast facilities, as required
12 under § 11-831 of this title; [and]

13 (9) **A SUMMARY OF THE ACTIVITIES OF THE EQUINE HEALTH,
14 SAFETY, AND WELFARE ADVISORY COMMITTEE AND ANY RECOMMENDATIONS BY
15 THE COMMISSION FOR CHANGES TO STATE LAW NECESSARY FOR THE
16 ENHANCEMENT OF THE HEALTH, SAFETY, OR WELFARE OF HORSES ENGAGED IN
17 RACING AND TRAINING AT TRACKS AND TRAINING FACILITIES IN THE STATE; AND**

18 (10) any other information that is useful in explaining the financial viability
19 of horse racing in the State and any recommendations to improve the industry.

20 11-511.

21 (a) (1) On or before December 1, the Commission shall award all racing days
22 for the next calendar year.

23 (2) However, the Commission may meet after December 1 to award racing
24 days that are requested in applications.

25 (b) (1) Except as provided in paragraph (2) of this subsection, the Commission
26 may award for any calendar year up to the number of racing days requested by an
27 applicant.

28 (2) The Commission shall award at least [40] **180** live racing days [to be
29 run at the] **COMBINED BETWEEN LAUREL PARK IN ANNE ARUNDEL COUNTY AND**
30 **Pimlico Race Course in Baltimore City in each calendar year unless:**

31 (I) otherwise agreed to by the racing licensee [and], the

1 organization that represents the majority of licensed thoroughbred owners and trainers in
2 the State, **AND A GROUP THAT REPRESENTS A MAJORITY OF THE THOROUGHBRED**
3 **BREEDERS IN THE STATE;** or [unless]

4 (II) the racing licensee is prevented by weather, acts of God, or other
5 circumstances beyond the racing licensee's control.

6 (c) The decision of the Commission on the award of a racing day is final.

7 11-519.

8 (a) The owner of the Bowie Race Course Training Center shall operate the Center
9 as a thoroughbred training facility to provide more stall space for a race meeting that a
10 licensee holds.

11 (b) The owner of the Bowie Race Course Training Center is responsible for the
12 cost to improve, maintain, and operate the Center.

13 (c) As long as the Bowie Race Course Training Center is used for the purpose
14 specified in subsection (a) of this section, the Commission shall have general regulatory
15 jurisdiction over the Center to:

16 (1) provide enough stalls;

17 (2) maintain safe operating conditions;

18 (3) require the owner of the Center to submit an annual operating financial
19 statement; and

20 (4) order reasonable improvements.

21 11-520.

22 (a) The requirements of this section are established in recognition of the
23 significance of the Preakness Stakes to the State.

24 (b) The Preakness Stakes may be transferred to another track in the State only
25 as a result of a disaster or emergency.

26 (c) If the Preakness Stakes is transferred out of the State, the Commission may:

27 (1) revoke any racing days awarded to the Maryland Jockey Club of
28 Baltimore City, Inc., or its successor; and

29 (2) award these racing days to another licensee, notwithstanding §
30 11-511(b) of this subtitle.

1 (d) (1) If the Preakness Stakes is offered for sale, the State has the option to
2 buy the Preakness Stakes for the amount of any offer that the licensee wishes to accept.

3 (2) Within 30 days after receiving an offer that it wishes to accept, the
4 licensee shall give the State notice of the offer.

5 (3) If the State wishes to exercise the option, it shall so notify the licensee
6 within 60 days after it receives the notice.

7 11-521.

8 (a) In addition to the other provisions of this subtitle, in accordance with the
9 sovereign power of the State and the provisions of Article III, §§ 40 and 40A of the Maryland
10 Constitution, and subject to subsections (b) and (c) of this section, the State may acquire by
11 purchase or condemnation for public use with just compensation some or all of the following
12 real, tangible, and intangible private property, including any contractual interests or
13 intellectual property:

14 (1) Pimlico Race Course, a racetrack located in Baltimore City, including
15 any and all property or property rights associated with it wherever located, whether
16 tangible, intangible, real, personal, or mixed, and any business entity that owns it;

17 (2) Laurel Park, a racetrack located in Anne Arundel County, including
18 any and all property or property rights associated with it wherever located, whether
19 tangible, intangible, real, personal, or mixed, and any business entity that owns it;

20 (3) Bowie Race Course Training Center, a training center located in Prince
21 George's County, including any and all property or property rights associated with it
22 wherever located, whether tangible, intangible, real, personal, or mixed, and any business
23 entity that owns it;

24 (4) the Preakness Stakes trophy that is known as the Woodlawn Vase,
25 including any and all property or property rights associated with it, whether tangible,
26 intangible, real, personal, or mixed, and any business entity that owns it;

27 (5) the name, common law and statutory copyrights, service marks,
28 trademarks, trade names, contracts, horse racing events, and other intangible and
29 intellectual property that are associated with the Preakness Stakes and the Woodlawn
30 Vase;

31 (6) all property of the Maryland Jockey Club of Baltimore City, Inc., or its
32 successors and assigns, including stock and equity interests in it, and including any and all
33 property or property rights associated with it, whether tangible, intangible, real, personal,
34 or mixed; and

35 (7) all property of the Laurel Racing Assoc., Inc., the Laurel Racing
36 Association Limited Partnership, or their respective successors and assigns, including stock

1 and equity interests, and including any and all property or property rights associated with
2 them, whether tangible, intangible, real, personal, or mixed.

3 (b) All proceedings for the condemnation for public use of the private property
4 described under subsection (a) of this section shall be in accordance with the provisions of
5 Title 12 of the Real Property Article and Title 12, Chapter 200 of the Maryland Rules.

6 (c) Pursuant to the provisions of Article III, § 40A of the Maryland Constitution,
7 as applicable, the private property described under subsection (a) of this section may be
8 taken immediately on payment for the property consistent with the procedures of §§ 8–334
9 through 8–339 of the Transportation Article.

20 **(X) (1) “LAUREL PARK RACING FACILITY SITE” MEANS THE PORTION OF**
21 **THE LAUREL PARK SITE DESIGNATED TO CONTAIN THE RACING FACILITY.**

22 **(2) “LAUREL PARK RACING FACILITY SITE” INCLUDES THE PORTION**
23 **OF THE SITE DESIGNATED TO CONTAIN:**

24 **(I) THE BARNS;**

25 **(II) THE CLUBHOUSE;**

26 **(III) THE DIRT, TURF, OR SYNTHETIC RACETRACKS;**

27 **(IV) THE INFIELD AND IMMEDIATELY ADJACENT SURROUNDING**

1 PERIMETER OF THE RACETRACKS;

2 (V) THE BACKSTRETCH, DORMITORIES AND HOUSING, EQUINE
3 DIAGNOSTIC AND HEALTH CENTER, STABLES, AND TRAINING FACILITIES;

4 (VI) THE TRACKSIDE APRONS; AND

5 (VII) THE ASSOCIATED ROADWAYS, WALKWAYS, SIDEWALKS,
6 PARKING AREAS, GREEN SPACE, FENCING, AND RELATED STRUCTURES AND AREAS
7 AS DESIGNATED IN THE PLANS APPROVED BY THE AUTHORITY.

8 (Y) "LAUREL PARK SITE" MEANS THE SITE IN ANNE ARUNDEL COUNTY
9 GENERALLY BOUNDED BY STATE ROUTE 198, WHISKEY BOTTOM ROAD, BROCK
10 RIDGE ROAD, AND THE CSX RAILWAY.

11 (Z) (1) "MJC ENTITIES" MEANS THE MARYLAND JOCKEY CLUB OF
12 BALTIMORE CITY, INC., LAUREL RACING ASSOCIATION LIMITED PARTNERSHIP,
13 LAUREL RACING ASSOCIATION, INC., AND TSG DEVELOPMENTS INVESTMENTS,
14 INC.

15 (2) "MJC ENTITIES" INCLUDES AN AFFILIATE, AN ASSIGNEE, A
16 DESIGNEE, A SUCCESSOR, OR A TRANSFEREE OF AN MJC ENTITY.

17 [(x)] (AA) "Montgomery County" includes the Montgomery County Revenue
18 Authority.

19 [(y)] (BB) (1) "Montgomery County Conference facility" means the Conference
20 Center facility located at the Montgomery County Conference site used for conferences,
21 trade shows, meetings, displays, or similar events.

22 (2) "Montgomery County Conference facility" includes, at the Montgomery
23 County Conference site, offices, parking lots and garages, access roads, food service
24 facilities, and other functionally related property, structures, improvements, furnishings,
25 or equipment.

26 (3) "Montgomery County Conference facility" does not include the privately
27 owned hotel adjacent to the Montgomery County Conference Center.

28 [(z)] (CC) "Montgomery County Conference Fund" means the Montgomery
29 County Conference Financing Fund established under § 10-654 of this subtitle.

30 [(aa)] (DD) "Montgomery County Conference site" means the site of the
31 Montgomery County Conference Center located in Rockville at the address generally
32 known as 5701 Marinelli Road, identified in the State Department of Assessments and
33 Taxation Real Property database as tax identification number District 04, Account Number

2 **[(bb)] (EE)** (1) “Ocean City Convention facility” means:

3 (i) a convention center, trade show facility, meeting hall, or other
4 structure in Ocean City used to hold conventions, trade shows, meetings, displays, or
5 similar events; and

6 (ii) offices, parking lots or garages, access roads, food service
7 facilities, and any other structures, improvements, equipment, furnishings, or other
8 property functionally related to the facilities described in item (i) of this paragraph.

9 (2) “Ocean City Convention facility” includes the following, if used, useful,

18 (1) FUNDS APPROPRIATED FOR DEPOSIT TO THE RACING AND

20 (2) PROCEEDS FROM THE SALE OF BONDS CONCERNING RACING AND
21 COMMUNITY DEVELOPMENT PROJECTS;

22 (3) REVENUES COLLECTED OR RECEIVED FROM ANY SOURCE UNDER
23 THIS SUBTITLE CONCERNING RACING AND COMMUNITY DEVELOPMENT PROJECTS;

24 (4) INVESTMENT AND INTEREST EARNINGS;

25 (5) MONEY PAID TO THE RACING AND COMMUNITY DEVELOPMENT
26 FUND UNDER § 9-120 OF THE STATE GOVERNMENT ARTICLE;

27 (6) THE UNENCUMBERED FUND BALANCE, INCLUDING ACCRUED
28 INTEREST, EXISTING AS OF JUNE 1, 2020, THAT IS ALLOCATED TO THOROUGHBRED
29 TRACKS UNDER THE RACETRACK FACILITY RENEWAL ACCOUNT; AND

1 expenses of administering and operating the State lottery, as authorized under this subtitle
2 and the State budget; and

3 (2) then, except as provided in § 10–113.1 of the Family Law Article, §
4 11–618 of the Criminal Procedure Article, and § 3–307 of the State Finance and
5 Procurement Article, the holder of each winning ticket or share.

6 (b) (1) By the end of the month following collection, the Comptroller shall
7 deposit or cause to be deposited:

8 (i) into the Maryland Stadium Facilities Fund established under §
9 7–312 of the State Finance and Procurement Article from the money that remains in the
10 State Lottery Fund, after the distribution under subsection (a) of this section, an amount

23 **(IV) AFTER JUNE 30, 2020, INTO THE RACING AND COMMUNITY**
24 **DEVELOPMENT FUND ESTABLISHED UNDER § 10–657.2 OF THE ECONOMIC**
25 **DEVELOPMENT ARTICLE FROM THE MONEY THAT REMAINS IN THE STATE LOTTERY**
26 **FUND, AFTER THE DISTRIBUTION UNDER SUBSECTION (A) OF THIS SECTION, AN**
27 **AMOUNT EQUAL TO \$17,000,000 IN EACH FISCAL YEAR THAT BONDS ARE**
28 **OUTSTANDING AND UNPAID; AND**

29 [(iv)] **(V)** into the General Fund of the State the money that remains
30 in the State Lottery Fund from the proceeds of all lotteries after the distributions under
31 subsection (a) of this section and items (i), (ii), [and] (iii), **AND (IV)** of this paragraph.

32 (2) The money paid into the General Fund under this subsection is
33 available in the fiscal year in which the money accumulates in the State Lottery Fund.

34 (c) The regulations of the Agency shall apportion the money in the State Lottery
35 Fund in accordance with subsection (b) of this section.

1 (a) In this section, “racing licensee” means the holder of a license issued by the
2 State Racing Commission to hold a race meeting in the State under Title 11 of the Business
3 Regulation Article.

4 (b) As a condition of eligibility for funding under § 9–1A–29 of this subtitle, a
5 racing licensee shall:

6 (1) [(i) for Laurel Park and Pimlico Race Course, conduct a minimum of
7 220 annual live racing days combined between Laurel Park and Pimlico Race Course unless
8 otherwise agreed to by the racing licensee and the organization that represents the majority
9 of licensed thoroughbred owners and trainers in the State or unless the racing licensee is
10 prevented by weather, acts of God, or other circumstances beyond the racing licensee’s
11 control;]

12 [(ii) (I) for Rosecroft Raceway, conduct a minimum of [90] 60
13 annual live racing days unless otherwise agreed to by the racing licensee and the
14 organization that represents the majority of licensed standardbred owners and trainers in
15 the State or unless the racing licensee is prevented by weather, acts of God, or other
16 circumstances beyond the racing licensee’s control; and

17 [(iii) (II) for Ocean Downs Racetrack, conduct a minimum of 40
18 annual live racing days unless otherwise agreed to by the racing licensee and the
19 organization that represents the majority of licensed standardbred owners and trainers in
20 the State or unless the racing licensee is prevented by weather, acts of God, or other
21 circumstances beyond the racing licensee’s control;

22 [(2) if the racing licensee holds the racing license for Pimlico Race Course,

25 Preakness Stakes and the Woodlawn Vase;

26 (3) if the racing licensee holds the racing license for the Pimlico Race
27 Course, promote and conduct the Preakness Stakes each year at:

28 (i) the Pimlico Race Course; or

29 (ii) if the Pimlico Race Course no longer exists, the Preakness Stakes
30 Race is prevented from being conducted at the Pimlico Race Course, or the State Racing
31 Commission, under § 11–513 of the Business Regulation Article, deems an emergency
32 exists, another track located in the State that is approved by the State Racing Commission;

33 (4) if the racing licensee holds the racing license for Laurel Park, permit
34 the event known as the Maryland Million to be run annually at Laurel Park unless:

25 \$1,500,000;

26 (ii)] for Rosecroft Raceway, \$300,000; and

30 any improvements necessary to ensure that the condition of any part of the racetrack
31 facility where individuals reside is satisfactory for human habitation and meets minimum
32 housing and sanitation standards in the county where the facility is located.

32 (a) Except as provided in subsections (b) and (c) of this section and §
33 9-1A-26(a)(3) of this subtitle, on a properly approved transmittal prepared by the
34 Commission, the Comptroller shall pay the following amounts from the proceeds of video

1 (5) (i) until the issuance of a video lottery operation license in
2 Baltimore City, 1.75% to the Racetrack Facility Renewal Account established under §

31 (5) [Expenditures] **EXCEPT AS PROVIDED IN PARAGRAPH (3)(II) OF**

33 approved transmittal prepared by the State Racing Commission as provided under

5 (g) Of the amount provided from the Racetrack Facility Renewal Account under
6 subsection (d)(1) of this section, the State Racing Commission may provide direct grant
7 funding for the establishment of a horse racing museum as part of the Pimlico Race Course.

8 **(h)] (F)** After a grant has been provided under this section, the State Racing
9 Commission shall:

10 (1) in consultation with the Department of General Services, monitor the
11 implementation of the approved capital construction plan; and

12 (2) make provisions for recapture of grant moneys if the capital
13 construction plan is not implemented within the time frame approved by the State Racing
14 Commission.

15 **[(i)] (G)** Any unencumbered funds remaining in the Racetrack Facility Renewal
16 Account after a video lottery facility has been in operation for 16 years shall be paid to the
17 Education Trust Fund established under § 9-1A-30 of this subtitle.

18 **[(j)] (H)** The State Racing Commission shall adopt regulations to implement the
19 provisions of this subsection, including regulations to:

20 **(1)** address minimum criteria for the types of improvements to be made by
21 the holder of a license; **AND**

25 **[(k)] (I)** The provisions of this section may not be construed to apply to the
26 racecourse in Allegany County.

27 9-1A-31.

28 (a) (1) Except as provided in paragraph (8) of this subsection, the local impact
29 grants provided under § 9-1A-27 of this subtitle shall be distributed as provided in this
30 subsection.

31 (2) The following amounts shall be distributed to the following
32 jurisdictions:

- 1 (i) Allegany County – \$200,000;
- 2 (ii) Cecil County – \$130,000;
- 3 (iii) Town of Forest Heights – \$120,000;
- 4 (iv) Town of Perryville – \$70,000; and
- 5 (v) Worcester County – \$200,000.

6 (3) The remaining funds for local impact grants shall be distributed in the
7 following manner:

8 (i) 82% to the local jurisdictions with video lottery facilities, based
9 on each jurisdiction's percentage of overall gross revenues from video lottery terminals; and

28 to a video lottery facility in Baltimore City, any neighborhood within an area bounded by
