Frederick County - Alcoholic Beverages - Municipal Golf Course License

- 3 FOR the purpose of establishing a Class M-G beer, wine, and liquor license for use at a 4 municipal golf course in Frederick County; authorizing the Board of License 5 Commissioners for Frederick County to issue the license to a manager of a municipal 6 golf course; specifying that the license authorizes the license holder to sell beer, wine, 7 and liquor for on-premises consumption on certain land and facilities used for golfing 8 purposes; authorizing the license holder to designate an agent for certain purposes; 9 providing that the agent shall be considered to be the vendor for certain purposes; authorizing the Board to transfer a license to a different golf course manager under 10 11 certain circumstances; specifying the hours and days of sale; specifying a certain 12 annual license fee; requiring the Board to adopt certain regulations; and generally 13 relating to alcoholic beverages licenses in Frederick County.

- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 25 That the Laws of Maryland read as follows:

- 4 (A) THIS SECTION APPLIES ONLY TO A MUNICIPAL GOLF COURSE THAT IS
- 5 OPERATED BY A MUNICIPAL GOLF COURSE MANAGER OR A GOLF COURSE MANAGER
- 6 UNDER A MANAGEMENT AGREEMENT WITH THE CITY OF FREDERICK.
- 7 (B) THERE IS A CLASS M-G BEER, WINE, AND LIQUOR LICENSE FOR USE AT
- 8 A MUNICIPAL GOLF COURSE.
- 9 (C) THE BOARD MAY ISSUE THE LICENSE TO A MANAGER OF A MUNICIPAL
- 10 GOLF COURSE.
- 11 (D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,
- 12 AND LIQUOR FOR ON-PREMISES CONSUMPTION ON THE LAND AND IN THE
- 13 FACILITIES USED FOR GOLFING PURPOSES.
- 14 (E) (1) THE LICENSE HOLDER MAY DESIGNATE AN AGENT TO SELL BEER,
- 15 WINE, AND LIQUOR AT THE MUNICIPAL GOLF COURSE.
- 16 (2) THE AGENT SHALL BE CONSIDERED THE VENDOR FOR PURPOSES
- 17 OF COLLECTING AND REMITTING THE SALES AND USE TAX.
- 18 (F) ON REQUEST OF THE CITY OF FREDERICK, THE BOARD MAY TRANSFER
- 19 THE LICENSE TO A DIFFERENT GOLF COURSE MANAGER.
- 20 (G) THE HOURS OF SALE ARE:
- 21 (1) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M. THE
- 22 FOLLOWING DAY; AND
- 23 (2) ON SUNDAY, FROM 10 A.M. TO 2 A.M. THE FOLLOWING DAY.
- 24 (H) THE ANNUAL LICENSE FEE IS \$600.
- 25 (I) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 27 1, 2020.
