4 FOR the purpose of ~~altering the actions with regard to which hospitals and related~~
5 ~~institutions are prohibited from discriminating against individuals on certain bases;~~
6 providing that the Secretary of Health or certain units of the Maryland Department
7 of Health have exclusive jurisdiction to enforce certain laws by certain action;
8 establishing that the Commission on Civil Rights and the Secretary or certain units
9 have concurrent jurisdiction over certain discrimination; authorizing the
10 Commission to take certain action when the Secretary or certain units have exclusive
11 jurisdiction; requiring the Secretary or certain units to notify the Commission of
12 certain hearings; requiring the Secretary or certain units to give the Commission
13 certain information regarding certain complaints under certain circumstances;
14 requiring the Secretary or certain units and the Commission to set certain
15 guidelines; altering the characteristics of an individual on the basis of which
16 hospitals and related institutions are prohibited from discriminating against the

14 **OBJECTS, THE SECRETARY OR A UNIT OF THE DEPARTMENT SHALL GIVE THE**
15 **COMMISSION ALL INFORMATION REGARDING ANY COMPLAINT ALLEGING**
16 **DISCRIMINATORY PRACTICES RECEIVED BY THE SECRETARY OR UNIT OF THE**
17 **DEPARTMENT.**

18 **(E) THE SECRETARY OR A UNIT OF THE DEPARTMENT AND THE**
19 **COMMISSION SHALL SET GUIDELINES FOR DETERMINING WHEN ALLEGATIONS OF**
