A BILL ENTITLED

1 AN ACT concerning

2 **Juvenile Services Education – Education Records and School Enrollment –**
3 **Requirements**

4 FOR the purpose of requiring that the State Department of Education and the Department
5 of Juvenile Services, after consultation with the Education Coordinating Council for
6 Juvenile Services Educational Programs and county boards of education, to develop
7 and implement a procedure to transfer a copy of certain education records to a certain
8 facility within a certain period of time and to develop a certain school reenrollment
9 plan for a certain child; and generally relating to juvenile services education.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Education**

23 22–301.

24 (a) In this title the following words have the meanings indicated.

1 (b) "Council" means the Education Coordinating Council for Juvenile Services
2 Educational Programs.

4 (A) The Department and the Department of Juvenile Services shall work
5 cooperatively to facilitate the implementation of this subtitle[, and may share education
6 records with each other when necessary to ensure the appropriate delivery of services].

7 (B) **THE DEPARTMENT AND THE DEPARTMENT OF JUVENILE SERVICES,
8 AFTER CONSULTATION WITH THE COUNCIL AND THE COUNTY BOARDS OF
9 EDUCATION, SHALL DEVELOP AND IMPLEMENT:**

10 (1) **A PROCEDURE TO TRANSFER A COPY OF THE EDUCATION
11 RECORDS OF A STUDENT FROM THE SCHOOL IN WHICH THE STUDENT IS ENROLLED
12 TO THE FACILITY IN WHICH THE STUDENT IS PLACED WITHIN 7 DAYS OF THE DATE
13 THE STUDENT IS COMMITTED TO THE CUSTODY OF AND RECEIVING SERVICES FROM
14 THE DEPARTMENT OF JUVENILE SERVICES; AND**

15 (2) **A PROCEDURE TO DEVELOP A PLAN FOR THE REENROLLMENT OF
16 A SCHOOL-AGE CHILD IN A PUBLIC OR PRIVATE SCHOOL BEFORE THE CHILD IS
17 RELEASED FROM THE CUSTODY OF THE DEPARTMENT OF JUVENILE SERVICES.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
19 1, 2020.
