- 3 (a) Words or phrases in this section that describe the common—law crime of 4 indecent exposure shall retain their judicially determined meanings except to the extent 5 expressly or implicitly changed in this section.
- 6 (b) An inmate may not, with intent to annoy, abuse, torment, harass, or 7 embarrass a correctional officer or authorized personnel, lewdly, lasciviously, and 8 indecently expose private parts of the inmate's body in the presence of the correctional 9 officer or authorized personnel.
- 10 (c) An inmate who violates this section is guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 3 years or a fine not exceeding \$1,000 to both.
