17 18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

21	(a) In this subtitle the following words have the meanings indicated.
22	(e) "Jurisdictions" means the 23 counties within Maryland, Baltimore City, the

- 3 (1) Article 1. Purpose.
- 4 (a) (1) The purpose of this Compact is to provide for mutual assistance 5 between the jurisdictions entering into this Compact in managing an emergency.
- 6 (2) This Compact also shall provide for mutual cooperation in 7 emergency—related exercises, testing, or other training activities using equipment or 8 personnel simulating performance of any aspect of the giving and receiving of aid by party 9 jurisdictions during emergencies.
- 10 (2) Article 2. Requests for Assistance.
- 11 (b) (1) The senior elected official of each jurisdiction shall designate an 12 authorized representative. The authorized representative of a party jurisdiction may 13 request assistance of another party jurisdiction by contacting the authorized representative 14 of that jurisdiction.
- 15 (2) The provisions of this Compact shall apply only to requests for assistance made by and to authorized representatives.
- 17 (3) Requests may be verbal or in writing.
- 18 (4) If verbal, the request shall be confirmed in writing at the earliest possible date, but no later than 10 calendar days following the verbal request.
- 20 (5) Written requests shall provide the following information:
- 21 (i) A description of the emergency support function for which 22 assistance is needed;
- 23 (ii) The emergency support function shall include, but not be limited 24 to, fire services, law enforcement, emergency medical services, transportation, 25 communications, public works and engineering, building inspection, planning and 26 information assistance, mass care, resource support, health and medical services, and 27 search and rescue;
- 28 (iii) The amount and type of personnel, equipment, materials, and supplies needed and a reasonable estimate of the length of time they will be needed; and
- 30 (iv) The specific place and time for staging of the assisting party's 31 response and a point of contact at that location.
- 32 (6) There shall be frequent consultations between the Maryland

- Emergency Management Agency and appropriate representatives of the party jurisdictions with free exchange of information and plans generally relating to emergency capabilities.
- 3 (7) A senior elected official or an authorized representative will advise the 4 Maryland Emergency Management Agency of verbal requests and provide copies of written 5 requests.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2020.
