## A BILL ENTITLED

1 AN ACT concerning

2 **Department of Information Technology – Study of a Common Information**  
3 **Technology Platform for Health Occupations Boards**

4 FOR the purpose of requiring the Department of Information Technology to conduct a  
5 certain review of certain information technology platforms used by certain health  
6 occupations boards and make certain recommendations on the feasibility and cost of  
7 developing a certain common information technology platform; requiring the  
8 Department to report certain findings and recommendations to certain committees  
9 of the General Assembly on or before a certain date; and generally relating to a  
10 common information technology platform for health occupations boards.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That:

13 (a) The Department of Information Technology, in consultation with the health  
14 occupations boards authorized to issue a license or certificate under the Health Occupations  
15 Article, shall:

16 (1) review the information technology platforms used by each board,  
17 including the administrative functions used by each board and the cost of operating the  
18 platforms; and

19 (2) make recommendations on the feasibility and cost of developing a  
20 common information technology platform for use by each board that standardizes the  
21 websites and administrative functions of the boards and makes available accurate licensing  
22 information on health care providers for the purposes of facilitating network adequacy,  
23 including:

24 (i) adopting a standardized website appearance and functionality

2 (ii) offering each board the ability to send automated notices to  
3 persons who request to receive notices from the board;

4 (iii) the ability to translate the website of the board into any language  
5 spoken by any limited English proficient population that constitutes at least 3% of the  
6 overall population within the State as measured by the U.S. Census;

7 (iv) offering a standardized method of presenting information to  
8 regulated health care providers and the public on:

- 9 1. licensing or certification;
- 10 2. meeting scheduling and agendas;
- 11 3. board membership and staff;
- 12 4. public notices; and
- 13 5. complaint processing; and

14 (v) if possible, using existing platforms employed by the boards, to  
15 the extent that the platform is consistent with the statewide information technology master  
16 plan, in developing the common platform.

17 (b) On or before December 1, 2020, the Department of Information Technology  
18 shall report its findings and recommendations to the Senate Education, Health, and  
19 Environmental Affairs Committee and the House Health and Government Operations  
20 Committee, in accordance with § 2–1257 of the State Government Article.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
22 1, 2020.
