A BILL ENTITLED

1 AN ACT concerning

$\mathbf{2}$ **Congressional Districts – Standards** 3 (Anti-Gerrymandering of Maryland's Congressional Districts) 4 FOR the purpose of proposing an amendment to the Maryland Constitution to require congressional districts to conform to certain standards, to prohibit the accounting for $\mathbf{5}$ 6 certain information relating to the voting history and party affiliation of certain 7 individuals, and to require that due regard be given to certain boundaries; and 8 submitting this amendment to the qualified voters of the State for their adoption or 9 rejection. 10 BY proposing an addition to the Maryland Constitution 11 New Article XX – Congressional Districts 12 Section 1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 13(Three-fifths of all the members elected to each of the two Houses concurring), That it be 14 proposed that the Maryland Constitution read as follows: 15

1 FORM, AND BE OF SUBSTANTIALLY EQUAL POPULATION; AND

2 (2) MAY NOT ACCOUNT FOR HOW INDIVIDUALS ARE REGISTERED TO 3 VOTE, HOW INDIVIDUALS VOTED IN THE PAST, OR THE POLITICAL PARTY TO WHICH 4 INDIVIDUALS BELONG.

5 (B) DUE REGARD SHALL BE GIVEN TO NATURAL BOUNDARIES AND THE 6 BOUNDARIES OF POLITICAL SUBDIVISIONS.

SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly
determines that the amendment to the Maryland Constitution proposed by Section 1 of this
Act affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the Maryland
Constitution concerning local approval of constitutional amendments do not apply.

11 SECTION 3. AND BE IT FURTHER ENACTED, That the amendment to the Maryland Constitution proposed by Section 1 of this Act shall be submitted to the qualified 12voters of the State at the next general election to be held in November 2020 for adoption or 13rejection pursuant to Article XIV of the Maryland Constitution. At that general election, 14the vote on the proposed amendment to the Constitution shall be by ballot, and on each 15ballot there shall be printed the words "For the Constitutional Amendment" and "Against 16 the Constitutional Amendment", as now provided by law. Immediately after the election. 17all returns shall be made to the Governor of the vote for and against the proposed 18amendment, as directed by Article XIV of the Maryland Constitution, and further 19 20proceedings had in accordance with Article XIV.
