A BILL ENTITLED

1 AN ACT concerning

2 **Worcester County – Special Event Zones – Prohibitions**

3 FOR the purpose of prohibiting a person from engaging in exhibition driving within a
4 special event zone in Worcester County; prohibiting a person from committing
5 certain violations of the Maryland Vehicle Law within a special event zone in
6 Worcester County; defining the term “exhibition driving” for purposes of this Act;
7 establishing certain penalties for violations of this Act; altering a certain definition;
8 making stylistic changes; making this Act an emergency measure; and generally
9 relating to special event zones in Worcester County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

21 That the Laws of Maryland read as follows:

22 **Article – Transportation**

23 [21–811.

1 (a) (1) In this section the following words have the meanings indicated.

2 (2) "Special event" means any automotive or motor vehicle event occurring
3 on or in close proximity to a highway that:

4 (i) Has been permitted or approved by a unit of local government; or

5 (ii) Is expected to have 1,000 or more individuals in attendance,
6 regardless of whether the event has been permitted or approved by a unit of local
7 government.

8 (3) "Special event zone" means an area on or alongside a highway that is
9 marked by appropriate warning signs or other traffic control devices designating that a
10 special event is in progress.

11 (b) This section applies only in Worcester County.

12 (c) (1) The State Highway Administration may, on its own initiative or at the
13 request of a local authority:

14 (i) Designate an area on a State highway as a special event zone;
15 and

16 (ii) Reduce established speed limits in the special event zone after a
17 determination that the change is necessary to ensure public safety.

18 (2) A local authority may:

19 (i) Designate an area on a highway under its jurisdiction as a
20 special event zone; and

21 (ii) Reduce established speed limits in the special event zone after a
22 determination that the change is necessary to ensure public safety.

23 (d) A speed limit established under this section shall become effective when
24 posted.

25 (e) A person may not drive a motor vehicle at a speed exceeding the posted speed
26 limit within a special event zone established in accordance with this section.

27 (f) A person convicted of a violation of subsection (e) of this section is subject to a
28 fine not exceeding \$1,000.]

30 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
31 **INDICATED.**

1 **(2) “EXHIBITION DRIVING” MEANS:**

2 **(I) THE OPERATION OF A MOTOR VEHICLE IN A MANNER THAT**
3 **RESULTS IN:**

4 **1. THE EXCESSIVE, ABRUPT ACCELERATION OR**
5 **DECELERATION OF THE MOTOR VEHICLE;**

6 **2. THE SKIDDING, SQUEALING, BURNING, OR SMOKING**
7 **OF THE TIRES OF THE MOTOR VEHICLE;**

8 **3. THE SWERVING OR SWAYING OF THE MOTOR VEHICLE**
9 **FROM SIDE TO SIDE WHILE SKIDDING;**

10 **4. THE ENGINE OF THE MOTOR VEHICLE PRODUCING AN**
11 **UNREASONABLY LOUD, RAUCOUS, OR DISTURBING NOISE;**

12 **5. THE GRINDING OF THE GEARS OF THE MOTOR**
13 **VEHICLE OR THE BACKFIRING OF THE ENGINE OF THE MOTOR VEHICLE; OR**

14 **6. ANY OF THE WHEELS OF THE MOTOR VEHICLE LOSING**
15 **CONTACT WITH THE GROUND; OR**

16 **(II) THE TRANSPORTATION OF A PASSENGER ON OR IN AN AREA**
17 **OF A MOTOR VEHICLE THAT IS NOT DESIGNED OR INTENDED FOR PASSENGER**
18 **TRANSPORT SUCH AS THE HOOD OR ROOF.**

19 **(3) “SPECIAL EVENT” MEANS ANY AUTOMOTIVE OR MOTOR VEHICLE**
20 **EVENT OCCURRING ON OR IN CLOSE PROXIMITY TO A HIGHWAY THAT:**

21 **(I) HAS BEEN PERMITTED OR APPROVED BY A UNIT OF LOCAL**
22 **GOVERNMENT; OR**

23 **(II) IS EXPECTED TO HAVE 1,000 OR MORE INDIVIDUALS IN**
24 **ATTENDANCE, REGARDLESS OF WHETHER THE EVENT HAS BEEN PERMITTED OR**
25 **APPROVED BY A UNIT OF LOCAL GOVERNMENT.**

26 **(4) (I) “SPECIAL EVENT ZONE” MEANS AN AREA ON OR ALONG A**
27 **HIGHWAY THAT IS MARKED BY APPROPRIATE WARNING SIGNS OR OTHER TRAFFIC**
28 **CONTROL DEVICES DESIGNATING THE AREA AS A SPECIAL EVENT ZONE AND**
29 **INDICATING THAT A SPECIAL EVENT IS IN PROGRESS.**

1 **(II) "SPECIAL EVENT ZONE" INCLUDES A PARKING STRUCTURE,**
2 **A PARKING LOT, A STREET, OR ANY OTHER PROPERTY, PRIVATE OR PUBLIC,**
3 **IMMEDIATELY ADJACENT TO THE MARKED AREA ON OR ALONG THE MARKED AREA.**

4 **(B) THIS SECTION APPLIES ONLY IN WORCESTER COUNTY.**

5 **(C) (1) THE STATE HIGHWAY ADMINISTRATION MAY, ON ITS OWN**
6 **INITIATIVE OR AT THE REQUEST OF A LOCAL AUTHORITY:**

7 **(I) DESIGNATE AN AREA ON A STATE HIGHWAY AS A SPECIAL**
8 **EVENT ZONE; AND**

9 **(II) REDUCE ESTABLISHED SPEED LIMITS IN THE SPECIAL**
10 **EVENT ZONE AFTER A DETERMINATION THAT THE CHANGE IS NECESSARY TO**
11 **ENSURE PUBLIC SAFETY.**

12 **(2) A LOCAL AUTHORITY MAY:**

13 **(I) DESIGNATE AN AREA ON A HIGHWAY UNDER ITS**
14 **JURISDICTION AS A SPECIAL EVENT ZONE; AND**

15 **(II) REDUCE ESTABLISHED SPEED LIMITS IN THE SPECIAL**
16 **EVENT ZONE AFTER A DETERMINATION THAT THE CHANGE IS NECESSARY TO**
17 **ENSURE PUBLIC SAFETY.**

18 **(3) A SPEED LIMIT ESTABLISHED UNDER THIS SUBSECTION SHALL**
19 **BECOME EFFECTIVE WHEN POSTED.**

20 **(D) A PERSON MAY NOT ENGAGE IN EXHIBITION DRIVING WITHIN A SPECIAL**
21 **EVENT ZONE.**

22 **(E) A PERSON MAY NOT COMMIT ANY OF THE FOLLOWING VIOLATIONS**
23 **WITHIN A SPECIAL EVENT ZONE:**

24 **(1) DRIVING A MOTOR VEHICLE AT A SPEED EXCEEDING THE POSTED**
25 **SPEED LIMIT;**

26 **(2) NEGLIGENT DRIVING UNDER § 21-901.1(B) OF THIS TITLE;**

27 **(3) DRIVING A MOTOR VEHICLE IN A RACE OR SPEED CONTEST UNDER**
28 **§ 21-1116(A) OF THIS TITLE THAT DOES NOT RESULT IN SERIOUS BODILY INJURY TO**
29 **ANOTHER PERSON, AS DEFINED IN § 20-102(C) OF THIS ARTICLE;**

1 **(4) PARTICIPATING IN A RACE OR SPEED CONTEST UNDER §**
2 **21-1116(B) OF THIS TITLE; OR**

3 **(5) SKIDDING, SPINNING OF WHEELS, OR CAUSING EXCESSIVE NOISE**
4 **UNDER § 21-1117 OF THIS TITLE.**

5 **(F) (1) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (E) OF**
6 **THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 60 DAYS OR A FINE**
7 **NOT EXCEEDING \$1,000 OR BOTH.**

8 **(2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (F) OF**
9 **THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
11 measure, is necessary for the immediate preservation of the public health or safety, has
12 been passed by a ye and nay vote supported by three-fifths of all the members elected to
13 each of the two Houses of the General Assembly, and shall take effect from the date it is
14 enacted.
