## A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County – Procurement – Contract Renewal**

3 FOR the purpose of limiting the number of times certain contracts entered into by Calvert  
4 County may be renewed; making certain stylistic changes; and generally relating to  
5 procurement in Calvert County.

6 BY repealing and reenacting, with amendments,  
7 The Public Local Laws of Calvert County  
8 Section 6–103  
9 Article 5 – Public Local Laws of Maryland  
10 (2002 Edition and July 2019 Supplement, as amended and Zoning Ordinances  
11 through August 2019)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article 5 – Calvert County**

15 6–103.

16 (a) When it is advantageous to the county to do so, the county may contract to  
17 purchase supplies or services for periods of more than one year if:

18 (1) Funds for the total cost of the contract are available at the time [of] the  
19 contract is executed; or

20 (2) Subject to Subsection [(C)] (C) of this section, a contract requiring the  
21 payment of funds from appropriations of more than one fiscal year is approved by resolution  
22 of the Commissioners.

1 (b) Notwithstanding Subsection (a) of this section, the County may enter into a  
2 contract for solid waste disposal that:

3 (1) May include transportation;

4 (2) May require payment of funds from appropriations of the County or  
5 receipt of payment to the County; and

6 (3) Is not for more than a twenty-year initial term.

7 (c) A contract requiring the payment of funds from appropriations of more than  
8 one fiscal year, approved by resolution of the Commissioners, shall be awarded as a  
9 one-year contract with the option to renew for [four additional one-year terms]:

10 (1) NOT MORE THAN FOUR ONE-YEAR TERMS; OR

11 (2) NOT MORE THAN 19 ONE-YEAR TERMS IF THE CONTRACT IS FOR:

12 (I) BANKING AND INVESTMENT SERVICES;

13 (II) RETIREMENT AND PENSION SYSTEM MANAGEMENT;

14 (III) HEALTH INSURANCE; OR

15 (IV) SOFTWARE.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
17 October 1, 2020.
