## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Economic Development – Baltimore Symphony Orchestra – Funding and**  
3 **Reporting**

4 FOR the purpose of requiring the Governor to appropriate certain amounts of money to the  
5 Baltimore Symphony Orchestra in certain fiscal years; requiring the Baltimore  
6 Symphony Orchestra to submit certain reports to the Governor and certain  
7 committees of the General Assembly on or before certain dates; repealing the  
8 termination of a certain provision of law requiring the Governor to appropriate a  
9 certain amount of money to the Baltimore Symphony Orchestra in certain fiscal  
10 years; and generally relating to the Baltimore Symphony Orchestra.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That the Laws of Maryland read as follows:

3 **Article – Economic Development**

4 4–513.

5 (A) For each of fiscal years 2020 and 2021, the Governor shall include in the State  
6 budget an annual appropriation to the Baltimore Symphony Orchestra of \$1,600,000.

7 (B) **FOR EACH OF FISCAL YEARS 2022 THROUGH 2026, THE GOVERNOR**  
8 **SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE**  
9 **BALTIMORE SYMPHONY ORCHESTRA AS FOLLOWS:**

10 (1) **FOR FISCAL YEAR 2022, \$1,500,000;**

11 (2) **FOR FISCAL YEAR 2023, \$1,300,000;**

12 (3) **FOR FISCAL YEAR 2024, \$1,100,000;**

13 (4) **FOR FISCAL YEAR 2025, \$900,000; AND**

14 (5) **FOR FISCAL YEAR 2026, \$700,000.**

15 (C) (1) **ON OR BEFORE OCTOBER 15 EACH YEAR, BEGINNING IN 2022 AND**  
16 **FOR THE FOLLOWING 4 YEARS, THE BALTIMORE SYMPHONY ORCHESTRA SHALL**  
17 **SUBMIT A REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF THE**  
18 **STATE GOVERNMENT ARTICLE, THE SENATE BUDGET AND TAXATION COMMITTEE**  
19 **AND THE HOUSE APPROPRIATIONS COMMITTEE ON THE EFFECTIVENESS OF THE**  
20 **FUNDING PROVIDED UNDER SUBSECTION (B) OF THIS SECTION.**

21 (2) **THE REPORT SHALL INCLUDE:**

22 (I) **A COMPLETE STATEMENT ON THE FINANCIAL CONDITION OF**  
23 **THE BALTIMORE SYMPHONY ORCHESTRA; AND**

24 (II) **AN ACCOUNTING OF ALL FINANCIAL RECEIPTS AND**  
25 **EXPENDITURES.**

26 **Chapter 743 of the Acts of 2019**

27 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
28 1, 2019. [Section 1 of this Act shall remain effective for a period of 2 years and, at the end  
29 of June 30, 2021, Section 1 of this Act, with no further action required by the General

1 Assembly, shall be abrogated and of no further force and effect.] Section 2 of this Act shall  
2 remain effective for a period of 1 year and, at the end of June 30, 2020, Section 2 of this  
3 Act, with no further action required by the General Assembly, shall be abrogated and of no  
4 further force and effect.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
6 1, 2020.
