BY repealing and reenacting, with amendments, Article – Health – General Section 4-214(c)(2)Annotated Code of Maryland (2019 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Health - General 4-214. (c) (2) **(I)** The Department may change the name on a birth certificate once
