## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Motor Vehicle Administration – Authority to Suspend Registration for**  
3 **Violations Recorded by Traffic Control Signal Monitoring Systems and Speed**  
4 **Monitoring Systems – Repeal**

5 FOR the purpose of repealing the Motor Vehicle Administration’s authority to suspend the  
6 registration of a motor vehicle if the owner or driver of the motor vehicle fails to pay  
7 the penalty assessed for ~~a certain violation~~ violations recorded by a traffic control  
8 signal monitoring system or a speed monitoring system; and generally relating to  
9 the Motor Vehicle Administration and traffic control signal monitoring systems and  
10 speed monitoring systems.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That the Laws of Maryland read as follows:

3 **Article – Transportation**

4 21–202.

5 (h) (1) Vehicular traffic facing a steady circular red signal alone:

6 (i) Shall stop at the near side of the intersection:

7 1. At a clearly marked stop line;

8 2. If there is no clearly marked stop line, before entering any  
9 crosswalk; or

10 3. If there is no crosswalk, before entering the intersection;  
11 and

12 (ii) Except as provided in subsections (i), (j), and (k) of this section,  
13 shall remain stopped until a signal to proceed is shown.

14 (2) Vehicular traffic facing a steady red arrow signal:

15 (i) May not enter the intersection to make the movement indicated  
16 by the arrow;

17 (ii) Unless entering the intersection to make a movement permitted  
18 by another signal, shall stop at the near side of the intersection:

19 1. At a clearly marked stop line;

20 2. If there is no clearly marked stop line, before entering any  
21 crosswalk; or

22 3. If there is no crosswalk, before entering the intersection;  
23 and

24 (iii) Except as provided in subsections (i), (j), and (k) of this section,  
25 shall remain stopped until a signal permitting the movement is shown.

26 21–202.1.

27 (a) (1) In this section the following words have the meanings indicated.

1 (5) "Traffic control signal monitoring system" means a device with one or  
2 more motor vehicle sensors working in conjunction with a traffic control signal to produce  
3 recorded images of motor vehicles entering an intersection against a red signal indication.

4 (c) This section applies to a violation of § 21–202(h) of this subtitle at an  
5 intersection monitored by a traffic control signal monitoring system.

6 (d) (1) Unless the driver of the motor vehicle received a citation from a police  
7 officer at the time of the violation, the owner or, in accordance with subsection (g)(5) of this  
8 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is  
9 recorded by a traffic control signal monitoring system while being operated in violation of  
10 § 21–202(h) of this subtitle.

11 (2) A civil penalty under this subsection may not exceed \$100.

12 (h) If the civil penalty is not paid and the violation is not contested, the  
13 Administration may refuse to register or reregister [or may suspend the registration of]  
14 the motor vehicle.

15 21–801.1.

16 (a) Unless there is a special danger that requires a lower speed to comply with §  
17 21–801 of this subtitle, the limits specified in this section or otherwise established under  
18 this subtitle are maximum lawful speeds. A person may not drive a vehicle on a highway  
19 at a speed that exceeds these limits.

20 (b) Except as otherwise provided in this section, the maximum speed limits are:

21 (1) 15 miles per hour in alleys in Baltimore County;

22 (2) 30 miles per hour on:

23 (i) All highways in a business district; and

24 (ii) Undivided highways in a residential district;

25 (3) 35 miles per hour on divided highways in a residential district;

26 (4) 50 miles per hour on undivided highways in other locations; and

27 (5) 55 miles per hour on divided highways in other locations.

28 21–809.

29 (a) (8) "Speed monitoring system" means a device with one or more motor  
30 vehicle sensors producing recorded images of motor vehicles traveling at speeds at least 12  
31 miles per hour above the posted speed limit.

1 (c) (1) Unless the driver of the motor vehicle received a citation from a police  
2 officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this  
3 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is  
4 recorded by a speed monitoring system while being operated in violation of this subtitle.

5 (2) A civil penalty under this subsection may not exceed \$40.

6 (g) If a person liable under this section does not pay the civil penalty or contest  
7 the violation, the Administration[:

8 (1) May] MAY refuse to register or reregister the motor vehicle cited for the  
9 violation[; or

10 (2) May suspend the registration of the motor vehicle cited for the  
11 violation].

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 October 1, 2020.
