## Labor and Employment - Wage History and Wage Range

FOR the purpose of requiring an employer, on request, to provide to an applicant for employment the wage range for the position for which the applicant applied; prohibiting an employer from taking certain actions against an applicant for employment under certain circumstances; prohibiting an employer from relying on wage history, except under certain circumstances, for certain purposes, and from seeking the wage history by certain methods and from certain persons; authorizing an employer to seek to confirm the wage history of an applicant for employment under certain circumstances; authorizing an affected applicant for employment to bring a certain action against an employer if the employer's action violates certain provisions of this Act; authorizing an applicant for employment to bring a certain action against an employer with certain other employees or applicants for employment; prohibiting an employer from discharging or otherwise discriminating against an applicant for employment under certain circumstances; prohibiting an employer from violating certain provisions of this Act; specifying that an employer is not subject to a certain criminal penalty for a violation of certain provisions of this Act; requiring the Commissioner of Labor and Industry to issue a certain order under certain circumstances; authorizing the Commissioner to bring a certain action against a person who violates a certain provision of this Act and assess a certain penalty not exceeding a certain amount under certain circumstances; requiring the Commissioner to consider certain factors when determining the amount of a certain penalty; specifying that, if the Commissioner assesses a certain penalty, the penalty
