1 AN ACT concerning

2 **Clean Energy Jobs – Workforce Development – Scope**

3 FOR the purpose of altering the scope of apprenticeship and training programs that may  
4 receive certain support through the Clean Energy Workforce Account from the  
5 Strategic Energy Investment Fund for clean energy industry development; ~~defining~~  
6 ~~a certain term~~ requiring certain apprenticeship and training programs to comply  
7 with certain rules, regulations, and a certain program; altering the definition of  
8 “clean energy industry” by expanding the list of included professions that provide  
9 certain products and services; providing that certain funds from the Maryland  
10 Strategic Energy Investment Fund designated for a specific purpose be reallocated  
11 for the recruitment of certain individuals into certain apprenticeship programs; and  
12 generally relating to clean energy industries and workforce development.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

13 **Article – Labor and Employment**

14 11–708.1.

15 (a) There is a Clean Energy Workforce Account.

16 (b) The Account shall be funded from the Strategic Energy Investment Fund in  
17 accordance with § 9–20B–05(f)(10), (f–2), and (f–3) of the State Government Article.

18 (c) (1) **IN THIS SUBSECTION, “CLEAN ENERGY INDUSTRY” HAS THE**  
19 **MEANING STATED IN § 9–20B–01 OF THE STATE GOVERNMENT ARTICLE.**

20 (2) The Account shall be used to provide grants to support workforce  
21 development programs that provide:

22 (i) pre–apprenticeship jobs training;

23 (ii) youth apprenticeship jobs training; and

24 (iii) registered apprenticeship jobs training.

25 [(2)] (3) A pre–apprenticeship jobs training program must:

26 (i) be designed to prepare individuals to enter and succeed in an  
27 apprenticeship program registered by the Maryland Apprenticeship and Training Council;

28 (ii) include:

29 1. training and curriculum based on national best practices  
30 that prepare individuals with the skills and competencies to enter one or more  
31 State–registered or U.S. Department of Labor–registered apprenticeship programs that  
32 prepare workers for careers in the clean energy industry;

1                   2.     a documented strategy for increasing apprenticeship  
2 opportunities for unemployed and underemployed individuals, including:

3                   A.     recruitment strategies to bring these individuals into the  
4 pre-apprenticeship jobs training program;

5                   B.     educational and pre-vocational services to prepare  
6 program participants to meet the entry requirements of one or more registered  
7 apprenticeship programs;

8                   C.     access to appropriate support services to enable program  
9 participants to maintain participation in the program; and

10                  D.     mechanisms to assist program participants in identifying  
11 and applying to registered apprenticeship programs; and

12                  3.     rigorous performance and evaluation methods to ensure  
13 program effectiveness and improvement; and

14                  (iii)    have a documented partnership with at least one registered  
15 apprenticeship program described in item (ii)<sup>2</sup> of this paragraph.

16                  **[(3)] (4)**     Eligible clean energy industry jobs for a pre-apprenticeship jobs  
17 training program include positions in:

18                  (i)     renewable energy;

19                  (ii)    energy efficiency;

20                  (iii)   energy storage;

21                  (iv)    resource conservation; and

22                  (v)     advanced transportation.

23                  **[(4)] (5)**   (i)     This paragraph applies to youth apprenticeship jobs  
24 training programs and registered apprenticeship jobs training programs supported by the  
25 Account under this subsection.

26                  (ii)    An apprenticeship sponsor shall receive as a grant from the  
27 Account:

28                           1.     up to \$150,000 for a program proposal and planning  
29 expenses; and

30                           2.     \$3,000 for each successfully completed apprenticeship.

(iii) The youth apprenticeship jobs training programs and the registered apprenticeship jobs training programs:

**1. SHALL COMPLY WITH:**

**A. ALL RULES AND REGULATIONS FOR THE ESTABLISHMENT OF A REGISTERED APPRENTICESHIP AND YOUTH APPRENTICESHIP STANDARD FOR SPONSORSHIP; AND**

**B. THE MARYLAND APPRENTICESHIP AND TRAINING PROGRAM; AND**

**2.** must prepare workers for careers in the ENERGY EFFICIENCY, GEOTHERMAL, solar, and wind sectors of the clean energy industry.

**(IV) THIS PARAGRAPH MAY NOT BE CONSTRUED TO ALTER OR AMEND THE DEFINITION OF “YOUTH APPRENTICE” OR “REGISTERED APPRENTICE” AS DEFINED BY THE MARYLAND APPRENTICESHIP AND TRAINING COUNCIL AND APPROVED BY THE SECRETARY.**

(d) “Clean energy industry” means a group of employers and building and trade associations that are associated by their promotion of:

(1) products and services that improve energy efficiency and conservation, including products and services provided by:

(i) electricians;

15     11-708.1(c)(4)] **§ 11-708.1(C)(5)** of the Labor and Employment Article starting in fiscal  
16     year 2021 until all amounts are spent; and

17                   **(III) \$750,000 FOR THE RECRUITMENT OF INDIVIDUALS,**  
18     **INCLUDING VETERANS AND FORMERLY INCARCERATED INDIVIDUALS, TO THE**  
19     **PRE-APPRENTICESHIP JOBS TRAINING PROGRAMS AND THE REGISTERED**  
20     **APPRENTICESHIP JOBS TRAINING PROGRAMS UNDER § 11-708.1 OF THE LABOR**  
21     **AND EMPLOYMENT ARTICLE STARTING IN FISCAL YEAR 2021 UNTIL ALL AMOUNTS**  
22     **ARE SPENT; AND**
