A BILL ENTITLED

1 AN ACT concerning

2 **Talbot County – Sunday Hunting – Deer Bow Hunting Season**

3 FOR the purpose of authorizing the Department of Natural Resources to allow a person to
4 hunt deer on private property during the bow hunting season on certain Sundays in
5 Talbot County, subject to certain provisions of law; making a conforming change; and
6 generally relating to Sunday deer hunting in Talbot County.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Natural Resources**

25 10–410.

1 (a) (1) Except as otherwise provided in this subsection, a person may not hunt
2 any game bird or mammal on Sundays.

3 (2) The following persons may hunt the specified game birds and mammals
4 on Sundays:

5 (iv) Subject to the provisions of § 10–411 of this subtitle, in Calvert,
6 Caroline, Carroll, Charles, Harford, Queen Anne’s, Somerset, [Talbot,] Wicomico, and
7 Worcester counties, a person hunting deer on private property with a bow and arrow or
8 crossbow during open season on the last three Sundays in October and the second Sunday
9 in November;

10 (12) (i) This paragraph applies only in Dorchester County.

11 (ii) Subject to §§ 10–411 and 10–415 of this subtitle, the Department
12 may allow a person to hunt deer on private property on the second and third Sunday of the
13 deer firearms season.

14 (iii) [Subject to §§ 10–411 and 10–415 of this subtitle, the
15 Department may allow a person to hunt deer on private property on a Sunday during the
16 bow hunting season from the first Sunday in October through the second Sunday in
17 January the following year, inclusive.

18 (iv)] Subject to §§ 10–411 and 10–415 of this subtitle, the Department
19 may allow a person to hunt deer on private property on a Sunday during the deer muzzle
20 loader season.

21 **(15) (i) THIS PARAGRAPH APPLIES ONLY IN DORCHESTER COUNTY**
22 **AND TALBOT COUNTY.**

23 **(ii) SUBJECT TO §§ 10–411 AND 10–415 OF THIS SUBTITLE, THE**
24 **DEPARTMENT MAY ALLOW A PERSON TO HUNT DEER ON PRIVATE PROPERTY ON A**
25 **SUNDAY DURING THE BOW HUNTING SEASON FROM THE FIRST SUNDAY IN OCTOBER**
26 **THROUGH THE SECOND SUNDAY IN JANUARY THE FOLLOWING YEAR, INCLUSIVE.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
28 1, 2020.
