Public Institutions of Higher Education – Outbreak Response Plan <u>(Olivia's Law)</u>

FOR the purpose of requiring a public institution of higher education to submit an outbreak 4 response plan to the Maryland Department of Health on or before a certain date each $\mathbf{5}$ 6 year; requiring a public institution of higher education to implement the outbreak 7 response plan under certain circumstances; requiring the outbreak response plan to include certain protocols and processes and the provision of certain staff; requiring 8 9 the Department, in consultation with the Maryland Higher Education Commission, 10 to adopt certain regulations; defining a certain term; and generally relating to public 11 institutions of higher education and outbreak response plans.
