BY repealing and reenacting, with without amendments, Article – State Personnel and Pensions Section 2–509(a) Annotated Code of Maryland (2015 Replacement Volume and 2019 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - State Personnel and Pensions**

- 1 (a) (1) This subsection applies to a retiree of an optional retirement program 2 under Title 30 of this article who began service as an employee of the State in the Executive, 3 Legislative, or Judicial Branch of government on or before June 30, 2011.
- 4 (2) (i) Subject to subparagraph (ii) of this paragraph, an individual may 5 enroll and participate in the health insurance benefit options established under the 6 Program if the individual retired under an optional program under Title 30 of this article and:
- 8 1. ended service with a State institution of higher education 9 with at least 10 years of service and was at least age 57;
- 10 2. ended service with a State institution of higher education 11 with at least 16 years of service; or
- 3. retired directly from and had at least 5 years of service with a State institution of higher education with a periodic distribution of benefits on or after July 1, 1984.
- 15 (ii) 1. For purposes of this subsection only, years of service shall 16 be calculated as follows:
- A. except as provided in subsubparagraph 2 of this subparagraph, a year of service means a period of 12 months during which an employee was a participant in an optional retirement program under Title 30 of this article and the participant's employer made contributions to the participant's account in the Program; or
- B. if an employee's work year is an academic year of at least 9 but less than 12 months, a year of service means a period equal to the academic year during which an employee was a participant in an optional retirement program under Title 30 of this article and the participant's employer made contributions to the participant's account in the Program.
