1 AN ACT concerning

2 **Education – High School Graduation Requirements – Students in Foster Care or**
3 **Homeless Youth**

4 FOR the purpose of requiring a county board of education to waive high school graduation
5 requirements established by the county board that are in addition to high school
6 graduation requirements established by the State Board of Education for a student
7 in foster care or who is a homeless youth under certain circumstances; prohibiting a
8 county board from waiving certain requirements if the county board makes a finding
9 that a certain student is reasonably able to complete certain requirements in time to
10 graduate from high school; defining a certain term; and generally relating to
11 graduation requirements for students in foster care or homeless youth.

17 Preamble

18 WHEREAS, The State of Maryland has a duty to care for and protect the children
19 the State places in foster care, and as a matter of public policy, the State assumes an
20 obligation to ensure the health, safety, and education of children in foster care; and

1 WHEREAS, According to the Department of Human Services, children in Maryland's
2 foster care system are regularly moved through multiple placements and schools, including
3 across county lines; and

4 WHEREAS, According to the National Foster Care Institute, a child who has
5 frequent transitions often has education-related problems, including a loss of school
6 credits, academic problems, and a delay in earning a high school diploma; and

7 WHEREAS, According to the American Bar Association's Legal Center for Foster
8 Care and Education, youth in out-of-home care lost approximately 4 to 6 months of
9 academic progress with each change in school placement; and

10 WHEREAS, A high school student in foster care who has taken the courses required
11 for graduation in one county school system who is required to relocate to another county
12 school system in their junior or senior year may be faced with additional graduation
13 requirements at their new school with little time to complete those requirements in order
14 to graduate with the rest of their class or cohort; now, therefore,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 7–205.

19 (a) **IN THIS SECTION, “HOMELESS YOUTH” HAS THE MEANING STATED IN**
20 **THE MCKINNEY–VENTO HOMELESS ASSISTANCE ACT.**

21 (B) The promotion of students in a public school and graduation from a public high
22 school shall be in accordance with:

23 (1) [Policies] **EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS**
24 **SECTION, POLICIES** established by the county board; and

25 (2) The rules and regulations of the State Board.

26 [(b)] (C) (1) Each student who graduates from a public high school shall
27 receive the same type of diploma or certificate, regardless of the high school attended or the
28 course taken.

29 (2) The diploma or certificate shall state that the student has completed a
30 program of studies satisfactorily in accordance with the requirements of the State Board.

31 (D) (1) **SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A COUNTY**
32 **BOARD SHALL WAIVE ALL HIGH SCHOOL GRADUATION REQUIREMENTS, INCLUDING**
33 **REQUIRED COURSEWORK, ESTABLISHED BY THE COUNTY BOARD THAT ARE IN**

1 ADDITION TO THE HIGH SCHOOL GRADUATION REQUIREMENTS ESTABLISHED BY
2 THE STATE BOARD FOR A STUDENT IN FOSTER CARE OR WHO IS A HOMELESS YOUTH,
3 IF THE STUDENT WHILE IN GRADE 11 OR 12:

4 ~~(I) TRANSFERS~~ TRANSFERS INTO THE LOCAL SCHOOL SYSTEM
5 FROM A DIFFERENT LOCAL SCHOOL SYSTEM IN THE STATE; ~~OR~~

6 ~~(H) TRANSFERS BETWEEN HIGH SCHOOLS IN THE LOCAL~~
7 ~~SCHOOL SYSTEM.~~

8 (2) A COUNTY BOARD MAY NOT WAIVE THE REQUIREMENTS UNDER
9 PARAGRAPH (1) OF THIS SUBSECTION IF THE COUNTY BOARD MAKES A FINDING
10 THAT THE STUDENT IS REASONABLY ABLE TO COMPLETE THE COUNTY HIGH SCHOOL
11 GRADUATION REQUIREMENTS IN TIME TO GRADUATE FROM HIGH SCHOOL WHILE
12 THE STUDENT REMAINS ELIGIBLE FOR FOSTER CARE BENEFITS.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2020.
