A BILL ENTITLED

1 AN ACT concerning

2 **Public Information Act – Motor Vehicle Administration – Warrant for Personal**
3 **Information and Reporting**

4 FOR the purpose of requiring a custodian of records for the Motor Vehicle Administration
5 to deny inspection by United States Immigration and Customs Enforcement of the
6 part of a public record that contains personal information unless the custodian is
7 provided with a valid warrant issued by a federal court or a court of this State;
8 requiring the Motor Vehicle Administration to annually report certain information
9 to the General Assembly on a certain date; making conforming changes; and
10 generally relating to the disclosure of Motor Vehicle Administration records under
11 the Public Information Act.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – General Provisions**

20 4–320.

21 (a) (1) In this section, “telephone solicitation” means the initiation of a
22 telephone call to an individual or to the residence or business of an individual to encourage
23 the purchase or rental of or investment in property, goods, or services.

24 (2) “Telephone solicitation” does not include a telephone call or message:

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (i) to an individual who has given express permission to the person
2 making the telephone call;

3 (ii) to an individual with whom the person has an established
4 business relationship; or

5 (iii) by a tax-exempt, nonprofit organization.

6 (b) Except as provided in subsections (c) through (f) of this section, a custodian
7 may not knowingly disclose a public record of the Motor Vehicle Administration containing
8 personal information.

9 (c) A custodian shall disclose personal information when required by federal law.

10 (d) (1) This subsection applies only to the disclosure of personal information
11 for any use in response to a request for an individual motor vehicle record.

12 (2) The custodian may not disclose personal information without written
13 consent from the person in interest.

14 (3) (i) At any time the person in interest may withdraw consent to
15 disclose personal information by notifying the custodian.

16 (ii) The withdrawal by the person in interest of consent to disclose
17 personal information shall take effect as soon as practicable after it is received by the
18 custodian.

19 (e) (1) This subsection applies only to the disclosure of personal information
20 for inclusion in lists of information to be used for surveys, marketing, and solicitations.

21 (2) The custodian may not disclose personal information for surveys,
22 marketing, and solicitations without written consent from the person in interest.

23 (3) (i) At any time the person in interest may withdraw consent to
24 disclose personal information by notifying the custodian.

25 (ii) The withdrawal by the person in interest of consent to disclose
26 personal information shall take effect as soon as practicable after it is received by the
27 custodian.

28 (4) The custodian may not disclose personal information under this
29 subsection for use in telephone solicitations.

30 (5) Personal information disclosed under this subsection may be used only
31 for surveys, marketing, or solicitations and only for a purpose approved by the Motor
32 Vehicle Administration.

1 (f) Notwithstanding subsections (d) and (e) of this section, a custodian shall
2 disclose personal information:

3 (1) **EXCEPT AS PROVIDED UNDER SUBSECTION (J) OF THIS SECTION,**
4 for use by a federal, state, or local government, including a law enforcement agency, or a
5 court in carrying out its functions;

6 (2) for use in connection with matters of:

7 (i) motor vehicle or driver safety;

8 (ii) motor vehicle theft;

9 (iii) motor vehicle emissions;

10 (iv) motor vehicle product alterations, recalls, or advisories;

11 (v) performance monitoring of motor vehicle parts and dealers; and

12 (vi) removal of nonowner records from the original records of motor
13 vehicle manufacturers;

14 (3) for use by a private detective agency licensed by the Secretary of State
15 Police under Title 13 of the Business Occupations and Professions Article or a security
16 guard service licensed by the Secretary of State Police under Title 19 of the Business
17 Occupations and Professions Article for a purpose allowed under this subsection;

18 (4) **EXCEPT AS PROVIDED UNDER SUBSECTION (J) OF THIS SECTION,**
19 for use in connection with a civil, an administrative, an arbitral, or a criminal proceeding
20 in a federal, state, or local court or regulatory agency for service of process, investigation in
21 anticipation of litigation, and execution or enforcement of judgments or orders;

22 (5) for purposes of research or statistical reporting as approved by the
23 Motor Vehicle Administration provided that the personal information is not published,
24 redisclosed, or used to contact the individual;

25 (6) for use by an insurer, an insurance support organization, or a
26 self-insured entity, or its employees, agents, or contractors, in connection with rating,
27 underwriting, claims investigating, and antifraud activities;

28 (7) for use in the normal course of business activity by a legitimate business
29 entity or its agents, employees, or contractors, but only:

30 (i) to verify the accuracy of personal information submitted by the
31 individual to that entity; and

1 (ii) if the information submitted is not accurate, to obtain correct
2 information only for the purpose of:

3 1. preventing fraud by the individual;

4 2. pursuing legal remedies against the individual; or

5 3. recovering on a debt or security interest against the
6 individual;

7 (8) for use by an employer or insurer to obtain or verify information
8 relating to a holder of a commercial driver's license that is required under the Commercial
9 Motor Vehicle Safety Act of 1986 (49 U.S.C. § 31101 et seq.);

10 (9) for use in connection with the operation of a private toll transportation
11 facility;

12 (10) for use in providing notice to the owner of a towed or impounded motor
13 vehicle;

14 (11) for use by an applicant who provides written consent from the
15 individual to whom the information pertains if the consent is obtained within the 6-month
16 period before the date of the request for personal information;

17 (12) for use in any matter relating to:

18 (i) the operation of a Class B (for hire), Class C (funeral and
19 ambulance), or Class Q (limousine) vehicle; and

20 (ii) public safety or the treatment by the operator of a member of the
21 public;

22 (13) for a use specifically authorized by State law, if the use is related to the
23 operation of a motor vehicle or public safety;

24 (14) for use by a hospital to obtain, for hospital security, information
25 relating to ownership of vehicles parked on hospital property;

26 (15) for use by a procurement organization requesting information under §
27 4-516 of the Estates and Trusts Article for the purposes of organ, tissue, and eye donation;

28 (16) for use by an electric company, as defined in § 1-101 of the Public
29 Utilities Article, but only:

30 (i) information describing a plug-in electric drive vehicle, as defined
31 in § 11-145.1 of the Transportation Article, and identifying the address of the registered
32 owner of the plug-in vehicle;

1 (ii) for use in planning for the availability and reliability of the
2 electric power supply; and

3 (iii) if the information is not:

4 1. published or redisclosed, including redisclosed to an
5 affiliate as defined in § 7-501 of the Public Utilities Article; or

6 2. used for marketing or solicitation; and

7 (17) for use by an attorney, a title insurance producer, or any other
8 individual authorized to conduct a title search of a manufactured home under Title 8B of
9 the Real Property Article.

10 (g) (1) A person receiving personal information under subsection (e) or (f) of
11 this section may not use or redisclose the personal information for a purpose other than the
12 purpose for which the custodian disclosed the personal information.

13 (2) A person receiving personal information under subsection (e) or (f) of
14 this section who rediscloses the personal information shall:

15 (i) keep a record for 5 years of the person to whom the information
16 is redisclosed and the purpose for which the information is to be used; and

17 (ii) make the record available to the custodian on request.

18 (h) (1) The custodian shall adopt regulations to implement and enforce this
19 section.

20 (2) (i) The custodian shall adopt regulations and procedures for
21 securing from a person in interest a waiver of privacy rights under this section when an
22 applicant requests personal information about the person in interest that the custodian is
23 not authorized to disclose under subsections (c) through (f) of this section.

24 (ii) The regulations and procedures adopted under this paragraph
25 shall:

26 1. state the circumstances under which the custodian may
27 request a waiver; and

28 2. conform with the waiver requirements in the federal
29 Driver's Privacy Protection Act of 1994 and other federal law.

30 (i) The custodian may develop and implement methods for monitoring
31 compliance with this section and ensuring that personal information is used only for the
32 purposes for which it is disclosed.

1 **(J) (1) A CUSTODIAN SHALL DENY INSPECTION BY UNITED STATES**
2 **IMMIGRATION AND CUSTOMS ENFORCEMENT OF THE PART OF A PUBLIC RECORD**
3 **THAT CONTAINS PERSONAL INFORMATION UNLESS THE CUSTODIAN IS PROVIDED**
4 **WITH A VALID WARRANT ISSUED BY A FEDERAL COURT OR A COURT OF THIS STATE.**

5 **(2) ON OR BEFORE JUNE 1, 2022, AND EACH JUNE 1 THEREAFTER,**
6 **THE MOTOR VEHICLE ADMINISTRATION SHALL REPORT TO THE GENERAL**
7 **ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE,**
8 **THE FOLLOWING INFORMATION FOR THE IMMEDIATELY PRECEDING CALENDAR**
9 **YEAR:**

10 **(I) THE NUMBER OF REQUESTS RECEIVED FROM FEDERAL LAW**
11 **ENFORCEMENT AGENCIES FOR PERSONAL INFORMATION, IN TOTAL AND BY LAW**
12 **ENFORCEMENT AGENCY;**

13 **(II) THE NUMBER OF REQUESTS RECEIVED FROM FEDERAL LAW**
14 **ENFORCEMENT AGENCIES FOR PERSONAL INFORMATION FOR WHICH A VALID**
15 **WARRANT ISSUED BY A FEDERAL COURT OR A COURT OF THIS STATE WAS PROVIDED;**

16 **(III) THE NUMBER AND PURPOSE OF FACIAL RECOGNITION**
17 **SEARCHES COMPLETED BY FEDERAL LAW ENFORCEMENT AGENCIES BASED ON**
18 **PERSONAL INFORMATION PROVIDED TO THE FEDERAL LAW ENFORCEMENT**
19 **AGENCIES BY THE MOTOR VEHICLE ADMINISTRATION; AND**

20 **(IV) THE NUMBER OF INDIVIDUALS WHOSE PERSONAL**
21 **INFORMATION WAS PROVIDED TO A FEDERAL LAW ENFORCEMENT AGENCY BY THE**
22 **MOTOR VEHICLE ADMINISTRATION.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2020.
