A BILL ENTITLED

1 AN ACT concerning

2 **Annual Curative Bill**

3 FOR the purpose of generally curing previous Acts of the General Assembly with possible
4 title defects; requiring a court to set a certain hearing under certain circumstances
5 as the court considers appropriate; repealing certain provisions of law authorizing
6 an affirmative defense for examining employer and school identifications; increasing
7 the limit on the number of new P-TECH Planning Grants that may be awarded
8 beginning in a certain fiscal year to establish a new P-TECH school until a certain
9 condition is met; altering the requirements, including the time period of active
10 clinical experience, that a supervising dentist is required to meet before a dental
11 hygienist is authorized to practice dental hygiene under the general supervision of
12 the licensed dentist in certain facilities; prohibiting the Governor from reducing an
13 appropriation for a certain fund notwithstanding certain provisions of law; providing
14 that certain performance evaluations may include certain actions; making this Act
15 an emergency measure; and generally repealing and reenacting without
16 amendments certain Acts of the General Assembly that may be subject to possible
17 title defects in order to validate those Acts.

30 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
31 That the Laws of Maryland read as follows:

32 **Article – Commercial Law**

33 24–303.

34 (c) (3) The court shall set a hearing for any timely filed objections as the court
35 considers appropriate.

5 9–601.

6 (j) (2) Each correctional facility shall have a written policy in place regarding
7 the medical care of pregnant inmates that addresses:

8 (xi) use of involuntary medical isolation or restrictive housing for
9 administrative, protective, or disciplinary purposes during pregnancy and 8 weeks during
10 the postpartum or post–pregnancy recovery period.

11 DRAFTER’S NOTE:

12 Error: Function paragraph of bill being cured incorrectly indicated that §
13 9–602(j)(2)(xi), rather than § 9–601(j)(2)(xi), of the Correctional Services Article was being
14 added.

16 **Article – Criminal Law**

17 10–107.

18 (d) In a prosecution for a violation of this section, it is a defense that the defendant
19 examined the purchaser’s or recipient’s driver’s license or other valid identification issued
20 by a government unit that positively identified the purchaser or recipient as at least 21
21 years of age or as at least 18 years of age and an active duty member of the military.

27 (a) (1) In this section the following words have the meanings indicated.

28 (2) “Bi–county unit” means:

29 (i) the Maryland–National Capital Park and Planning Commission;

1 or

2 (ii) the Washington Suburban Sanitary Commission.

3 (3) (i) “Bulky item” means any discarded furniture, home or industrial
4 appliance, or abandoned vehicle or part of an abandoned vehicle not designated for disposal
5 purposes under the laws of Prince George’s County.

6 (ii) “Bulky item” does not include discarding, dropping, or scattering
7 of small quantities of waste matter ordinarily carried on or about the person, including:

8 1. beverage containers and closures;

9 2. packaging;

10 3. wrappers;

11 4. wastepaper;

12 5. newspapers;

13 6. magazines; and

14 7. waste matter that escapes or is allowed to escape from a
15 container, receptacle, or package.

16 (4) “Litter” means all rubbish, waste matter, refuse, garbage, trash, debris,
17 dead animals, or other discarded materials of every kind and description.

18 (5) “Public or private property” means:

19 (i) the right-of-way of a road or highway;

20 (ii) a body of water or watercourse or the shores or beaches of a body
21 of water or watercourse;

22 (iii) a park;

23 (iv) a parking facility;

24 (v) a playground;

25 (vi) public service company property or transmission line
26 right-of-way;

27 (vii) a building;

1 (viii) a refuge or conservation or recreation area;

2 (ix) residential or farm property; or

3 (x) timberlands or a forest.

8 **Article – Criminal Procedure**

9 11–928.

10 (a) The Governor's Office of Crime Control and Prevention shall establish and
11 sustain child advocacy centers in the State and ensure that every child in the State has
12 access to a child advocacy center.

13 (b) The child advocacy centers:

14 (1) may be based in private nonprofit organizations, local departments of
15 social services, local law enforcement agencies, or a partnership among any of these
16 entities;

17 (2) shall be developed and located to facilitate their use by alleged victims
18 residing in the surrounding areas;

19 (3) shall assist in the response to or investigation of allegations of sexual
20 crimes against children under Title 3, Subtitle 3 of the Criminal Law Article and sexual
21 abuse of minors under Title 3, Subtitle 6 of the Criminal Law Article and Title 5, Subtitle
22 7 of the Family Law Article;

23 (4) may assist in the response to or investigation of allegations of child
24 abuse and neglect under Title 3, Subtitle 6 of the Criminal Law Article and Title 5, Subtitle
25 7 of the Family Law Article and allegations of a crime of violence in the presence of a minor
26 under § 3–601.1 of the Criminal Law Article;

27 (5) shall provide a level of care that meets or exceeds the national
28 accreditation standards for child advocacy centers established by the Maryland Statewide
29 Organization for Child Advocacy Centers under subsection (d) of this section; and

30 (6) shall be included in all joint investigation procedures developed in
31 accordance with § 5–706 of the Family Law Article.

1 (c) The Governor's Office of Crime Control and Prevention may contract with
2 public or private nonprofit organizations to operate child advocacy centers.

3 (d) (1) The Governor's Office of Crime Control and Prevention shall contract
4 with a nonprofit organization that is qualified under § 501(c)(3) of the Internal Revenue
5 Code and represents urban, rural, and suburban child advocacy centers in the State to
6 establish a Maryland Statewide Organization for Child Advocacy Centers.

7 (2) The purpose of the Maryland Statewide Organization for Child
8 Advocacy Centers is to provide training, technical assistance, data collection, and capacity
9 building to meet local, State, and national requirements for child advocacy centers.

10 (3) The Maryland Statewide Organization for Child Advocacy Centers
11 shall establish standards for child advocacy centers in the State that meet national
12 accreditation standards for child advocacy centers and shall include:

13 (i) multidisciplinary teams that include representation from law
14 enforcement, prosecutors, child protective services, the medical and mental health fields,
15 and victim advocacy;

16 (ii) cultural competency and diversity;

17 (iii) forensic interviews that are neutral, fact-finding, and avoid
18 duplicative interviewing;

19 (iv) victim support and advocacy for children and caregivers,
20 including appropriate counseling, legal, and medical services or referrals;

21 (v) medical evaluations;

22 (vi) mental health services;

23 (vii) a formal case review process;

24 (viii) a case tracking, monitoring, and outcomes process;

25 (ix) organizational capacity;

26 (x) creating a child-focused setting that is comfortable, safe, and
27 private; and

28 (xi) any additional necessary standards.

29 (e) Money for child advocacy centers:

30 (1) shall be distributed to child advocacy centers in accordance with a
31 formula agreed on by the Maryland Statewide Organization for Child Advocacy Centers

1 and the Governor's Office of Crime Control and Prevention;

2 (2) shall be used to supplement, not supplant, money that the program
3 receives from other sources; and

4 (3) may be used to assist child advocacy centers in meeting the standards
5 under subsection (d) of this section.

6 (f) On or before June 1 each year, the Governor's Office of Crime Control and
7 Prevention shall submit an annual report, in accordance with § 2-1257 of the State
8 Government Article, on child advocacy centers to the General Assembly.

14 5-101.

15 (f) (1) In addition to all other information required by this section, the Prince
16 George's County Board of Education shall provide to the County Executive and County
17 Council with the annual budget, information relating to each of the following categories:

18 (i) Instructional supplies and materials;

19 (ii) Additional equipment;

20 (iii) Replacement equipment; and

21 (iv) Availability payments related to any public-private partnership
22 agreement entered into under §§ 4-126 and 4-126.1 of this article.

23 DRAFTER'S NOTE:

28 (d) Beginning in fiscal year 2020, no more than three new P-TECH Planning
29 Grants may be awarded to establish a new P-TECH school until the 2016-2017 cohort of

1 P-TECH students completes the 6-year pathway sequence.

6 **Article – Health Occupations**

7 4-308.

8 (m) (4) Before a dental hygienist is authorized to practice dental hygiene under
9 general supervision in a facility in accordance with this subsection, the supervising dentist
10 shall:

11 (i) Hold an active general license to practice dentistry in the State;

12 (ii) Hold a current certificate evidencing health provider level C
13 proficiency, or its equivalent, in cardiopulmonary resuscitation;

14 (iii) Have at least 3,000 hours of active clinical practice in direct
15 patient care; and

16 (iv) Have a written agreement between the supervising dentist and
17 the dental hygienist that:

18 1. Clearly sets forth the terms and conditions under which
19 the dental hygienist may practice, including a statement that the dental hygienist may
20 provide dental hygiene services without the supervising dentist on the premises unless this
21 title requires that a licensed dentist be on the premises in order for the service to be
22 performed by the dental hygienist;

23 2. Indicates the population to be served;

24 3. States the method by which the services are to be provided
25 and the procedures to be used by the supervising dentist to oversee and direct the dental
26 hygienist; and

27 4. States the names and license numbers of the dentist and
28 dental hygienist performing services under the written agreement.

4 (b) (3) (iii) Notwithstanding the provisions of § 7–213 of the State Finance
5 and Procurement Article, the Governor may not reduce an appropriation for the Reserve
6 Fund in the State budget as approved by the General Assembly.

12 2–1235.

13 (b) A performance evaluation conducted by the Office may include:

14 (1) evaluating the efficiency, effectiveness, and economy with which
15 resources are used;

16 (2) determining whether desired program results are achieved;

17 (3) determining whether a program aligns with the unit’s mission;

18 (4) evaluating whether a program duplicates another program or activity
19 within another unit;

20 (5) evaluating whether the governmental activity or unit under evaluation
21 operates:

22 (i) in an open and accountable manner, with public access to records
23 and meetings, safeguards against conflicts of interest, and opportunity for public
24 participation; and

25 (ii) in a fair and nondiscriminatory manner that complies fully with
26 law and State policy;

27 (6) determining the reliability of performance measures, as defined in §
28 3–1001 of the State Finance and Procurement Article, identified in:

1 (i) the managing for results agency strategic plan developed under
2 § 3–1002(c) of the State Finance and Procurement Article; or

3 (ii) the StateStat strategic plan and performance measurement
4 report submitted to the Secretary of Budget and Management under § 3–1003(d) of the
5 State Finance and Procurement Article; and

6 (7) for a performance evaluation of a local school system:

7 (i) evaluating whether or not the school system is complying with
8 federal and State laws and regulations;

9 (ii) analyzing grading standards, graduation requirements,
10 assessments, procurement, and equitable use of resources among the schools within the
11 system evaluated; and

12 (iii) identifying instances of fraud, waste, and abuse.

18 **SECTION 2. AND BE IT FURTHER ENACTED,** That the Drafter's Notes contained
19 in this Act are not law and may not be considered to have been enacted as part of this Act.

20 **SECTION 3. AND BE IT FURTHER ENACTED,** That this Act is an emergency
21 measure, is necessary for the immediate preservation of the public health or safety, has
22 been passed by a ye and nay vote supported by three-fifths of all the members elected to
23 each of the two Houses of the General Assembly, and shall take effect from the date it is
24 enacted.
