A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Alcoholic Beverages – Class MD Beer, Wine, and Liquor**
3 **License**

4 FOR the purpose of establishing in Baltimore County a Class MD beer, wine, and liquor
5 license; authorizing the Board of License Commissioners for Baltimore County to
6 issue the license for use by an establishment that is located in a certain arts and
7 entertainment district and maintains average daily receipts from the sale of food
8 that are at least a certain percentage of total daily receipts; authorizing the license
9 holder to sell beer, wine, and liquor manufactured in the State, at retail, for
10 on-premises consumption at a certain location; exempting the license from certain
11 license quota limitations; specifying the days and hours of sale of alcoholic beverages
12 under the license; authorizing the Board to set an annual license fee; and generally
13 relating to alcoholic beverages licenses in Baltimore County.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

26 **Article – Alcoholic Beverages**

4 **(A) THERE IS A CLASS MD BEER, WINE, AND LIQUOR LICENSE.**

5 **(B) THE BOARD MAY ISSUE THE LICENSE FOR USE BY AN ESTABLISHMENT**
6 **THAT:**

7 **(1) IS LOCATED IN AN ARTS AND ENTERTAINMENT DISTRICT IN THE**
8 **COUNTY; AND**

9 **(2) MAINTAINS AVERAGE DAILY RECEIPTS FROM THE SALE OF FOOD**
10 **THAT ARE AT LEAST 70% OF THE TOTAL DAILY RECEIPTS OF THE ESTABLISHMENT.**

11 **(C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**
12 **AND LIQUOR MANUFACTURED IN THE STATE, AT RETAIL, AT THE PLACE DESCRIBED**
13 **IN THE LICENSE, FOR ON-PREMISES CONSUMPTION.**

14 **(D) THE LICENSE IS EXEMPT FROM ANY LICENSE QUOTA LIMITATION**
15 **ESTABLISHED UNDER THIS TITLE.**

16 **(E) THE LICENSE HOLDER MAY SELL BEER, WINE, AND LIQUOR ON MONDAY**
17 **THROUGH SUNDAY, FROM NOON TO MIDNIGHT.**

18 **(F) THE BOARD MAY SET AN ANNUAL FEE FOR THE LICENSE.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2020.
