6 4. for a member of the General Assembly, food or beverages 7 received at the time and geographic location of a meeting of a legislative organization for 8 which the member's presiding officer has approved the member's attendance at State 9 expense;

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2020.
