## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – Class C Beer, Wine, and Liquor Licenses**

3 FOR the purpose of authorizing the Board of License Commissioners for Baltimore City to  
4 issue a Class C beer, wine, and liquor license to a club in a certain area in Baltimore  
5 City; and generally relating to alcoholic beverages licenses in Baltimore City.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 12–102.

20 This title applies only in Baltimore City.

21 12–906.

22 (a) There is a Class C beer, wine, and liquor license.

5 (c) The Board may issue:

(1) in the alcoholic beverages districts specified in subsection (b) of this section:

8 (i) a 1-day license; or

9 (ii) a Class B beer, wine, and liquor license to a restaurant that:

10                                   1.     has a minimum capital investment, not including the cost  
11     of land and buildings, of \$200,000 for restaurant facilities; and

12 2. has a minimum seating capacity of 75 individuals;

13 (2) a Class C beer, wine, and liquor license in the 45th alcoholic beverages  
14 district;

15 (3) a Class C beer, wine, and liquor license in ward 5, precinct 1 of the 44th  
16 alcoholic beverages district;

(4) a Class C beer, wine, and liquor license in the 200 block of West Saratoga Street in ward 4, precinct 3 of the 40th alcoholic beverages district;

23 [ (5) (6) a Class B-D-7 license in the unit block of West North Avenue in  
24 the 45th alcoholic beverages district;

[6] (7) two Class B-D-7 licenses in the 2100 block of North Charles Street in the 43rd alcoholic beverages district;

27 [7] (8) two Class B-D-7 licenses in the 2100 block of Maryland Avenue  
28 in the 43rd alcoholic beverages district; and

[8] (9) subject to the requirements under subsection (e) of this section,  
four Class B-D-7 licenses in the 43rd alcoholic beverages district.

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
2   1, 2020.
