CHAPTER _____

1 AN ACT concerning

2 **Recreational Striped Bass Fishery – Study on Harvest Data**

3 FOR the purpose of requiring the Department of Natural Resources to conduct a study on
4 methods of obtaining more accurate harvest data for the recreational striped bass
5 fishery; requiring the study to examine certain issues relevant to obtaining more
6 accurate harvest data for the recreational striped bass fishery; requiring the
7 Department to report its findings and recommendations to the Governor and certain
8 committees of the General Assembly on or before a certain date; providing for the
9 termination of this Act; and generally relating to the study on methods of obtaining
10 more accurate harvest data for the recreational striped bass fishery.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That:

13 (a) The Department of Natural Resources shall conduct a study on methods of
14 obtaining more accurate harvest data for the recreational striped bass fishery.

15 (b) The study shall:

16 (1) examine the benefits that more accurate harvest data for the
17 recreational striped bass fishery would have on the scientific and management capabilities
18 of the Department with respect to the entire striped bass fishery;

19 (2) consider the types of information and level of detail that would be most
20 beneficial for the Department to obtain for its scientific and management duties and

2 (3) consider the advantages, disadvantages, and feasibility of
3 implementing various methods for obtaining more accurate harvest data for the
4 recreational striped bass fishery;

5 (4) recommend methods for obtaining more accurate harvest data for the
6 recreational striped bass fishery; and

7 (5) recommend any enforcement measures that would need to be
8 implemented to support any methods recommended under item (4) of this subsection.

9 (c) On or before December 1, 2020, the Department shall report its findings and
10 recommendations with respect to obtaining more accurate harvest data for the recreational
11 striped bass fishery to the Governor and, in accordance with to § 2-1257 of the State
12 Government Article, the Senate Education, Health, and Environmental Affairs Committee
13 and the House Environment and Transportation Committee.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
15 1, 2020. It shall remain effective for a period of 1 year and, at the end of May 31, 2021, with
16 no further action required by the General Assembly, this Act shall be abrogated and of no
17 further force and effect.
