| FOR the purpose of prohibiting certain individuals who are members of the Employees' Pension System of the State Retirement and Pension System from becoming a member of the Optional Retirement Program of the State Retirement and Pension System on or after a certain date; prohibiting certain individuals from continuing membership in the Optional Retirement Program on or after a certain date; requiring certain individuals to resume participation as a member of the Employees' Pension System on a certain date; providing that certain retirees of the Teachers' Pension |

If a participating employee withdraws the accumulated 30

contributions, the participating employee forfeits any right to a benefit in the State system

from which the accumulated contributions were withdrawn.

- 1 (b) (1) A participating employee is ineligible for membership in a retirement 2 system or pension system while the participating employee is employed in any eligible 3 position by any employing institution.
- 4 (2) A participating employee who is subsequently appointed, promoted, or 5 transferred to another position that is eligible for membership in a State system but is not 6 eligible for participation in the program shall participate in a State system with respect to 7 that position as a condition of employment.

SECTION 2. AND BE IT FURTHER ENACTED, That:

- (a) This section applies to an individual who:
- 10 (1) on or before July 1, 1986, began employment in the State Personnel 11 Management System as an assistant attorney general assigned to the Maryland 12 Department of Transportation headquarters and enrolled in the Employees' Pension 13 System of the State Retirement and Pension System as a condition of employment;
- 14 (2) on or before August 1, 1993, transferred into the personnel system of 15 the University System of Maryland while continuing employment as an assistant attorney 16 general but reassigned to work on higher education issues and elected to participate in the 17 Optional Retirement Program of the State Retirement and Pension System;
- 18 (3) on or before March 1, 1997, transferred into the State Personnel 19 Management System while continuing employment as an assistant attorney general 20 assigned to work on higher education issues and resumed participation in the Employees' 21 Pension System of the State Retirement and Pension System as a condition of employment; 22 and
- 23 (4) on or before April 1, 1997, withdrew their accumulated contributions 24 from the Optional Retirement Program.
- 25 (b) Notwithstanding §§ 30–302, 30–303, and 30–307 of the State Personnel and 26 Pensions Article, an individual described under subsection (a) of this section may not 27 participate in the Optional Retirement Program on or after July 1, 2020.

- 21 State Personnel and Pensions Article as a commissioner of the Town Commission for the
- 22 Town of Walkersville on or after October 1, 2015; and
- 23 (iii) remains a commissioner of the Town Commission for the Town of
- 24 Walkersville on June 1, 2020; and
- 25 on or before July 1, 2020, has reached or exceeded normal retirement age
