## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Sexual Harassment Prevention Training – Designated Coordinator – University**  
3 **System of Maryland**

4 FOR the purpose of providing for the application of certain sexual harassment prevention  
5 training requirements; repealing the requirement that a certain representative  
6 designated by a unit of the University System of Maryland to coordinate certain  
7 sexual harassment prevention training be the unit's Title IX Coordinator; and  
8 generally relating to sexual harassment prevention training and the University  
9 System of Maryland.

10 BY repealing and reenacting, with amendments,  
11 Article – State Personnel and Pensions  
12 Section ~~2-203.1(d)(1)~~ 2-203.1(b) and (d)(1)  
13 Annotated Code of Maryland  
14 (2015 Replacement Volume and 2019 Supplement)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – State Personnel and Pensions**

18 2-203.1.

1           **(b) (1)** This section applies to all units in the Executive, Judicial, and  
 2 Legislative branches of State government, including all units with independent personnel  
 3 systems.

4                   **(2) FOR THE UNIVERSITY SYSTEM OF MARYLAND, THIS SECTION**  
 5 **APPLIES TO EACH CONSTITUENT INSTITUTION.**

6           (d) (1) (i) Each unit shall designate a representative to coordinate with the  
 7 Commission to implement the training State employees are required to complete under  
 8 subsection (c) of this section.

9                               (ii) [For a unit of the University System of Maryland, the  
 10 representative designated under subparagraph (i) of this paragraph shall be the unit's Title  
 11 IX Coordinator.

12                               (iii)] A unit may incorporate the training into existing employment  
 13 training for new employees and supervisors.

14           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
 15 1, 2020.
