A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Maryland Code of Military Justice**

3 FOR the purpose of establishing a Maryland Code of Military Justice; providing for
4 jurisdiction and applicability of this Act; providing for authority of certain judge
5 advocates; establishing the rights of certain victims; providing for the apprehension
6 and restraint of certain offenders; providing for certain non-judicial punishment;
7 establishing the jurisdiction for certain courts-martial; providing for the
8 appointment and composition of certain courts-martial; establishing certain
9 pre-trial procedures; providing for certain sentences; establishing certain post-trial
10 procedures; establishing certain procedures for review of certain courts-martial;
11 prohibiting the commission of certain acts; establishing certain penalties; providing
12 for certain courts of inquiry; authorizing certain persons to administer certain oaths;
13 requiring that certain sections of this Act be explained to certain persons at certain
14 times; authorizing a certain person to file a certain complaint about a certain wrong
15 under certain circumstances; providing for the redress of certain injuries to property;
16 authorizing the Governor to delegate certain authority; providing for the payment
17 and collection of certain fines; providing for the interpretation of this Act; providing
18 for immunity for certain persons for taking certain actions under this Act; providing
19 that the provisions of this Act are severable; providing that this Act supersedes
20 certain other laws; defining certain terms; providing that certain catchlines are not
21 law and may not be considered to have been enacted as part of this Act; and generally
22 relating to the Maryland Code of Military Justice.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That Section(s) 13–801 through 13–814 and the subtitle “Subtitle 8. Courts – Martial” of
7 Article – Public Safety of the Annotated Code of Maryland be repealed.

8 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
9 as follows:

11 **TITLE 13A. MARYLAND CODE OF MILITARY JUSTICE.**

12 **SUBTITLE 1. GENERAL PROVISIONS.**

13 **13A–101. DEFINITIONS.**

14 **(A) IN THIS TITLE, UNLESS THE CONTEXT OTHERWISE REQUIRES, THE**
15 **FOLLOWING WORDS HAVE THE MEANINGS INDICATED.**

16 **(B) “ACCUSER” MEANS:**

17 **(1) A PERSON WHO SIGNS AND SWEARS TO CHARGES;**

18 **(2) A PERSON WHO DIRECTS THAT CHARGES NOMINALLY BE SIGNED**
19 **AND SWORN TO BY ANOTHER; OR**

20 **(3) ANY OTHER PERSON WHO HAS AN INTEREST OTHER THAN AN**
21 **OFFICIAL INTEREST IN THE PROSECUTION OF THE ACCUSED.**

22 **(C) “CADET” OR “CANDIDATE” MEANS A PERSON WHO IS ENROLLED IN OR**
23 **ATTENDING A STATE MILITARY ACADEMY, A REGIONAL TRAINING INSTITUTE, OR**
24 **ANY OTHER FORMAL EDUCATION PROGRAM FOR THE PURPOSE OF BECOMING A**
25 **COMMISSIONED OFFICER IN THE STATE MILITARY FORCES.**

26 **(D) “CLASSIFIED INFORMATION” MEANS:**

27 **(1) INFORMATION OR MATERIAL THAT HAS BEEN DETERMINED BY AN**
28 **OFFICIAL OF THE UNITED STATES OR A STATE PURSUANT TO LAW, AN EXECUTIVE**
29 **ORDER, OR REGULATION TO REQUIRE PROTECTION AGAINST UNAUTHORIZED**
30 **DISCLOSURE FOR REASONS OF NATIONAL OR STATE SECURITY; AND**

1 **(2) RESTRICTED DATA, AS DEFINED IN § 11(Y) OF THE ATOMIC**
2 **ENERGY ACT OF 1954, 42 U.S.C. § 2014(Y).**

3 **(E) “COMMANDER” MEANS COMMANDING OFFICER.**

4 **(F) “COMMANDING OFFICER” INCLUDES:**

5 **(1) COMMISSIONED OFFICERS OF THE STATE MILITARY FORCES; AND**

6 **(2) OFFICERS IN CHARGE ONLY WHEN ADMINISTERING**
7 **NON-JUDICIAL PUNISHMENT UNDER § 13A-301 OF THIS CODE.**

8 **(G) “CONVENING AUTHORITY” INCLUDES:**

9 **(1) THE PERSON WHO CONVENEED THE COURT; AND**

10 **(2) (I) A COMMISSIONED OFFICER COMMANDING FOR THE TIME**
11 **BEING; OR**

12 **(II) A SUCCESSOR IN COMMAND TO THE CONVENING**
13 **AUTHORITY.**

14 **(H) “DAY” MEANS:**

15 **(1) CALENDAR DAY AND IS NOT SYNONYMOUS WITH THE TERM “UNIT**
16 **TRAINING ASSEMBLY.”**

17 **(2) AS IT RELATES TO ANY PUNISHMENT AUTHORIZED BY THIS**
18 **ARTICLE THAT IS MEASURED IN TERMS OF DAYS, WHEN SERVED IN A STATUS OTHER**
19 **THAN ANNUAL FIELD TRAINING, SUCCEEDING DUTY DAYS.**

20 **(I) (1) “DUTY STATUS OTHER THAN STATE ACTIVE DUTY” MEANS ANY**
21 **OTHER TYPE OF DUTY NOT IN FEDERAL SERVICE AND NOT FULL-TIME DUTY IN THE**
22 **ACTIVE SERVICE OF THE STATE UNDER AN ORDER ISSUED BY AUTHORITY OF LAW.**

23 **(2) “DUTY STATUS OTHER THAN STATE ACTIVE DUTY” INCLUDES**
24 **TRAVEL TO AND FROM SUCH DUTY.**

25 **(J) “ENLISTED MEMBER” MEANS A PERSON IN AN ENLISTED GRADE.**

26 **(K) “JUDGE ADVOCATE” MEANS A COMMISSIONED OFFICER OF THE**
27 **ORGANIZED STATE MILITARY FORCES WHO IS A MEMBER IN GOOD STANDING OF THE**

1 **BAR OF THE HIGHEST COURT OF A STATE:**

2 **(1) (I) CERTIFIED OR DESIGNATED AS A JUDGE ADVOCATE IN THE**
3 **JUDGE ADVOCATE GENERAL'S CORPS OF THE ARMY, AIR FORCE, NAVY, OR THE**
4 **MARINE CORPS OR DESIGNATED AS A LAW SPECIALIST AS AN OFFICER OF THE**
5 **COAST GUARD, OR A RESERVE COMPONENT OF ONE OF THESE; OR**

6 **(II) CERTIFIED AS A NON-FEDERALLY RECOGNIZED JUDGE**
7 **ADVOCATE, UNDER REGULATIONS ADOPTED PURSUANT TO THIS PROVISION, BY THE**
8 **SENIOR JUDGE ADVOCATE OF THE COMMANDER OF THE FORCE IN THE STATE**
9 **MILITARY FORCES OF WHICH THE ACCUSED IS A MEMBER, AS COMPETENT TO**
10 **PERFORM SUCH MILITARY JUSTICE DUTIES REQUIRED BY THIS CODE; OR**

11 **(2) IF NO JUDGE ADVOCATE CERTIFIED UNDER ITEM (1) OF THIS**
12 **SUBSECTION IS AVAILABLE, CERTIFIED BY A SENIOR JUDGE ADVOCATE OF THE**
13 **COMMANDER OF ANOTHER FORCE IN THE STATE MILITARY FORCES, AS THE**
14 **CONVENING AUTHORITY DIRECTS.**

15 **(L) "MILITARY COURT" MEANS:**

16 **(1) A COURT-MARTIAL; OR**

17 **(2) A COURT OF INQUIRY.**

18 **(M) "MILITARY JUDGE" MEANS AN OFFICIAL OF A GENERAL OR SPECIAL**
19 **COURT-MARTIAL DETAILED IN ACCORDANCE WITH § 13A-505 OF THIS TITLE.**

20 **(N) "MILITARY OFFENSES" MEANS THE OFFENSES PRESCRIBED UNDER THE**
21 **PUNITIVE PROVISIONS OF THE CODE.**

22 **(O) "NATIONAL SECURITY" MEANS THE NATIONAL DEFENSE AND FOREIGN**
23 **RELATIONS OF THE UNITED STATES.**

24 **(P) "OFFICER" MEANS A COMMISSIONED OR WARRANT OFFICER.**

25 **(Q) "RECORD," WHEN USED IN CONNECTION WITH THE PROCEEDINGS OF A**
26 **COURT-MARTIAL, MEANS:**

27 **(1) AN OFFICIAL WRITTEN TRANSCRIPT, WRITTEN SUMMARY, OR**
28 **OTHER WRITING RELATING TO THE PROCEEDINGS; OR**

29 **(2) AN OFFICIAL AUDIOTAPE, VIDEOTAPE, DIGITAL IMAGE OR FILE,**
30 **OR SIMILAR MATERIAL FROM WHICH SOUND, OR SOUND AND VISUAL IMAGES**

1 DEPICTING THE PROCEEDINGS, MAY BE REPRODUCED.

2 (R) "SENIOR FORCE COMMANDER" MEANS THE COMMANDER OF THE SAME
3 FORCE OF THE STATE MILITARY FORCES AS THE ACCUSED.

4 (S) "SENIOR FORCE JUDGE ADVOCATE" MEANS THE SENIOR JUDGE
5 ADVOCATE OF THE COMMANDER OF THE SAME FORCE OF THE STATE MILITARY
6 FORCES AS THE ACCUSED AND WHO IS THAT COMMANDER'S CHIEF LEGAL ADVISOR.

7 (T) (1) "STATE ACTIVE DUTY" MEANS FULL-TIME DUTY IN THE STATE
8 MILITARY FORCES UNDER AN ORDER OF THE GOVERNOR OR OTHERWISE ISSUED BY
9 AUTHORITY OF LAW, AND PAID BY STATE FUNDS.

10 (2) "STATE ACTIVE DUTY" INCLUDES TRAVEL TO AND FROM SUCH
11 DUTY.

12 (U) (1) "STATE MILITARY FORCES" MEANS THE NATIONAL GUARD OF
13 THE STATE, AS DEFINED IN TITLE 32 OF THE UNITED STATES CODE, WHEN NOT IN
14 A STATUS SUBJECTING THEM TO EXCLUSIVE JURISDICTION UNDER 10 U.S.C. 47.

15 (2) "STATE MILITARY FORCES" DOES NOT INCLUDE THE
16 UNORGANIZED MILITIA, MARYLAND DEFENSE FORCE, OR ANY OTHER STATE FORCE
17 THAT DOES NOT MEET THE DEFINITION UNDER PARAGRAPH (1) OF THIS
18 SUBSECTION.

19 (V) "SUPERIOR COMMISSIONED OFFICER" MEANS A COMMISSIONED
20 OFFICER SUPERIOR IN RANK OR COMMAND.

21 (W) "VICTIM OF AN OFFENSE UNDER THIS CODE" MEANS AN INDIVIDUAL
22 WHO HAS SUFFERED DIRECT PHYSICAL, EMOTIONAL, OR PECUNIARY HARM AS A
23 RESULT OF THE COMMISSION OF AN OFFENSE UNDER THIS CODE.

24 13A-102. PERSONS SUBJECT TO THIS TITLE; JURISDICTION.

25 (A) THIS TITLE APPLIES TO ALL MEMBERS OF THE STATE MILITARY FORCES
26 AT ALL TIMES.

27 (B) (1) SUBJECT MATTER JURISDICTION IS ESTABLISHED IF A NEXUS
28 EXISTS BETWEEN AN OFFENSE, EITHER MILITARY OR NON-MILITARY, AND THE
29 STATE MILITARY FORCE.

30 (2) COURTS-MARTIAL HAVE PRIMARY JURISDICTION OF MILITARY
31 OFFENSES.

1 **(3) (I) A PROPER CIVILIAN COURT HAS PRIMARY JURISDICTION OF**
2 **A NON-MILITARY OFFENSE WHEN AN ACT OR OMISSION VIOLATES BOTH THIS TITLE**
3 **AND LOCAL CRIMINAL LAW, FOREIGN OR DOMESTIC.**

4 **(II) IN A CASE DESCRIBED IN SUBPARAGRAPH (I) OF THIS**
5 **PARAGRAPH, A COURT-MARTIAL MAY BE INITIATED ONLY AFTER THE CIVILIAN**
6 **AUTHORITY DECLINED TO PROSECUTE OR DISMISSED THE CHARGE, PROVIDED**
7 **JEOPARDY HAS NOT ATTACHED.**

8 **(4) JURISDICTION OVER ATTEMPTED CRIMES, CONSPIRACY CRIMES,**
9 **SOLICITATION, AND ACCESSORY CRIMES MUST BE DETERMINED BY THE**
10 **UNDERLYING OFFENSE.**

11 **13A-103. JURISDICTION TO TRY CERTAIN PERSONNEL.**

12 **(A) (1) EACH PERSON DISCHARGED FROM THE STATE MILITARY FORCES**
13 **WHO IS LATER CHARGED WITH HAVING FRAUDULENTLY OBTAINED A DISCHARGE IS,**
14 **SUBJECT TO §13A-708 OF THIS TITLE, SUBJECT TO TRIAL BY COURT-MARTIAL ON**
15 **THAT CHARGE AND IS, AFTER APPREHENSION, SUBJECT TO THIS TITLE WHILE IN**
16 **CUSTODY UNDER THE DIRECTION OF THE STATE MILITARY FORCES FOR THAT**
17 **TRIAL.**

18 **(2) ON CONVICTION OF THAT CHARGE, THAT PERSON IS SUBJECT TO**
19 **TRIAL BY COURT-MARTIAL FOR ALL OFFENSES UNDER THIS TITLE COMMITTED**
20 **BEFORE THE FRAUDULENT DISCHARGE.**

21 **(B) NO PERSON WHO HAS DESERTED FROM THE STATE MILITARY FORCES**
22 **MAY BE RELIEVED FROM AMENABILITY TO THE JURISDICTION OF THIS TITLE BY**
23 **VIRTUE OF A SEPARATION FROM ANY LATER PERIOD OF SERVICE.**

24 **13A-104. TERRITORIAL APPLICABILITY OF THE TITLE.**

25 **(A) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THIS TITLE**
26 **HAS APPLICABILITY AT ALL TIMES AND IN ALL PLACES, PROVIDED THAT EITHER THE**
27 **PERSON SUBJECT TO THIS TITLE IS IN A DUTY STATUS OR, IF NOT IN A DUTY STATUS,**
28 **THAT THERE IS A NEXUS BETWEEN THE ACT OR OMISSION CONSTITUTING THE**
29 **OFFENSE AND THE EFFICIENT FUNCTIONING OF THE STATE MILITARY FORCES.**

30 **(2) THIS GRANT OF MILITARY JURISDICTION SHALL NEITHER**
31 **PRECLUDE NOR LIMIT CIVILIAN JURISDICTION OVER AN OFFENSE, WHICH IS**
32 **LIMITED ONLY BY THE PROHIBITION OF DOUBLE JEOPARDY.**

1 **(B) (1) COURTS–MARTIAL AND COURTS OF INQUIRY MAY BE CONVENED**
2 **AND HELD IN UNITS OF THE STATE MILITARY FORCES WHILE THOSE UNITS ARE**
3 **SERVING OUTSIDE THE STATE WITH THE SAME JURISDICTION AND POWERS AS TO**
4 **PERSONS SUBJECT TO THIS TITLE AS IF THE PROCEEDINGS WERE HELD INSIDE THE**
5 **STATE.**

6 **(2) OFFENSES COMMITTED OUTSIDE THE STATE MAY BE TRIED AND**
7 **PUNISHED EITHER INSIDE OR OUTSIDE THE STATE.**

8 **13A–105. JUDGE ADVOCATES.**

9 **(A) THE SENIOR FORCE JUDGE ADVOCATES IN EACH OF THE STATE’S**
10 **MILITARY FORCES OR THAT JUDGE ADVOCATE’S DELEGATES SHALL MAKE**
11 **FREQUENT INSPECTIONS IN THE FIELD IN SUPERVISION OF THE ADMINISTRATION**
12 **OF MILITARY JUSTICE IN THAT FORCE.**

13 **(B) (1) CONVENING AUTHORITIES SHALL AT ALL TIMES COMMUNICATE**
14 **DIRECTLY WITH THEIR JUDGE ADVOCATES IN MATTERS RELATING TO THE**
15 **ADMINISTRATION OF MILITARY JUSTICE.**

16 **(2) THE JUDGE ADVOCATE OF A COMMAND IS ENTITLED TO**
17 **COMMUNICATE DIRECTLY WITH THE JUDGE ADVOCATE OF A SUPERIOR OR**
18 **SUBORDINATE COMMAND, OR WITH THE STATE JUDGE ADVOCATE.**

19 **(C) A PERSON WHO HAS ACTED AS MEMBER, MILITARY JUDGE, TRIAL**
20 **COUNSEL, DEFENSE COUNSEL, OR INVESTIGATING OFFICER, OR WHO HAS BEEN A**
21 **WITNESS IN A CASE MAY NOT LATER ACT AS A JUDGE ADVOCATE TO A REVIEWING**
22 **AUTHORITY ON THE SAME CASE.**

23 **13A–106. RIGHTS OF THE VICTIM OF AN OFFENSE UNDER THIS TITLE.**

24 **(A) A VICTIM OF AN OFFENSE UNDER THIS TITLE HAS ALL RIGHTS**
25 **CONFERRED BY STATE LAW IN NON–MILITARY COURTS, INCLUDING:**

26 **(1) THE RIGHT TO BE REASONABLY PROTECTED FROM THE ACCUSED;**

27 **(2) THE RIGHT TO REASONABLE, ACCURATE, AND TIMELY NOTICE**
28 **PROVIDED BY MILITARY TRIAL COUNSEL OF:**

29 **(I) A PUBLIC HEARING CONCERNING THE CONTINUATION OF**
30 **CONFINEMENT PRIOR TO TRIAL OF THE ACCUSED;**

31 **(II) A PRELIMINARY HEARING UNDER § 13A–603 OF THE TITLE**

1 RELATING TO THE OFFENSE;

2 (III) A COURT-MARTIAL RELATING TO THE OFFENSE, INCLUDING
3 ALL RELATED MOTIONS, HEARINGS, PLEAS, SENTENCING HEARINGS, ALTERATIONS
4 OR SUSPENSION, AND ALL RELATED FILED DOCUMENTS, INCLUDING THOSE
5 RELATED TO § 13A-606 OF THE TITLE;

6 (IV) A PUBLIC PROCEEDING OF THE SERVICE CLEMENCY AND
7 PAROLE BOARD RELATING TO THE OFFENSE; AND

8 (V) THE RELEASE OR ESCAPE OF THE ACCUSED, UNLESS SUCH
9 NOTICE MAY ENDANGER THE SAFETY OF ANY PERSON;

10 (3) THE RIGHT NOT TO BE EXCLUDED FROM ANY PUBLIC HEARING OR
11 PROCEEDING DESCRIBED IN PARAGRAPH (2) OF THIS SUBSECTION, UNLESS THE
12 MILITARY JUDGE OR PRELIMINARY HEARING OFFICER, AS APPLICABLE, AFTER
13 RECEIVING CLEAR AND CONVINCING EVIDENCE, DETERMINES THAT TESTIMONY BY
14 THE VICTIM OF AN OFFENSE UNDER THIS TITLE WOULD BE MATERIALLY ALTERED
15 IF THE VICTIM HEARD OTHER TESTIMONY AT THAT HEARING OR PROCEEDING;

16 (4) THE RIGHT TO BE REASONABLY HEARD AT:

17 (I) A PUBLIC HEARING CONCERNING THE CONTINUATION OF
18 CONFINEMENT PRIOR TO TRIAL OF THE ACCUSED;

19 (II) A SENTENCING HEARING RELATING TO THE OFFENSE;

20 (III) A PROCEEDING INVOLVING CLEMENCY AND PAROLE
21 RELATED TO THE OFFENSE; AND

22 (IV) ANY PUBLIC MILITARY PROCEEDINGS, INCLUDING
23 APPEALS, IN CONNECTION WITH THE VICTIM'S LEGAL RIGHTS WHERE THOSE RIGHTS
24 ARE IMPLICATED;

25 (5) THE REASONABLE RIGHT TO CONFER BEFOREHAND WITH THE
26 COUNSEL REPRESENTING THE GOVERNMENT AT A PROCEEDING DESCRIBED IN
27 PARAGRAPH (2) OF THIS SUBSECTION AND AT A PROCEEDING UNDER § 13A-301, §
28 13A-405, § 13A-601.1, AND § 13A-902;

29 (6) THE RIGHT TO RECEIVE FULL RESTITUTION BEFORE A
30 FORFEITURE MAY BE RECEIVED BY THE MILITARY AS PROVIDED BY LAW;

31 (7) THE RIGHT TO PROCEEDINGS FREE FROM UNREASONABLE DELAY;

1 AND

2 (8) THE RIGHT TO BE TREATED WITH FAIRNESS AND WITH RESPECT
3 FOR THE DIGNITY AND PRIVACY OF THE VICTIM OF AN OFFENSE UNDER THIS TITLE.

4 (B) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IN THE CASE
5 OF A VICTIM OF AN OFFENSE UNDER THIS TITLE WHO IS UNDER 18 YEARS OF AGE
6 BUT NOT A MEMBER OF THE ARMED FORCES, INCOMPETENT, INCAPACITATED, OR
7 DECEASED, THE MILITARY JUDGE SHALL DESIGNATE A REPRESENTATIVE OF THE
8 ESTATE OF THE VICTIM, A FAMILY MEMBER, OR ANOTHER SUITABLE INDIVIDUAL TO
9 ASSUME THE VICTIM'S RIGHTS UNDER THIS SECTION.

10 (2) THE INDIVIDUAL DESIGNATED UNDER PARAGRAPH (1) OF THIS
11 SUBSECTION MAY NOT BE THE ACCUSED.

12 (C) NOTHING IN THIS SECTION MAY BE CONSTRUED:

13 (1) TO AUTHORIZE A CAUSE OF ACTION FOR DAMAGES;

14 (2) TO CREATE, TO ENLARGE, OR TO IMPLY A DUTY OR OBLIGATION
15 TO A VICTIM OF AN OFFENSE UNDER THIS TITLE OR OTHER PERSON FOR BREACH OF
16 WHICH THE STATE OR ANY OF ITS OFFICERS OR EMPLOYEES COULD BE HELD LIABLE
17 FOR DAMAGES OTHER THAN RESTITUTION; OR

18 (3) TO IMPAIR THE EXERCISE OF DISCRETION UNDER § 13A-601 OR §
19 13A-605 OF THIS TITLE.

20 (D) (1) IF THE VICTIM OF AN OFFENSE UNDER THIS TITLE BELIEVES THAT
21 A PRELIMINARY HEARING RULING UNDER § 13A-603 OF THIS TITLE OR A
22 COURT-MARTIAL RULING VIOLATES THE RIGHTS OF THE VICTIM AFFORDED BY A
23 PROVISION SPECIFIED IN PARAGRAPH (4) OF THIS SUBSECTION, THE VICTIM MAY
24 FILE AN INTERLOCUTORY APPEAL TO THE COURT OF MILITARY APPEALS, AND
25 THEREAFTER FILE A CERTIORARI PETITION WITH THE MARYLAND COURT OF
26 APPEALS, AND AN AUTOMATIC STAY OF THE MILITARY PROCEEDINGS SHALL TAKE
27 EFFECT ON THE FILING OF THE NOTICE OF APPEAL UNTIL FINAL DISPOSITION OF
28 THE APPEAL, IN ORDER TO REQUIRE THE PRELIMINARY HEARING OFFICER OR THE

28 (E) A CIVIL OFFICER HAVING AUTHORITY TO APPREHEND OFFENDERS

30 OR NONCOMMISSIONED OFFICER SUBJECT TO THIS TITLE WHO HAS BEEN
31 AUTHORIZED BY THE GOVERNOR BY REGULATION OR WITH THE AUTHORITY OF THE
32 ADJUTANT GENERAL MAY SUMMARILY APPREHEND A PERSON SUBJECT TO THIS

3 (A) (1) AN ENLISTED MEMBER MAY BE ORDERED INTO ARREST OR
4 CONFINEMENT BY A COMMISSIONED OFFICER BY AN ORDER, ORAL OR WRITTEN,
5 DELIVERED IN PERSON OR THROUGH OTHER PERSONS SUBJECT TO THIS TITLE.

6 (2) A COMMANDING OFFICER MAY AUTHORIZE WARRANT OFFICERS
7 OR NONCOMMISSIONED OFFICERS TO ORDER ENLISTED MEMBERS OF THE
8 COMMANDING OFFICER'S COMMAND OR SUBJECT TO THE COMMANDING OFFICER'S
9 AUTHORITY INTO ARREST OR CONFINEMENT.

10 (B) (1) A COMMISSIONED OFFICER, A WARRANT OFFICER, OR A CIVILIAN
11 SUBJECT TO THIS TITLE OR TO TRIAL THEREUNDER MAY BE ORDERED INTO ARREST
12 OR CONFINEMENT ONLY BY A COMMANDING OFFICER TO WHOSE AUTHORITY THE
13 PERSON IS SUBJECT, BY AN ORDER, ORAL OR WRITTEN, DELIVERED IN PERSON OR
14 BY ANOTHER COMMISSIONED OFFICER.

15 (2) THE AUTHORITY TO ORDER SUCH PERSONS INTO ARREST OR
16 CONFINEMENT MAY NOT BE DELEGATED.

17 (C) NO PERSON MAY BE ORDERED INTO ARREST OR CONFINEMENT EXCEPT
18 FOR PROBABLE CAUSE.

19 (D) THIS SECTION DOES NOT LIMIT THE AUTHORITY OF PERSONS
20 AUTHORIZED TO APPREHEND OFFENDERS TO SECURE THE CUSTODY OF AN
21 ALLEGED OFFENDER UNTIL PROPER AUTHORITY MAY BE NOTIFIED.

22 **13A-204. RESTRAINT OF PERSONS CHARGED WITH OFFENSES.**

23 (A) A PERSON SUBJECT TO THIS TITLE CHARGED WITH AN OFFENSE UNDER
24 THIS TITLE MAY BE ORDERED INTO ARREST OR CONFINEMENT, AS CIRCUMSTANCES
25 MAY REQUIRE.

26 (B) WHEN A PERSON SUBJECT TO THIS TITLE IS PLACED IN ARREST OR
27 CONFINEMENT PRIOR TO TRIAL, IMMEDIATE STEPS SHALL BE TAKEN TO INFORM
28 THE PERSON OF THE SPECIFIC WRONG OF WHICH THE PERSON IS ACCUSED AND
29 DILIGENT STEPS SHALL BE TAKEN TO TRY THE PERSON OR TO DISMISS THE
30 CHARGES AND RELEASE THE PERSON.

31 **13A-205. PLACE OF CONFINEMENT; REPORTS AND RECEIVING OF PRISONERS.**

17 (2) A REPRIMAND;

18 (3) THE WITHHOLDING OF PRIVILEGES FOR NOT MORE THAN 6
19 MONTHS, WHICH NEED NOT BE CONSECUTIVE;

20 (4) THE FORFEITURE OF PAY OF NOT MORE THAN 7 DAYS' PAY;

21 (5) A FINE OF NOT MORE THAN 7 DAYS' PAY;

22 (6) A REDUCTION TO THE NEXT INFERIOR PAY GRADE, IF THE
23 SOLDIER OR AIRMAN IS IN THE RANK OF E-4 OR BELOW;

24 (7) EXTRA DUTIES, INCLUDING FATIGUE OR OTHER DUTIES, FOR NOT
25 MORE THAN 14 DAYS, WHICH NEED NOT BE CONSECUTIVE; OR

26 (8) RESTRICTION TO CERTAIN SPECIFIED LIMITS, WITH OR WITHOUT
27 SUSPENSION FROM DUTY, FOR NOT MORE THAN 14 DAYS, WHICH NEED NOT BE
28 CONSECUTIVE.

29 (C) A COMMANDING OFFICER OF THE GRADE OF MAJOR OR ABOVE MAY

1 IMPOSE ON ENLISTED MEMBERS OF THE OFFICER'S COMMAND:

2 (1) ANY PUNISHMENT AUTHORIZED IN SUBSECTIONS (B)(1), (2), OR
3 (3) OF THIS SECTION;

4 (2) THE FORFEITURE OF NOT MORE THAN ONE-HALF OF 1 MONTH'S
5 PAY PER MONTH FOR 2 MONTHS;

6 (3) A FINE OF NOT MORE THAN 1 MONTH'S PAY;

7 (4) A REDUCTION TO THE LOWEST OR ANY INTERMEDIATE PAY
8 GRADE, IF THE SOLDIER OR AIRMAN IS IN THE RANK OF E-6 OR BELOW, BUT AN
9 ENLISTED MEMBER IN A PAY GRADE ABOVE E-4 MAY NOT BE REDUCED MORE THAN
10 TWO PAY GRADES;

11 (5) EXTRA DUTIES, INCLUDING FATIGUE OR OTHER DUTIES, FOR NOT
12 MORE THAN 45 DAYS, WHICH NEED NOT BE CONSECUTIVE; OR

13 (6) RESTRICTION TO CERTAIN SPECIFIED LIMITS, WITH OR WITHOUT
14 SUSPENSION FROM DUTY, FOR NOT MORE THAN 60 DAYS, WHICH NEED NOT BE
15 CONSECUTIVE.

16 (D) THE GOVERNOR, THE ADJUTANT GENERAL, AN OFFICER EXERCISING
17 GENERAL COURT-MARTIAL CONVENING AUTHORITY, OR AN OFFICER OF A GENERAL
18 OR FLAG RANK IN COMMAND MAY IMPOSE:

19 (1) ON OFFICERS OF THE OFFICER'S COMMAND:

20 (I) ANY PUNISHMENT AUTHORIZED IN SUBSECTIONS (C)(1), (2),
21 (3), OR (6) OF THIS SECTION; OR

22 (II) ARREST IN QUARTERS FOR NOT MORE THAN 30 DAYS,
23 WHICH NEED NOT BE CONSECUTIVE; OR

24 (2) ON ENLISTED MEMBERS OF THE OFFICER'S COMMAND:

25 (I) ANY PUNISHMENT AUTHORIZED IN SUBSECTION (C) OF THIS
26 SECTION; OR

27 (II) A REDUCTION TO THE LOWEST OR ANY INTERMEDIATE PAY
28 GRADE, IF THE SOLDIER OR AIRMAN IS IN THE RANK OF E-9 OR BELOW, BUT AN
29 ENLISTED MEMBER IN A PAY GRADE ABOVE E-4 MAY NOT BE REDUCED MORE THAN
30 TWO PAY GRADES.

1 (E) WHENEVER ANY PUNISHMENTS ARE COMBINED TO RUN
2 CONSECUTIVELY, THE TOTAL LENGTH OF THE COMBINED PUNISHMENT MAY NOT
3 EXCEED THE AUTHORIZED DURATION OF THE LONGEST PUNISHMENT IN THE
4 COMBINATION, AND THERE MUST BE AN APPORTIONMENT OF PUNISHMENTS SO
5 THAT NO SINGLE PUNISHMENT IN THE COMBINATION EXCEEDS ITS AUTHORIZED
6 LENGTH UNDER THIS SECTION.

7 (F) (1) PRIOR TO THE OFFER OF NON-JUDICIAL PUNISHMENT, THE
8 COMMANDING OFFICER SHALL DETERMINE WHETHER PUNISHMENT MORE SEVERE
9 THAN 14 DAYS EXTRA DUTY OR 14 DAYS RESTRICTION AND ADMONITION SHALL BE
10 CONSIDERED AS PUNISHMENTS.

11 (2) IF THE COMMANDING OFFICER DETERMINES THAT THE

30 (II) WHEN MITIGATING REDUCTION IN GRADE TO FORFEITURE
31 OF PAY, THE AMOUNT OF THE FORFEITURE MAY NOT BE GREATER THAN THE
32 AMOUNT THAT COULD HAVE BEEN IMPOSED INITIALLY UNDER THIS SECTION BY THE

1 OFFICER WHO IMPOSED THE PUNISHMENT MITIGATED.

2 (H) (1) A PERSON PUNISHED UNDER THIS SECTION WHO CONSIDERS THE
3 PUNISHMENT UNJUST OR DISPROPORTIONATE TO THE OFFENSE MAY, THROUGH
4 THE PROPER CHANNEL, APPEAL TO THE NEXT SUPERIOR AUTHORITY WITHIN 15
5 DAYS AFTER THE PUNISHMENT IS EITHER ANNOUNCED OR SENT TO THE ACCUSED,
6 AS THE COMMANDER MAY DETERMINE.

7 (2) THE APPEAL SHALL BE PROMPTLY FORWARDED AND DECIDED,
8 BUT THE PERSON PUNISHED MAY IN THE MEANTIME BE REQUIRED TO UNDERGO THE
9 PUNISHMENT ADJUDGED.

10 (3) IF THE SUPERIOR AUTHORITY ACTING ON THE APPEAL DOES NOT
11 RENDER A DECISION WITHIN 5 DAYS OF THE ELECTION TO APPEAL, THE
12 PUNISHMENT SHALL BE SUSPENDED UNTIL SUCH TIME AS THE APPEAL IS DECIDED.

13 (4) THE SUPERIOR AUTHORITY MAY EXERCISE THE SAME POWERS
14 WITH RESPECT TO THE PUNISHMENT IMPOSED AS MAY BE EXERCISED UNDER
15 SUBSECTION (G) OF THIS SECTION BY THE OFFICER WHO IMPOSED THE
16 PUNISHMENT.

17 (5) BEFORE ACTING ON AN APPEAL FROM A PUNISHMENT, THE
18 AUTHORITY THAT IS TO ACT ON THE APPEAL MAY REFER THE CASE TO A JUDGE
19 ADVOCATE FOR CONSIDERATION AND ADVICE.

20 (I) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE
21 IMPOSITION AND ENFORCEMENT OF DISCIPLINARY PUNISHMENT UNDER THIS
22 SECTION FOR AN ACT OR OMISSION IS NOT A BAR TO TRIAL BY COURT-MARTIAL OR
23 A CIVILIAN COURT OF COMPETENT JURISDICTION FOR A SERIOUS CRIME OR
24 OFFENSE GROWING OUT OF THE SAME ACT OR OMISSION AND NOT PROPERLY
25 PUNISHABLE UNDER THIS TITLE.

26 (2) THE FACT THAT A DISCIPLINARY PUNISHMENT HAS BEEN
27 ENFORCED MAY BE SHOWN BY THE ACCUSED AT TRIAL AND, WHEN SO SHOWN, IT
28 SHALL BE CONSIDERED IN DETERMINING THE MEASURE OF PUNISHMENT TO BE
29 ADJUDGED IN THE EVENT OF A FINDING OF GUILTY.

30 (J) WHENEVER A PUNISHMENT OF FORFEITURE OF PAY IS IMPOSED UNDER

(A) PUNISHMENT BY FLOGGING, OR BY BRANDING, MARKING, OR TATTOOING ON THE BODY, OR ANY OTHER CRUEL OR UNUSUAL PUNISHMENT MAY NOT BE ADJUDGED BY A COURT-MARTIAL OR INFLICTED ON ANY PERSON SUBJECT TO THIS TITLE.

(B) THE USE OF IRONS, SINGLE OR DOUBLE, EXCEPT FOR THE PURPOSE OF SAFE CUSTODY, IS PROHIBITED.

13A-802. MAXIMUM LIMITS.

(A) (1) THE PUNISHMENT WHICH A COURT-MARTIAL MAY DIRECT FOR AN OFFENSE MAY NOT EXCEED SUCH LIMITS AS PRESCRIBED BY THIS TITLE, BUT IN NO INSTANCE MAY A SENTENCE EXCEED MORE THAN 10 YEARS FOR A MILITARY OFFENSE, NOR MAY A SENTENCE OF DEATH BE ADJUDGED.

(2) (I) A CONVICTION BY GENERAL COURT-MARTIAL OF ANY MILITARY OFFENSE FOR WHICH AN ACCUSED MAY RECEIVE A SENTENCE OF CONFINEMENT FOR MORE THAN 1 YEAR IS A FELONY OFFENSE.

(II) EXCEPT FOR CONVICTIONS BY A SUMMARY COURT-MARTIAL, ALL OTHER MILITARY OFFENSES ARE MISDEMEANORS.

(3) A CONVICTION BY A SUMMARY COURT-MARTIAL IS NOT A CRIMINAL CONVICTION.

(B) THE LIMITS OF PUNISHMENT FOR VIOLATIONS OF THE PUNITIVE PROVISIONS PRESCRIBED HEREIN SHALL BE LESSER OF THE SENTENCES PRESCRIBED BY THE MANUAL FOR COURTS-MARTIAL OF THE UNITED STATES IN EFFECT ON JANUARY 1, 2020, BUT IN NO INSTANCE SHALL ANY PUNISHMENT EXCEED THAT AUTHORIZED BY THIS TITLE.

(C) (1) IN SENTENCING AN ACCUSED UNDER § 13A-718 OF THIS TITLE, A COURT-MARTIAL SHALL IMPOSE PUNISHMENT THAT IS SUFFICIENT, BUT NOT GREATER THAN NECESSARY, TO PROMOTE JUSTICE AND TO MAINTAIN GOOD ORDER AND DISCIPLINE IN THE ARMED FORCES, TAKING INTO CONSIDERATION:

14 6. TO REHABILITATE THE ACCUSED; AND

15 7. TO PROVIDE, IN APPROPRIATE CASES, THE
16 OPPORTUNITY FOR RETRAINING AND RETURN TO DUTY TO MEET THE NEEDS OF THE
17 SERVICE; AND

18 **(IV) THE SENTENCES AVAILABLE UNDER THIS TITLE.**

19 **(2) (I) IN ANNOUNCING THE SENTENCE IN A GENERAL OR SPECIAL**
20 **COURT-MARTIAL IN WHICH THE ACCUSED IS SENTENCED BY A MILITARY JUDGE**
21 **ALONE UNDER § 13A-718 OF THIS TITLE, THE MILITARY JUDGE SHALL, WITH**
22 **RESPECT TO EACH OFFENSE OF WHICH THE ACCUSED IS FOUND GUILTY, SPECIFY**
23 **THE TERM OF CONFINEMENT, IF ANY, AND THE AMOUNT OF THE FINE, IF ANY.**

24 **(II) IF THE ACCUSED IS SENTENCED TO CONFINEMENT FOR**
25 **MORE THAN ONE OFFENSE, THE MILITARY JUDGE SHALL SPECIFY WHETHER THE**

23 (A) FINES IMPOSED BY A MILITARY COURT OR THROUGH IMPOSITION OF
24 NON-JUDICIAL PUNISHMENT MAY BE PAID TO THE U.S. TREASURY.

25 (B) FINES MAY BE COLLECTED BY:

26 (1) CASH OR MONEY ORDER;

27 (2) RETENTION OF PAY OR ALLOWANCES DUE OR TO BECOME DUE

5 **13A-1109. IMMUNITY FOR ACTION OF MILITARY COURTS.**

6 **A PERSON ACTING UNDER THE PROVISIONS OF THIS TITLE, WHETHER AS A**
7 **MEMBER OF THE MILITARY OR AS A CIVILIAN, SHALL BE IMMUNE FROM PERSONAL**
8 **LIABILITY FOR ANY OF THE ACTS OR OMISSIONS THAT THE PERSON DID OR FAILED**
9 **TO DO AS PART OF THE PERSON'S DUTIES UNDER THIS TITLE.**

10 **13A-1110. SEVERABILITY.**

11 **THE PROVISIONS OF THIS TITLE ARE HEREBY DECLARED TO BE SEVERABLE**

19 **ON ENACTMENT, THIS LAW SUPERSEDES ALL EXISTING STATUTES,**
20 **ORDINANCES, DIRECTIVES, RULES, REGULATIONS, ORDERS, AND OTHER LAWS IN**
21 **THE STATE COVERED BY THE SUBJECT MATTER OF THIS LAW, AND ALL SUCH**
