Senate Bill 599

(Harford County Senators)

Sheriff of Harford County - Salary

This bill specifies that the salary of the Harford County Sheriff is equal to the salary of a lieutenant colonel of the Maryland State Police (DSP), at the highest available step that is in effect on the day prior to the day that the sheriff begins a term of office. Any change in DSP's salary schedule during a term of office may not apply to the incumbent sheriff, but the changed rate will take effect at the beginning of the next term. Pursuant to constitutional requirements, the salary structure specified in the bill takes effect at the beginning of the next term of office.

Fiscal Summary

State Effect: None.

Local Effect: Harford County expenditures increase by approximately \$14,400 in FY 2023 and by approximately \$25,200 annually thereafter. County revenues are not affected.

Small Business Effect: None.

Analysis

Current Law/Background: Chapter 736 of 2017 altered the annual salary of the Harford County Sheriff so that (1) beginning December 1, 2018, the annual salary is \$136,000 and (2) on or after July 1, 2019, the salary is adjusted annually to reflect the annual change in the consumer price index (CPI), as specified. The current salary of the Harford County Sheriff is \$138,598.

Exhibit 1 shows the salary for the sheriff in other jurisdictions based on fiscal 2019 data, as provided by the Maryland Association of Counties.

Article III, § 35 of the Maryland Constitution prohibits the salary or compensation of any public officer from being increased or diminished during the individual's term of office, except those whose full term is fixed by law in excess of four years. According to a letter from the Counsel to the General Assembly, dated January 17, 1978, salary increases that are to be implemented over a period of time are permissible if implemented before the beginning of the term.

Local Fiscal Effect: Harford expenditures increase by \$14,370 in fiscal 2023 and by approximately \$25,000 annually thereafter. Pursuant to constitutional requirements, the salary is not altered until the next term of office. The estimate accounts for the increase taking effect the first week in December 2022, includes fringe benefits, uses current CPI projections, and is based on the current salary for a lieutenant colonel of DSP at Step 18 (\$165,596).
