<u>AMENDMENTS TO HOUSE BILL 700</u> (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike "**Disruption of School Activities – Repeal of Prohibition**" and substitute "<u>Crimes on School Grounds – Exemptions</u>"; strike beginning with "repealing" in line 3 down through "education;" in line 6 and substitute "<u>specifying that certain provisions of law prohibiting and penalizing certain behavior on</u> the grounds or in the classes of institutions of elementary, secondary, or higher education do not apply to students who commit offenses at the institution they attend, students on exclusionary discipline who commit offenses at the institution they attend, or students who commit offenses while participating in or attending a sporting event or other extracurricular program sponsored by another institution;"; and in line 6, strike "the disruption of activities" and substitute "<u>exemptions from provisions of law that</u> prohibit and penalize disruptive and threatening behavior".

AMENDMENT NO. 2

On page 1, in lines 17 and 19, in each instance, strike the bracket; in line 20, strike the brackets; and in the same line, strike "(A)".

On page 1 in lines 17 and 20, and on page 2 in line 5, in each instance, strike "A" and substitute "<u>SUBJECT TO SUBSECTION (F) OF THIS SECTION, A</u>".

On page 2, in lines 5, 9, and 14, in each instance, strike the brackets; in lines 5, 9, and 14, strike "(B)", "(C)", and "(D)", respectively; in line 14, strike "Any" and substitute "<u>SUBJECT TO SUBSECTION (F) OF THIS SECTION, A</u>"; and after line 16, insert:

"(F) <u>THE PROHIBITIONS AND PENALTIES IN THIS SECTION DO NOT APPLY</u> <u>TO A PERSON WHO IS:</u>
